Freedom of Information and Protection of Privacy Request #: AE000-2021-G-20

On June 14, 2021, Advanced Education received your request under the Freedom of Information and Protection of Privacy Act (FOIP Act) for a copy of:

This request is for the Ministry of Advanced Education, for the period of March 6, 2020 to January 22, 2021.

This request is in reference to the work of the Evaluation Committee referenced on page 17 of RFP-AE-20-01, "Alberta 2030: Transforming Post-Secondary Education," and defined as "the individuals who will evaluate the Proposals on behalf of the Province."

We request the names and job titles of the members of the Evaluation Committee, as well as which stage(s) of the evaluation they participated in (the first and/or the second).

In the first stage, five proponent proposals met the mandatory requirements and were graded by the Evaluation Committee (as defined above) according to the rubric on page 17 of the RFP. We request the grades for each of the five proponent proposals in each of the rubric categories.

In the second stage, a shortlist of three proponents were invited to present to the Evaluation Committee. We request to know which of the five proponents made it to the shortlist of three.

We request the three shortlisted proponents' presentation materials.

We request any notes or evaluations resulting from those presentations.

Time period: from March 06, 2020 to January 22, 2021.

Advanced Education has decided to grant you access to part of the records you requested. The records contain information that was withheld from disclosure in accordance with sections 16(1) [Disclosure harmful to business interests of a third party] and 25(1) [Disclosure harmful to economic and other interests of a public body]. In addition, the records contain some information that is not responsive to your request.

We have removed the information that is withheld from disclosure and that is non-responsive in order to provide you with access to the remainder of the records (attached).

You may ask for a review under Part 5 of the FOIP Act by the Information and Privacy Commissioner (Commissioner) of the decision to not give access to part of the record. To request a review, you must submit a completed Request for Review form within 60 days from the date of this letter to the Commissioner at Suite 410, 9925 – 109 Street, Edmonton, Alberta, T5K 2J8. The form is available under 'Resources' on the Commissioner's website, www.oipc.ab.ca, or you can call 1-888-878-4044 to request a copy.
