In the Gateway Student Journalism Society's (GSJS) February 17th Board of Directors (BoD) meeting, the BoD made several motions to change The Gateway's operations for the upcoming 2011/2012 publishing year in order to ensure fiscal stability for the paper in the upcoming years. In addition to cutting down paid-staff positions and reducing salaries, the BoD decided to decrease the publication of The Gateway from twice per week to once a week. While online-exclusive content will be increased throughout the week and each weekly issue will be bigger than average, these changes raise some confusion in terms of The Gateway's publishing schedule as outlined in Bylaw 6000.

In Bylaw 6000 Section 3 Sub-Section (3) (a), it states that the GSJS' mandate is "to publish at least fifteen issues of The Gateway during each Fall or Winter term." In order to ensure that it fulfills its mandate, while upholding to its proposed reduction in publication, the GSJS wants to publish their annual Orientation issue before classes begin and/or their Joke Issue after classes end. The question is: would publishing issues before and/or after classes, so that the total number of issues published in each semester would be equal to 15, fulfill the GSJS mandate as outlined in Bylaw 6000 Section 3 Sub-Section (3) (a)?
