#### **Facts**

- 1. Blue Knox, candidate for Vice President External was present at the mandatory candidates' meeting on February 12 at 18:00.
- 2. At approximately 15:56 on February 16, Elliot Tanti, volunteer for Blue Knox, notified the Chief Returning Officer that a contravention to bylaw was made regarding unintentional precampaigning in the Blue Knox campaign in the following email:

"Hello Jessica,

My name is Elliott Tanti and I am working on Blue Knox's campaign for VP External. Approximately 15 minutes ago I created a draft event on Facebook as a reminder for Blue's supporters to vote on election day. The event was called "On March 4th and 5th I'm voting for Blue Knox". In my haste I neglected to adjust the settings to private, and thus the event was live and public upon creation. Fortunately, in returning to the private election group, I recognized my mistake and quickly deleted the event. The event was not live for longer than a few seconds.

In the interest of full discloser I felt the need to bring this to your attention. I can assure you that this was an honest mistake and that I in no way meant to gain an unfair advantage by campaigning outside of the set time frame. Blue has set clear expectations regarding the conduct of her campaign and I in no way meant to undermine those expectations.

### Ruling

- All candidates and their volunteers are required to read, understand, and comply with all Rules & Regulations and Bylaws and were informed as such in the nomination package and at the mandatory candidates' meeting. Blue Knox, candidate for Vice President External, was in attendance at the mandatory candidates' meeting.
- 2. The rules and regulations state that social media channels must not be made publicly available until the start of the campaign period. Furthermore, regulations specify material approval by the Chief Returning Officer is required prior to public release. Pre-campaigning rules are further stipulated in Bylaw 2200 and the Rules and Regulations.
- 3. The Chief Returning Officer appreciated that the Blue Knox campaign was forthcoming in providing information. The Chief Returning Officer was also satisfied the information provided was accurate.

# **Penalty**

- The Schedule of Fines and Penalties affixed to the nomination package denotes that unsolicited campaigning is a \$10.00 counterbalancing fine + \$0.10 for each individual contacted.
- 2. The Chief Returning Officer does not believe that anyone was reached in the few seconds that the event was unintentionally made public.
- 3. The Chief Returning Officer appreciates that the Blue Knox campaign was forthcoming making the contravention known to the Chief Returning Officer, therefore no punitive fine will be levied.
- 4. The Blue Knox campaign will be levied a fine of \$10.00 against the candidate budget.
