"F" indicates the amount transferred for each full-time student per Fall or Winter Term, "P" indicates the amount transferred for each part-time student per Fall or Winter Term, and "S" indicates the amount transferred for each student per Spring or Summer Term.

Recalculation: This indicates the date that the transfer payment will be recalculated in accordance with the Bylaw Respecting Faculty Association and Campus Association Finances.

Expiry: This indicates the date that the fee will cease to be collected in accordance with the Bylaw Respecting Faculty Association and Campus Association Finances.

Off Campus Students: This indicates whether the fee or payment applies to students in the constituency who are registered as off campus students.
