A Committee member:

This was created 4 or 5 years ago by the then Policy Committee.

One thing President Belcourt has put down is the indigenous requirement by SU.

Sunday:

Resolution are connected by facts. Increasing indigenous employment at SU would improve situation. Rebecca mentioned that in Policy

Committee. I thought there should information about why the TRC was created. SU will advocate with Aboriginal Relation Committee at the U of A to legitimize it, and right we are setting our feet. First point should be why the TRC exists.

Line 1 about Resident Schooling, Line 2 about TRC and Line 3 about Reconciliation Commission.

Number 2 is that we have a mandate to improve the undergraduate students at the U of A. It is true that we have the mandate to improve the experience of all students at the U of A. All schools are like the U of A, but should stick to U of A.

There were three comments attached to this.

Whatever be it, resolutions must match the facts. I don't know how to word it, but think it is good to say "all Canadians".

Calls for actions from TRC final report.

Line 5: The backlog regarding indigenous students must be dealt with. It could be post-secondary financing. We can also quantify it – we can email it to Councilor Callihoo.

Line 7: I don't think that it about aboriginal people, but it is resolution. It just needs some more work. It says students regardless of their of study should have access to reconciliation. Line 7 and 8 are about reconciliation. Policy Committee needs to provide feedback. It should go through it.

SU is going to email me about this.

A Committee member:

In regards to no work being done on it, the Chair's idea was that foundation should have been laid out by ARRC, instead of Councilor Palmer saying something. That was their logic behind the person fixing wrong things there and the policy.
