TAYLOR: Established that the Committee exists to bridge Aboriginal students with the Students' Union, provide recommendations to Council, and advance indigenisation. Identified that the Committee will complete an Aboriginal Collaboration Framework in August, report on Executive Committee advocacy in November, report on Students' Council Aboriginal representation in January, as well as select an elder, prepare transition materials, complete a report on Aboriginal priorities, and complete a second report assessing Executive Committee advocacy in April. Noted that the Committee will also support drafting the Truth and Reconciliation Commission political policy.

VARGAS ALBA: Inquired into whether the position posting for the ARRC students-at-large has been completed.

TAYLOR: Responded in the affirmative.

BELCOURT nominated SUNDAY: accepted.

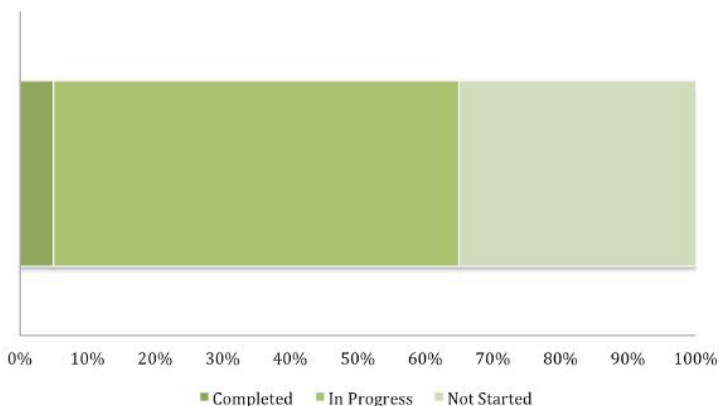

- Students' Council

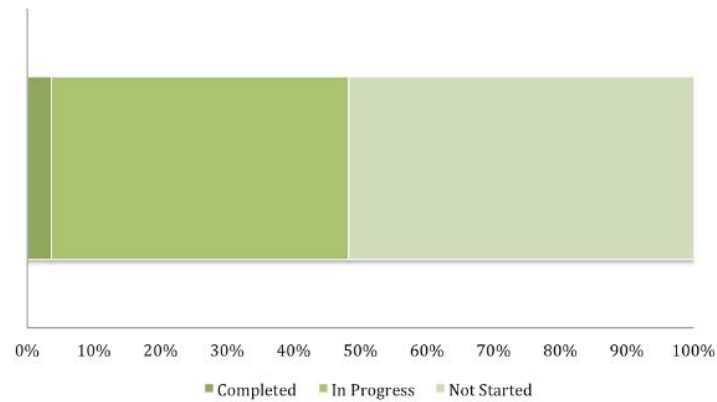
A key operational recommendation states that:
