Ilya says that he can make a summary of all the changes to make everything in one place.

Deidra is wondering why we need to get everything done before election changes

Nathan says that this requirement is because our mandate is only for this council, and other future council members might be different.

Nathan advocates for a simpler process in which standing orders would be published first, then everyone goes over the recommendations, and finally the recommendations would be published after.

Everyone votes yes.

Nathan says February 5th will be the deadline for all the consultations for the standing orders. After that time, they will go through with the recommendations.

VP Shane suggests to go through their each of consultations on the To-Do List document, and make sure that everyone knows what they are doing.

Nathan proceeds to read out the To-Do items, and everyone responds in the affirmative, or clarifies their responsibility.
