SUNDAY: Called the meeting to order at 5:00.

2017-15/3a CHRISTENSEN, JONES MOVED to cancel the February 13, 2018 meeting of

CHRISTENSEN: Noted Students' Council is due to meet on February 6th, 13th and 27th. Emphasised three meetings as being excessive under the current workload. Described the need for time, in-between Council meetings, for committees to meet.

THIBAUDEAU: Inquired into whether Students' Council meets during an election or campaigning period.

SUNDAY: Responded that meetings do still take place during elections.

2017-15/4 **DISCUSSION**

2017-15/4a Students' Council Office Poster

JONES: Proposed a Students' Council poster be purchased for the sixth floor Students' Council Room office window. Suggested \$10 in order to print the poster.

SUNDAY: Suggested the traffic on the sixth floor of Students' Union Building is insufficient to warrant the placement of a poster. Suggested another location be determined.

JONES: Responded that many persons study on the sixth floor.

THIBAUDEAU: Suggested the SUB Stage area as a better location for a Students' Council poster.

SUNDAY: Proposed posters be placed in Campus of Augustana and St. Jean in order to establish the presence of Students' Council.

ANDERSON: Noted a poster may be placed on the board near the Augustana Students' Association Office.

SUNDAY: Requested a CAC member to volunteer to find the specific locations at which to add posters and return to next meeting with a motion.

SCOTT: Inquired into whether the poster ought to include information about the role and members of Students' Council.

FLAMAN: Proposed a poster similar to the one in main-floor Students' Union Building should be placed elsewhere.

THIBAUDEAU: Proposed InfoLink stations could serve as sites for Students' Council posters.

FLAMAN: Suggested Students' Council pamphlets be made available at InfoLink stations.

SUNDAY: Noted VP Paches is undertaking a redesign of the pamphlets. Supported issuing pamphlets from InfoLink stations.

THIBAUDEAU: Requested CAC allot portions of the budget for pamphlets in years forthcoming.

SCOTT: Noted InfoLink stations predominantly exist in buildings outside of the Students' Union control. Described the potential difficulty of adding permanent posters where most groups use temporary spaces.

FLAMAN: Suggested the top, high portion of the board be used for the permanent posters. Suggested Cllrs. Anderson and Howie arrange the poster dispersal on their campuses.

SUNDAY: Volunteered to investigate spaces for North Campus poster placement.

2017-15/4b Students' Council Facebook Page Policy See CAC 2017-15.02

SUNDAY: Opened that Discover Governance, Cllr. Jones, and himself created a policy for Facebook page posting and content review. Requested councillors provide feedback.

SCOTT: Inquired into the process for a post coming from the page administrator, rather than an individual's account.

SUNDAY: Noted councillors would submit a post to the page administrator for review and posting. Noted anyone may post on the community section of the page.

FLAMAN: Suggested all councillors be enabled to post content through Students' Council page itself.

CHRISTENSEN: Suggested the system for post approval is overly rigours. Expressed faith in the professionalism and benevolence of councillors. Proposed all councillors be granted posting rights.

FLAMAN: Emphasised that the policy may discourage councillors from posting content and decrease page utilisation.

JONES: Suggested the guidelines should determine the nature of the content permitted to be be posted and not the manner in which it is posted.

CHRISTENSEN: Suggested administrators review the posts to determine whose permissions are to be revoked rather than moderating who receives posting

permissions.

SCOTT: Inquired into if, on a page with multiple contributors, it is possible to track which post comes from whom.

CHRISTENSEN: Responded that it is possible to determine the originator of a post.

SUNDAY: Declared the policy grant posting privileges to all councillors with administrative oversight.

JONES: Noted the widespread involvement of councillors will drive student engagement.

SCOTT: Inquired into the nature of the content permitted on the page.

THIBAUDEAU: Indicated that current bylaws prohibit the posting of "any content which [go] against the stated purpose of the UofA SU Strategic Plan and legislation" §3.2.H.

SCOTT: Determined to investigate the inclusion of political policy, which applies to Executive and Faculty Associations, as being part of the 'legislation' in the posting policy.
