### November 4th, 2022 1:00 pm MST Zoom

The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųliné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

2022-11/3a <u>Presentation on Balmoral Lounge</u>

TURNER: Presents on the Operating Plan Overview of Balmoral Lounge.. States that Balmoral Lounge is located on the UofA South Campus in the eastern half of the Saville Community Sports Centre. There is a bar and a full commercial space available at Balmoral Lounge.

Explains how the UASU has gotten involved in this project – Campus & Community Recreation (CCR) approached the UASU in 2021 and stated that there was a lack of food and beverage options on South Campus, which impacted memberships and the reputation of the Saville Community Sports Centre (SCSC). The UASU then began limited catering services at the SCSC in November 2021, operated by the Horowitz Events Centre (HEC)team. The HEC team worked with CCR to plan and design a new functional kitchen after both parties expressed interest in the UASU providing a full-service food and beverage operation. Updates that the kitchen is almost nearing its completion after a renovation. A proposed lease has been sent to the UASU and is being reviewed.

From the UASU side, this is an opportunity for a modest new revenue stream for future years. This space can also serve as back-up coverage for the UASU. It is also an opportunity for the UASU and HEC to have a physical footprint at South Campus.

Key risks involved include: low-margin turnout from the Retail food & beverage industry, increased operational responsibility for alcohol service within campus and the financial risk due to the volatility in start-up revenue projections.
