To: Finance Committee **Re:** Bill 18 Consultation

BONDARCHUK MOVES TO approve Bill 18: Amendments to the (Bylaw 3000) Elections Reserve in Students' Union Bylaw in first reading based on the following first principles:

- 1) The Students' Union holds a number of financial reserves for the purpose of large-expense projects not outlined in an annual budget.
- 2) The Elections Reserve is distinct from the other reserves in that it may be used more frequently and unexpectedly than other reserves.
- 3) The Elections Reserve shall be renamed to the Campaign and Advocacy Reserve, and the definition shall be changed to include advocacy campaigns towards the University, for clarity.
- 4) Guidelines shall be set for use of the reserve, where the Executive Committee has authority to approve up to \$5,000 in spending for a single campaign before requiring Finance Committee to release additional funds.
- 5) An upper limit shall be set on the accrual of the reserve, where additional funds outside the limit will be reallocated to the operating budget on an annual basis.

Fund: This is the fund to which the fee is allocated, in accordance with Bylaws 3000 and 6000.

Fee Level: This indicates the level of the fee.

- "F" indicates the fee payable by each full-time student per Fall of Winter Term;
- "P" indicates the fee payable by each part-time student per Fall or Winter Term; and,
- "S" indicates the fee payable by each student per Spring or Summer Term.

Increase: This is the indexing provision of the fee.

- "CPI" denotes that the fee is indexed to inflation each year.
- "Rolling Average" denotes that the fee "F" and "P" shall be equivalent to the average of the total monies disbursed and net transfers to the fund over the previous two fiscal years and the projected disbursement for the current fiscal year, pro-rated on a per-student basis. "S" shall be equivalent to 50% of "F".

Augustana: This indicates whether or not the fees are assessed to students at Augustana Faculty in accordance with Section 5 (3) of Bylaw 6100.

- "Yes" denotes that students at Augustana Faculty are assessed the fee at the same rate as all other undergraduate students.
- "No" denotes that this fee is not assessed to students at Augustana Faculty.

Limit: This indicates the maximum increase to the fee in a given fiscal year.

Joint Consent: This identifies the body which must consent to the amendment of the fee, as set out in Section 4 (4) of Bylaw 6100.

BONDARCHUK: The operating agreement between the Students' Union and The Gateway as well as the brief payment agreement are not included in the public agenda because they are confidential.

2015-11/3a DFU Financial Package Review: The Gateway

BONDARCHUK: Their review is quite late, and they are aware about it. We have a letter from the Executive Director and the Business Manager of the Gateway. I'll pull out the rules to remind people what we're looking for. They should have a budget illustrating how funds would be spent through the year, audited financial statements, evidence of fulfillment of contracts, evidence of mandate fulfillment, and any other information that the Finance

Committee may need.

FLAMAN: As they have acknowledged, their revenue has dropped. While I do appreciate that they still give some scholarships, it may be prudent to postpone those when there is a \$21,000 shortfall even know the scholarships are only \$1,500.

BONDARCHUK: Those scholarships are a requirement for them to be in this building. They go to students.

FLAMAN: Can we give an exception to that?

BONDARCHUK: We technically could, but I'm not sure of the precedent it'll set for other tenants.

FLAMAN: How many other tenants are facing a serious financial shortfall like this?

BONDARCHUK: I believe none are. I'm not sure.

FLAMAN: Everything else looks good. It's just this point that I'm concerned about. You just don't keep doling money out when you don't have the money.

Was there anything about what the change to their mandate was?

BONDARCHUK: Yes. They'll be going for 4 print issues per term in a magazine format, and 500 unique online contents per term.

FLAMAN: Is it similar to the magazine they print now?

BONDARCHUK: Yes. They are essentially going online.

There has been a significant decrease in advertising revenue, and the budget has dropped by about \$50,000. They hire an external company called Free Media to manage their advertising. They had projected about \$135,000 in advertising revenue initially, but had dropped the projection to about \$85,000 halfway through the year. The Gateway board is not pleased.

FLAMAN: How often is the contract signed with Free Media?

BONDARCHUK: It's a continuous contract.

FLAMAN: Will the board continue with them?

BONDARCHUK: They indicated that they want to continue with Free Media for now. However, I wasn't at the last meeting and don't know if there have been any changes.

With online advertisements, you could identify who's looking at your content much easily. We'll see how many page clicks occur.

FLAMAN: With online content, people use ad blocking software.

BONDARCHUK: Will it affect the company which placed the ad or the host?

WANG: The host. The company pays money whenever the ad is viewed. So, the host may not get money for their advertising space if the ad is not clicked.

BONDARCHUK: Sponsored content is a good solution. I don't know if the Gateway had that conversation.

FLAMAN: Are they eligible to apply for the Activation Fund under conference sponsorship advertising revenue?

BONDARCHUK: No they are not as they're not a group.

FLAMAN: With the economic downturn, it appears that the Gateway wouldn't have consistent revenue.

BONDARCHUK: They have consistent revenue through student fees. About half of The Gateway's budget comes from student fees.

WANG: Do we advertise with them as well?

BONDARCHUK: Our previous contract had given us a guaranteed amount of space in the paper for a guaranteed amount of revenue we give them. That agreement no longer exists. We are still required to advertise things such as elections and certain job postings with The Gateway.

Regarding the scholarships, some of our other tenants do not want to provide scholarships, but have to. To waive that requirement, I believe it should be a separate motion.

FLAMAN: Do you think the proposed changes made by the Gateway would be effective?

BONDARCHUK: Yes, people just don't want to advertise in a downturned economy. I think that it's a smart move to make before it's too late. Print media is on its way out. They have a fair amount of clicks for their online content, and it'll grow when they are primarily online. They'll have to make a good presence during the week of welcome and orientation. Anyway, it's the best option for now. There's a staff structure change as well. This will be talked about at the presentation during Council sessions tomorrow.

FLAMAN: Are they trimming editors?

BONDARCHUK: They'll have the same staff cost at the end.

FLAMAN: How much money would they save from printing?

BONDARCHUK: They save about half the printing cost.

STEPHEN: Was there any reason for the staff restructure?

BONDARCHUK: They added another full-time position last year.

They are also restructuring their contracts as well.

WANG: I'm curious about the bad debts.

BONDARCHUK: These occur whenever they issue an invoice for someone, which remains unpaid.

FLAMAN: This was discussed during CJSR's review too. Their reasoning was that they had lumped together several years' worth bad debts into a single year. That's why it was huge instead of a steady amount.

BONDARCHUK: The Students' Union has bad debts too. We send around the list of people who haven't paid us to other departments so that they wouldn't work with these people in the future.
