5. OLD BUSINESS

(a) Standing Orders Change

IRA: This is the last Standing Orders change regarding the student awards. It basically clarifies consideration means preferential consideration.

HODGSON moved to amend the Finance Committee's Standing Orders 83.f as below:

from-

Voting membership on Students' Council or any of its standing committees, with exception of the Finance Committee, or any positions that have been granted by virtue of membership on Students' Council, shall not be a consideration in the selection of award recipients.

to-

Voting membership on Students' Council or any of its standing committees, with exception of the Finance Committee, or any positions that have been granted by virtue of membership on Students' Council, shall not be a preferential consideration in the selection of award recipients.

(b) Awards Update

IRA: The awards are open now. They opened on Monday. We have been a little weak on non-physical advertising, especially on social media. We are trying to avoid the orientation accounts to actively post things. We are waiting for access to the SU (Students' Union) accounts so that we could do that. There's no real big change.

Does the Finance Committee meet during the finals? In our timelines, we have to finalize the adjudication committee in the first week of December. That would need to be approved by the Finance Committee. We can probably move that timeline up a bit.

HANSRA: I'm assuming the goal of this is to have as many applicants as possible. Is there any budget for social media advertising?

IRA: We haven't given any thoughts to that yet. But, it's definitely an option. I don't think we are using a lot of our marketing budget right now.

We are using listservs to target involved students. There's a new search function on our website which makes it easier for students to look through the awards.

DIAZ: We can put your poster for the next SU newsletter.

IRA: That's a great idea.

(c) Access Fund Agreement Progress

HODGSON: There are no updates for now. My meeting is tomorrow. The same issues regarding the process around appeals, how appeals are advertised, and our representation on the appeals committee remain. We will also be discussing first principles of the bylaw change around the Access Fund at tomorrow's Bylaw Committee meeting.

(b) SU Businesses Pricing Updates

HODGSON: We talked about this before. The increases are marginal. The last price increase was in 2010.

CHEN: These increases have already happened right?

HODGSON: Yes. It has already occurred. From 2010 to 2014, the price of a pound of green coffee beans has gone up to \$5.09 from \$3.81, 2% milk has gone up to \$6.61 from \$3.30, and a sleeve of 50 cups has increased from \$4.95 to \$6.09. The costs have jumped across the board.

CHEN moved to approve the price increases for the Daily Grind and the Undergrind.
