MINUTES (PC 2020-12)

2020-12/1 INTRODUCTION

2020-12/1a Call to Order

MONTEIRO: Called the meeting to order at 5:02pm.

2020-12/2a Policy Updates

MONTERIO: Updated that the Student Employment Policy team has not met since the last meeting. Noted that various Committee members are working on creating a Consultation Policy and a Climate Action Policy and renewing the Assessment and Grading Policy and the Mental Health Policy. Expressed concern that there is no bylaw addressing what occurs when a policy expires for failing to be renewed.

DRAPER: Suggested that expired policies are like milk that goes bad in the fridge: you can still drink it but it tastes poor.

KIDD: Suggested that policies become inoperative upon expiration.

FOTANG: Imagined that a policy could expire while the Committee is in the process of renewing it, leaving a policy gap.

KIDD: Suggested that a temporary policy gap caused by delays in the renewal process would be unproblematic as the Executive would not have sufficient time to advocate for radically different priorities than those contained within the policy before the Committee finishes renewing the policy.

KIDD: Updated that she is now working on the Sexual Violence Policy instead of updating the Health and Wellness Policy with a section on mental health as she has identified the University's Service Excellence Transformation (SET) as an opportunity to effect change in sexual violence supports.

MONTERIO: Invited the Committee to revise the Committee goal tracker as needed based on their work plans.

2020-12/3 COMMITTEE BUSINESS

2020-12/3a Open Education Policy 1st Principles

DRAPER: Established that the Policy's First Principles are ready for approval. Commended Batycki and Fotang on their work in writing the Policy. Noted that the Policy is relatively unchanged from the version the Committee previewed earlier. Invited the Committee to provide feedback as to the Policy's citations. Clarified that the Policy is new and not part of a renewal.

KIDD: Expressed concern that the Policy has uncited definitions. Inquired as to whether the Committee intends to standardise using preambles in all its policies.

FOTANG: Supported the use of preambles given that they provide students context to the policy.

KIDD: Proposed that the Committee write a guide for writing and structuring bylaws in terms of their preambles, definitions, and content.

DRAPER: Determined to add citations to the definitions where possible.

FOTANG: Suggested that some of the Policy's definitions cannot be found in standard dictionaries.

DRAPER: Agreed with Fotang that dictionaries do not define concepts.

KIDD: Proposed that the Committee make clear that policies should be backed with evidence from trusted sources, such as the University Copyright Office.

BRANDWEIN: Commended Draper on the Policy. Proposed revising the Policy to replace technical economics terms with their plain language equivalents.

DRAPER: Determined to act on Brandwein's proposal.

DRAPER/FOTANG MOVED to approve Open Education Policy 1st Principles. CARRIED
