Happy new year! I hope you had a restful and pleasant holiday and are coming back refreshed and energized. I was feeling refreshed and energized until I stayed up all night like an idiot this Wednesday watching the fiasco in Washington, and now my sleep schedule is ruined again. However I did have an opportunity to rediscover the joys of winter cycling. Finding ways to get out and active these days is really important for mental and physical health, and if you can get a solid mountain bike, cycling is surprisingly easy and pleasant! I spent the rest of my break hanging out with my dog and eating cake. Here's a picture of my dog Tilda in her sleepy Christmas mood. There isn't too much to report coming off the holidays.



WTF is happening in Alberta politics?

A lot of our work for the next few months is going to be happening in a very different context, so I will bring you quickly up to speed on what's going on. A number of senior government staffers, the Minister of Municipal Affairs, and four MLAs were caught travelling outside of Canada over the holidays, which is against the government's own guidelines. This has created a pretty serious crisis in the Alberta government. The municipal affairs minister has resigned, the staff who traveled have been fired, and the governing party's poll numbers have dropped dramatically. The government is very distracted by this and the ongoing vaccine rollout (Alberta's is the fastest and most efficient in Canada). So what does this mean for students?

There is a huge amount of unpredictability in the government right now. We don't know if they will choose a more moderate approach or to double down on some of their more controversial plans. This will have a lot of influence on the budget (and the size of the cuts to U of A), which we will see in February, and the Alberta 2030 review implementation.



Alberta 2030 Town Hall with Minister Nicolaides

Myself, VP Agarwal, OASIS President Beasley, and a bunch of other folks from U of A attended Minister Nicolaides' town hall last Thursday on the Alberta 2030 review recommendations. Most of us managed to get a question in. We didn't learn too much we didn't already know, but there was some interesting new information. Here's some of the big takeaways.

- The 2030 review report has been delayed until March or April. As you all know it was initially planned for January. This in some ways makes it much harder for us to respond to it because we had planned for a January launch. This also means we will not need to call a special meeting of Council.
- The Minister has cooled to the idea of tuition deregulation and is not interested in a complete deregulation of tuition. He does feel there is room to explore changes to the tuition model in Alberta, but with some form of firm regulation.
- The Minister says his goal is to ensure every Alberta student has access to a quality work-integrated learning program, making Alberta arguably the first jurisdiction in North America to do that. He clarified that he hopes those opportunities will be available for students in arts and fundamental sciences fields, which is a welcome clarification because his government has invested a lot in engineering/applied science and trades work-integrated learning. That is excellent and we were very pleased to see those investments, but it has left a big gap in access to work-integrated learning for students in other areas.

Lessons in Leadership

The events of the last week in both Alberta and Washington have some pretty valuable lessons in leadership. Words have a real impact, and it's easier to stoke anger than it is to control it. Doing the right thing doesn't count if you wait until it's in your interest. And maybe most importantly, all real leadership is leadership by example-- bad examples in leadership positions seriously hurt communities and organizations. I'm thinking about how I can learn from those lessons to be a better part of my community, and I'd encourage all of us in leadership roles to reflect on it too.

Dear Council,

I hope you all had a peaceful and joyful holiday season, despite probably being away from family and friends. I spent my first Christmas away from my parents, and it was very different. I am looking forward to these next four months of work, as they will be busy and exciting. I have chosen to make this report an overview of the budget process, about which you will be hearing from me quite a bit this semester.

SU Capital & Operating Budget

Governance

The budget process is governed by Students' Council Standing Orders and Bylaws. If you are interested, you can check out <u>Standing Orders s.13</u> and Bylaws <u>1100</u> and <u>3000</u>.

Process

As mandated in Standing Orders, the first step is for the VP Ops-Fi to submit a proposed set of budget principles to Finance Committee. The budget principles set out the Students' Union's priorities and values for the budget, meaning that the money that gets set aside for certain projects, services, initiatives, reserves, etc. is determined by both need and priority. Budget principles are heavily influenced by the multi-year Strategic Plan, meaning that not all budget principles are new every year. Of course, Students' Council has the authority to provide input and alterations to existing budget principles year over year. The Executive Committee and the SU's Core Managers contribute to the creation of the proposed set of budget principles which will arrive at Students' Council through Finance Committee.

After receiving budget principles from Finance Committee, Council reviews, discusses, and amends them as needed. This will ultimately result in an approval of a set of budget principles by mid-March.

The Executive Committee then submits a proposed Operating and Capital Budget, which is built to reflect the budget principles, to Finance Committee. Finance Committee then recommends a final Operating & Capital Budget to Students' Council.

As seen in Standing Orders s.13(6), here is the process for Council's approval of the final budget:

- a. Students' Council shall approve a final Operating and Capital Budget;
- b. The Budget will be presented in a three-part document consisting of:
 - i. The Budget Principles passed on first reading,
 - ii. An estimated numerical breakdown of the budget, and





- iii. Additional written instruction providing further direction on how money within budget categories is to be spent.
- c. Debate is confined to the technical merits of whether the Finance Committee properly interpreted the principles passed in first reading.

Timeline

With some possible changes depending on the speed with which certain phases pass through Students' Council, Executive Committee, and Finance Committee, this is the timeline which we will follow for the budget process. This timeline is based on Standing Orders and Bylaw, so we ought to stick to it as closely as possible.

January 15th: Deadline for submission of budget principles to Finance

February 15th: Deadline for Finance's submission of budget principles to Council

- **February 9th** Council meeting at latest
- January 26th is also possible

March 15th: Deadline for Council's approval of budget principles

- March 9th Council meeting at latest
- February 23rd is also possible

March 31st: Deadline for Exec to submit final O&C budget (reflecting principles) to Finance

- If presentation to Council on March 23rd (see below), must submit to Finance before **March** 22nd

Finance recommends a final O&C budget to Council

- Assume 3 Council meetings
 - Presentation & discussion: March 23rd at latest
 - Approval of first reading: April 6th at latest
 - Approval of second reading: April 20th at latest
- May 1st: Deadline for Council's approval of operating budget
 - April 20th Council meeting at latest

I am very much looking forward to working and learning with each of you during this process. Don't be afraid to ask questions if you have them, and please be patient with me if I have to get back to you on an answer!

Happy Holidays and Happy New Year! I hope 2021 holds good things for all of us, especially a COVID-19 vaccine and any vaccines for new strains.

Student-Friendly Communications

 In response to a Service Excellence Transformation update, I recommended to Todd Gilchrist, Vice-President Finance and Administration, that students would best interact with progress updates on the Service Excellence Transformation through Instagram content, as I did not see that platform included in his outreach strategies. He received the recommendation openly.

College Dean Portfolio Development

 In response to an update regarding College Dean portfolio development, I asked Bill Flanagan how students will be included in shaping this portfolio as the update did not cite student contribution in portfolio development. No answer yet. If you have any ideas about what College Deans should do, let me know, and I can bring them to developers.

AB 2030 Town Hall

- 1. Although he said nice things, the Minister ignored his government's failed oil and gas investments that made them feel justified in cutting post-secondary and decided to operate from the standpoint of, "Now that Alberta is in a tough financial spot, I expect institutions to be fiscally responsible and innovative," throughout the town hall.
- 2. A primary goal of AB 2030 is to co-develop a strategic plan between the government and PSIs in Alberta.
 - a. Because of time constraints I did not get to ask about recommending mandating data collection on minority-based violence, sexual or otherwise, or about populationally accurate representation in institutional governments in Alberta. Others, of whom many were UAlberta students, like Harnoor Kochar, Adrian Wattamaniuk, Beth Blanchette and Rowan Ley, shared tackled about sexual violence response, tuition deregulation, "brain drain¹," bursaries in light of cuts

A brain drain can result from turmoil within a nation, the existence of favorable professional opportunities in other countries, or from a desire to seek a higher standard of living." (<u>Investopedia</u>)



and tuition increases, domestic student enrolment over international student enrolment, and Indigenous student recruitment.

This fall semester has been a very busy one for the Policy Committee. Here is a breakdown of everything the committee has accomplished over the semester (and year), as well as ongoing projects:

Policy Renewal

This trimester marks the end of 2021 policy renewal for the committee. We have made some of these policies more comprehensive (AM, DM, HW, NP, SE) as well as combined existing policies for less redundancy (SFA - this combined the Student Financial Assistance and Scholarships and Bursaries). 2020-18/5 <u>OPEN FORUM</u>

PAWLUK: Inquired as to whether Agarwal believes the SU's had a sufficient response to the Board of Governors' decision to reject the academic restructuring proposal of General Faculties Council.

AGARWAL: Responded that the Board clearly overruled GFC. Recognised that there needs to be a larger discussion concerning the nature of collegial governance at the University.

WATTAMANIUK: Inquired as to Agarwal anticipates student concerns will be heard in the academic restructuring moving forward.

AGARWAL: Responded that faculty and departmental student associations must get involved in advocacy as restructuring changes will be trickling down within university governance.

MATHIESON: Inquired as to whether students were consulted on possible alternative uses for the Myer Horowitz Theatre space before the SU decided to proceed with its renovation using the Sustainability and Capital Fund.

KRAHN: Responded that the SU consulted students over three years on the Theatre renovation and consulted Council on alternative uses of the space.

NARVEY: Inquired to Ley as to what advocacy strategies the SU will employ in an effort to prevent the Alberta Government from deregulating post-secondary tuition.

LEY: Responded that all strategies are being considered, including advertising. Noted that tuition deregulation may not be a priority for the government.

WATTAMANIUK: Inquired to Draper as to whether there will be special meeting of GFC to address online proctoring in the Winter 2021 term.

DRAPER: Responded in the negative. Clarified that he is advocating President Flanagan to call a special meeting.

PAWLUK: Inquired to Agarwal as to how he can ensure that the Board does not reject the views of GFC in future.

AGARWAL: Responded that there needs to be a larger discussion concerning the nature of collegial governance at the University.

NARVEY: Inquired to Kidd as to whether the mandatory instructional fee increase paying for the sexual assault prevention coordinator will be used exclusively to pay the costs related to the salary of the position.

KIDD: Responded that she will not sign a funding memorandum of understanding with the University without a guarantee that the funds will be used only to pay for the coordinator. Clarified that there are costs related to benefits in addition to the salary cost.

PAWLUK: Inquired to Kidd as to why she believes the coordinator will be successful at effecting change in University policy and practice given that the University has been apathetic to SU advocacy concerning sexual assault and refused to pay for the position without increasing student fees.

KIDD: Responded that the coordinator will be effective because they can focus on solely on the issue of sexual assault prevention and operate at a high administrative level. Noted that students can stop paying for the coordinator position when the fee is renegotiated if they feel it does not provide value.

BOSE: Inquired to Agarwal as to the status of SU governance restructuring.

AGARWAL: Responded that the working group is meeting and reviewing reports. Clarified that their scope is Council and not the structure of faculty associations.

DIXON: Inquired to Agarwal as to how the SU can support faculty and departmental associations in advocating for student interests in the university academic restructuring.

AGARWAL: Responded that he will bring concerns from these associations to higher levels of University governance.

LEY: Stated that he will look to call a special meeting of Council to address the Alberta 2030 Recommendations upon their release.

DHILLON: Inquired to Agarwal as to what the SU will do to honour the Ukraine International Airlines Flight 752 in which a UAlberta student died.

AGARWAL: Responded that the SU participated in the and will rename one of its SU Awards after a victim of the crash.

DRAPER: Stated that he is advocating the University to adopt zero textbook cost course signifiers.

MONTERIO: Inquired to Krahn as to how the SU can make it easier for students to apply to the City of Edmonton Ride Transit Program.

KRAHN: Responded that the SU Marketing team can create a guide to help students.

OLIVERA: Inquired to Konrad how he consults students in representing them at Board. Expressed concern that student concerns were not strongly voiced during the most recent meeting.

KONRAD: Responded that many members of the Board were decided on the issue but were convinced to allow new amendments to the proposal that made the Dean's Council superiority to college deans.

BOSE: Inquired to Draper as to how he intends to support the International Student Association in reducing co-op fees.

DRAPER: Respond that he was unaware of this effort and would be happy to meet to address it further.

FOTANG: Inquired to Ley as to what happened to the funds the federal government provided for the Canada Student Service Grant.

LEY: Responded that the funds were used to provide tuition loans interest moratorium, expanding the Canada Summer Jobs Program, and for other employment and skills offerings. Expressed concern that the tuition loans payment moratorium was not extended.

VILLOSO: Inquired as to how the SU is ensuring the compliance of COVID public health orders in SUB.

KRAHN: Responded that the SU hired private security to ensure compliance.

KONRAD: Stated that he addressed several issues related to academic restructuring at the Board including the University's communication failings, the importance of collegiality, the capacities of the Dean's Council, the unknowns and risks of adding an additional layer of administration, and the need for ongoing monitoring of performance and value-for-money.

FOTANG MOVED to amend the Question as follows with changes in red:

The Gateway, founded in 1910, is a student-run campus newspaper and the only student-run media organization at the University of Alberta. The Gateway covers events on campus, U of A and Students' Union governance, the achievements of students and academics, and SU elections. The Gateway also provides students a platform to voice their opinions on important issues.

The Gateway is a not-for-profit, funded by a Dedicated Fee Unit (DFU) and advertising revenue.

The DFU, paid by all part time and full time undergraduate students except those at Augustana Campus, is a non-opt outable \$3.54 per Fall/Winter semester and \$0.54 per Spring/Summer fee, increasing with inflation, and is renewed every five years by a plebiscite.

The fee pays for:

• Publication of over 1000 articles each year, written by volunteers and staff from faculties across the U of A.

- Opportunities for students to work in journalism
- Provides a platform for volunteer contributors
- Community projects such as
 - O Guest columns series where organizations on campus are provided professional training in journalism
 - O Honorariums to organizations to foster campus conversations.
- Collaborations in the field of student journalism

Administration of the fee is overseen by the Gateway Student Journalism Society Board of Directors made up of 12 members: Two (2) volunteer representatives, One (1) Editor's Representative, The sitting Editor in Chief, Two (2) Continuity Representatives, One (1) Community Representative, One (1) Student-at-large, One (1) Students' Council representative, Vice-President (Operations and Finance) of the SU, One (1) Alumni representative, and the Gateway Executive Director.

Do you support the continuation of The Gateway's \$3.54 fee for Fall/Winter semester and \$0.54 per spring/summer fee?
