Good evening Council,

The following is a list of things that I have been working on since last meeting:

1. **Universal Bus Pass** – Alex and I attended another meeting with ETS to discuss the U-Pass. We finalized a project charter and we will be signing off on it soon. We also had the opportunity to learn more about the price calculation for the U-Pass. This meeting was ok, but it continues to be frustrating. We will need to put a lot of pressure on the new city council elected on the 18th if we want the U-Pass to become a reality.
2. **Municipal Election** – The Students' Union sponsored a Mayoral forum on September 30th at Tin Palace. The forum was put on by VOTE! Society and a lot of people showed up. I would like to congratulate the VOTE! Society and our VP External for a well-run event that was covered well by the media. The Students' Union also held a 'Democracy is Sexy' Ship Night with the LHSA. We distributed information on how students can register to vote as well as some Democracy is Sexy swag. We are still sending volunteers to forums around the city. Talk to Alex if you are interested in helping.
3. **Provincial Election Strategy** – The lawn sign campaign is well under way. We have distributed almost 1000 signs. There are five distribution points on campus: the SU, GSA, AAS:UA, NASA, and U-Hall. Please let interested people know how to pick up a sign. We are holding a media conference tomorrow to officially launch the lawn signs and let the public know how to pick them up. We have already had quite a few hits on our website with people requesting lawn signs. As of October 19th we will be distributing signs on public property. We are hoping to have signs all over the city, so if you are available to help, please let us know. Also, I have been in touch with my counterpart in Calgary and they are in discussion with the U of C to possibly order signs for Calgary. As for the coalition campaign, we have met to discuss the radio ads and shot the TV commercials. If you would like more information on the coalition campaign, talk to Alex. We are also planning actions in the coming weeks to 'earn' media. If you would like to help out, or have any ideas for actions, please contact us.
4. **Fest for Knowledge** – The event happened on September 29th with varying degrees of success. I was disappointed with the turnout at the event; however, in my opinion the event was not a total failure. We got media coverage on CFRN, twice on A-Channel, CBC radio, and the Edmonton Journal. Also, the students that did attend the event had a really good time. The event was also a good opportunity to preview the lawn signs.

5. **Budget Advisory Committee** – Alex and I attended the second meeting of the Budget Advisory Committee. We talked about the tuition guidelines and forecast overviews. We also discussed the consultation process for tuition, the proposed increase, the GSA agreement, and Graduate Student Fees. Our next meeting is October 26th.

Report to Students' Council, October 12, 2004

My apologies to Councilor Lettner for not getting this report into the regular agenda package after he asked so nicely at the Sept 28 Council meeting! Despite my best intentions (which were to get this done by Thursday), last week threw a few curveballs my way and I was not able to get it done on time.

❖ PROJECTS:

Academic Survey

Working on compiling academic issues or topics and will be meeting with ATL soon to discuss focus groups. I will likely need to go write up another (!) ethics proposal to be able to conduct this research. Oh joy. The good news: I have a lot more time to complete this project than originally anticipated due to the updated academic planning timeline.

Mid-term Course Evaluations

The UPIO has written a report on her findings from her research into the course evaluation methods used at other Canadian universities. The UPIO, AVPA, and myself will be meeting later this week to review the results and discuss our goals for this project. We are still arranging the live demonstration of the U of C's online system.

Students' Union Undergraduate Survey 2004

We are still waiting for final ethical approval to administer surveys and for bubble sheet paper to arrive at the Bookstore. CNS has already drafted a survey to translate onto the bubble sheets once they arrive. Dan Costigan is contacting instructors via e-mail at present to request permission to survey classes, and we have sent out a job ad looking for people to administer surveys for \$10/hour, which should amount to three classes @ 20 minutes/class. Expected start date for survey administration is October 20, which is about 2 1/2 weeks later than originally planned, but will not seriously harm us.

❖ VP ACADEMIC COMMITTEES:

Council of Faculty Associations Meeting - October 2, 2004

We had a 2 1/2 hour meeting with just under 50% attendance from FA reps, but we had a fairly productive meeting. I gave a 10-minute presentation about University governance and then we spent a lot of time talking about COFA's mandate, each FA's goals, the SU Exec's goals and how we would like to see FAs involved, and ideas for things COFA could work on. The AVPA and I are working to increase the focus on academic issues and advocacy within the faculties by FAs, although there is still room on COFA for discussion about the social and organizational aspects of FAs.

Attendance at Council Meetings

Of late, certain individuals have commented on my supposed negligent attendance at Students' Council meetings. This is somewhat ironic, given my support for retaining attendance requirements. Nevertheless, by my recollection, I have missed two meetings this year: one in August when I was on vacation out of the country, and one in September when I was sick. On three occasions, I have missed part of a Council meeting due to Board-related duties: in August, when I was lobbying at the Riverview Progressive Conservative Constituency nomination meeting; on September 28, when I went to the Ward 5 candidates' forum to lobby candidates on the U-Pass; and on October 7, when I had a previous engagement that gave me some insights into the creation of a new Vet school in Alberta.

While I have no intention of abdicating my SU responsibilities (quite frankly, I've been the most SU-involved BOG Rep in recent history), my job extends beyond merely showing up to Council meetings. It requires a careful balancing of priorities to best use my position to serve students. This is one of the things I have done over the past year and a half, it's something I've done quite well, and it is what I will continue to do.

Highlights from the Board Meeting

Five hours of fun. Some highlights include approval of pre-planning for Phase 2 of the Centre for Interdisciplinary Science (which will include more classroom space and Quad greenspace), approval of the design plan for Augustana, a final report from the Funding Solutions Task Force, updates on ongoing campus capital projects, a presentation from the Faculty of Nursing, and the usual constituency reports. If you'd like more information on anything, please talk to me since, at the time of this writing, my detailed agenda is locked away in my office for the long weekend. Incidentally, I have never seen the Board receive something so enthusiastically as they did Jordan's presentation on the "I Love Alberta's Universities" campaign.

Trimester System

In my last Council report, I mentioned a plan to bring a motion to GFC to study the potential benefits of moving towards a trimester system. I've discussed the issue with Jordan, Lisa and the Provost. For various reasons, I will instead look to include this issue in the Students' Union recommendations to the University's development of the new Academic Plan. Stay tuned.
