Bill #2 – Faculty Association Political Policy Diversion - *First Principles* CHRISTENSEN/PROCHNAU MOVE to amend Bylaw 8100, on the recommendation of Bylaw Committee, to allow faculty associations additional autonomy as guided by these principles:

First Principles

- Faculty associations are often the best representatives of undergraduate students within the individual faculties of the University of Alberta.
- 2. With proper consultation, faculty associations shall be allowed to advocate and represent the interests of their constituents as best as possible.
- 3. Barriers to the effective advocacy of faculty associations shall be removed from Bylaw 8100 to facilitate proper representation of students at a grassroots level.
- 4. Bylaw 8100 shall be amended to allow faculty associations to advocate for issues deemed important to their constituents, even if these issues contradict Students' Union political policies, so long as appropriate procedural steps are completed, including a plebiscite or referendum.
- 5. Upon completing the proper consultative and procedural steps, faculty associations shall provide Students' Council with a summary and presentation of these steps taken.
- 6. Students' Council shall be allowed to discuss, debate, question, and approve/reject the advocacy effort based on presentation provided, procedural steps taken and any other metrics so deemed appropriate.

Bill #1 - Vacancy Petition - Second Reading

CHRISTENSEN/PROCHNAU MOVE to approve the second reading of Bill #1, on the recommendation of Bylaw Committee, and implement Vacancy Petitions as a mechanism to fill vacant Students' Council seats.

Bylaw 100

6 Replenishment

- In the event of a vacancy in the office of President, Vice President, or Undergraduate Board of Governors Representative, the vacancy shall be filled in the following manner
 - a. if the vacancy occurs during the period on or after May 1st and on or prior to September 1st, Council will appoint an individual to the position on an interim basis until the results of the by-election are announced in accordance with Bylaw 2400.
 - if the vacancy occurs in the period after September 1st, but on or before April 30th, Council will appoint someone to the position for the remainder of the position's elected term.
- 2. During the Council meeting on or immediately following the vacancy, Council shall move to create the Executive Nominee Selection Committee of four (4) members
 - a. these members shall be taken from Students' Council; and
 - b. this committee shall only meet at the close of nominations, in the event that more than ten (10) applications are received, with the mandate of narrowing the pool of candidates to ten (10)
- 3. Following the Council meeting where the vacancy occurs
 - a. the business day immediately following the meeting in which or following when the vacancy occurred, the C.R.O. will make applications for the vacant position available to the Students' Union membership.
 - The C.R.O shall produce nomination packages which shall contain, at minimum
 - a. complete and current copies of
 Bylaw 2200 and Bylaw 1500; and
 - nomination papers soliciting the name, contact information, and student identification number of the

proposed nominee, the position the nominee wishes to contest, and for Executive and Board of Governors elections, nominations papers soliciting the names, faculties, years, signatures, and student identification numbers of at least fifty (50) and at most one hundred (100) members as nominators.

- ii. Valid nomination packages shall contain
 - a signed acceptance of the nomination by the proposed nominee;
 - a signed letter from the proposed nominee's faculty confirming that the nominee is in good academic standing under University regulations; and
 - c. papers soliciting the names, faculties, years, signatures, and student identification numbers of at least fifty (50) members identifying themselves as nominators.
- b. nominations shall be closed seven (7) days prior to the next Council meeting.
- 4. Selection of the candidate shall be made on the basis of interviews held during the next Council meeting following the close of nominations as well as any relevant information from the nomination package.
- 5. The appointment will be made with respect to a vote by Council using a preferential ballot.
- 6. In the event of a vacancy in the office of Councillor, the Chief Returning Officer of the Students' Union shall offer the position to the candidate who would have been elected had another Councillor been allocated to the resigning Councillor's faculty during the last election before which nominations were open for that faculty.
- 7. Notwithstanding (2), no person shall be offered a Councillor position who
 - a. has already vacated a Councillor position since the last election before which nominations were open for the faculty in question,

- has already declined appointment to a Councillor position since the last election before which nominations were open for the faculty in question, or
- c. is a member of Students' Council.
- 8. The process for replenishment of Councillor positions shall continue until
 - a. no vacancies remain for the faculty in question,
 - the list of candidates from the last election before which nominations were open for the faculty in question is exhausted, or
 - c. the position would be offered to None of the Above.
- 9. In the event that vacancies exist after the procedures outlined in (6) and after the by-election outlined in Bylaw 2400(15), the Vacancy Petition system shall be used as outlined in Section 20 of this Bylaw.
- 10. Students' Council does not have the authority to appoint any Councillor.
- 11. In the event of a vacancy in the office of the Speaker of Students' Council, Students' Council shall select a new Speaker of Students' Council.
 - a. representing Students' Council before the Discipline, Interpretation, and Enforcement Board; and
 - b. other duties as may be required by Students' Council from time to time.
- 2. The Speaker shall have access to sufficient administrative support to carry out the logistical needs of Students' Council.
- 3. The President of the Students' Union reports to the Speaker for of purpose of all Students' Council business.
- 4. The Speaker reports to Students' Council.
- 5. The Speaker may be dismissed by a simple majority vote of Students' Council.
- 6. The Chair of the Council Administration Committee shall be the Deputy Speaker of Students' Council and shall carry out the duties of the Speaker in the absence of the Speaker of Students' Council.

20 Vacancy Petitions

- Immediately following the by-election period for Students' Council, as outlined in Bylaw 2400, the office of Discover Governance, with the assistance of the Chief Returning Officer, shall create a Vacancy Petition form for all faculties with vacancies and disseminate the form broadly, including to the Faculty Association in which the vacancy is held.
- 2. The Vacancy Petition form, to be filled out by the candidate, shall include:
 - a. the name, e-mail, faculty, and ID number of the candidate seeking to fill the vacancy; and
 - b. a signed acceptance of the petition by the candidate; and

- c. a signed letter for the candidate from their faculty confirming that they are in good academic standing under University regulations; and
- d. a list of nominators including the names, faculties, years, signatures, and student identification numbers; and
- e. a copy of Bylaw 100(20); and
- f. a link to the Vacancy Petition webpage.
- 3. In order for the petition to be declared valid, the candidate must collect a greater number of signatures from nominators than either 3(a) or 3(b), whichever is lower:
 - a. the voter turnout percentage in their vacant faculty during the last general Students' Council election in which a candidate ran; or
 - b. the mean voter turnout percentage for the last three (3) general Students' Council elections.
- 4. The Vacancy Petition form for Open Studies students shall include all requirements mentioned in (2) with the exception of collecting nominators' signatures.
- 5. The completed Vacancy Petition shall be submitted to the Office of Discover Governance upon its completion for validation of nominators, if applicable.
- 6. The first valid Vacancy Petition submitted for a given faculty will trigger a seven (7) day period after which no other petitions will be received per vacant seat.
- 7. If no other valid Vacancy Petitions are received within the seven (7) day period, the successful candidate shall be declared a Councillor for the vacant seat for the remainder of that term.
- 8. If two or more candidates submit valid Vacancy Petitions for the same seat during the seven (7) day period outlined in (6), the candidate with the most signatures at the end of this period shall be the winner.
 - a. Any candidate shall be allowed to retrieve their petition during the seven
 (7) day waiting period to collect more signatures, so long as the final
 petition is re-submitted by 5:00pm on the last business day prior to the
 deadline.
 - b. In the event of a tie in the number of signatures, the Chief Returning Officer shall determine the winner by flipping a coin or other random-chance tie-breaking method in the presence of the Deputy Returning Officer or a member of the Office of Discover Governance.
- 9. Individuals that are ineligible to submit Vacancy Petitions include:
 - a. any member of Students' Council; or
 - b. the Speaker of Students' Council; or
 - c. the Chief Returning Officer or Deputy Returning Officer; or
 - d. any student who ran during the previous general election or by-election and lost to none of the above; or
 - e. any student who has previously used this mechanism in the last 365 days; or
 - f. two person candidates.
- 10. The period for Vacancy Petitions to be submitted shall be from:
 - a. the first business day following the fall by-election; to
 - b. February 1 of the subsequent year.
- 11. The Office of Discover Governance, with the assistance of the Chief Returning Officer, shall create and maintain a Vacancy Petition webpage to list the current status of all vacant Students' Council seats:

- a. the link to this webpage shall be included in the Vacancy Petition package;
 and
- b. this webpage shall be maintained with regular updates, deadlines and other relevant information; and
- c. at a minimum, the number of packages submitted in each faculty shall be updated daily during the seven (7) day deadline period.

21 No Force or Effect

1. Any decision of Students' Council that is in conflict with federal or provincial statute or with the Common Law is of no force or effect.

Bylaw 2400

15 By-Election - General Faculties Council and Students' Council

- 1. Where vacancies exist in positions filled under this bylaw on August 15 of any year, the C.R.O. shall call a by-election to take place in September or October of that year for all those positions vacant on August 15.
- 2. Notwithstanding Section 15(1), if positions become vacant between August 15 and twenty-four hours prior to the release of the nomination package, those positions shall also be included in the by-election.
- 3. Where the total voting membership of Students' Council falls below twenty-three, the C.R.O. shall call a by-election to occur
 - a. not more than one month past the date that the voting membership of Students' Council fell below twenty-three; or
 - b. where Students' Council's voting membership falls below twentythree during the months of May, June, July, or August, in September.
- 4. Except as otherwise stipulated in this bylaw, there shall be no by-elections to fill positions filled under this bylaw.
- 5. The deadline for the nomination of candidates in any by-election shall be determined and announced by the C.R.O. at the same time as the date of the by-election is announced, such deadline occurring not less than nine (9) days prior to the Election.
- 6. The commencement of the Campaign for any by-election shall be determined and announced by the C.R.O. at the same time as the date of the by-election is announced, such commencement occurring not less than five (5) days prior to the Election.

- 7. Except as otherwise stipulated in this bylaw, any by-election shall be conducted in accordance with the rules governing the Election.
- 8. Where vacancies exist following the fall by-election procedures outlined above, Vacancy Petitions, as outlined in Bylaw 100(20), shall be used to fill these seats.

Bylaw 2100

8 Duties of the Elections Staff

- 1. The duties of the Chief Returning Officer shall include:
 - a. overseeing the implementation of the Elections Bylaws, Bylaws
 2100 through 2500; and
 - such duties as may be required of the Chief Returning Officer under
 Bylaw 100 and the Elections Bylaws: Bylaws 2100, 2200, 2300,
 2400, 2500; and
 - c. the submission to Students' Council of a written report of activities and recommendations prior to April 30.
- 2. The duties of the Deputy Returning Officer(s) shall include:
 - a. such duties as may be required of the Deputy Returning Officer(s)
 under the Elections Bylaws, Bylaws 2100 through 2500; and
 - b. such assistance as required by the Chief Returning Officer in the discharge of their duties, as set out in Section 8(1).

Hi Council,

Hope your summer is going well, and those of you who attended enjoyed Gov Camp! Gov Camp marked the end of a string of transition conferences federally, provincially and locally. For the majority of the summer, **I'll be at home base** until CAUS and CASA pick up for conferences again.

Here is an update on my duties:

1. Residences

The first meeting of the Residence Life Task Force occurred, where we outlined a few major **issues** that **the Task Force will investigate** when it comes to the student experience in all our residences. Some items in particular that arose were respecting **students' established democratic processes**, **ambiguous tenancy processes** and the collision of expectations between groups in residence.

We will be **interviewing students and other stakeholders**, like Facilities and Operations, through the summer, which is where VP Ghossein's Residence Life Testimonial form will come in handy.

2. Board of Governors

The Board had our last meeting of the summer, where a few items that had been vetted by Board committees were approved. In particular, the **Board approved** the Institutional Strategic Plan "For the Public Good" unanimously.

There was also a **Board dinner the evening before** this meeting where we recognized the hard work of many retiring Board members, including last year's President Navneet Khinda.

3. CAUS & CASA

CAUS had a meeting where we reformed our budgeting processes so that we budget based on more consistent information from year to year. It does mean that UASU will be paying an additional 2% towards CAUS next year, which should be manageable within our budgets.

I **chaired the first meeting of CASA's Policy committee** with help from Vice-Chair Tina Oh, the VP External at Mount Allison Students' Association. We found a few areas that Policy committee will be focusing on this year, and will take the list to CASA's full membership at the next conference.

4. GFC



I attended a meeting of **GFC APC (Academic Planning Committee)**. The agenda was very light as we approved two graduate program changes that were already quite vetted.

5. Internal Projects: Access Fund & Myer Horowitz Renovations

The executive had a meeting to discuss some of our future goals for the **Access Fund** and student financial aid, as well as how to proceed with renovations to our Myer Horowitz theatre. Ideally we would be able to fund as many students as possible with the Access Fund, but we are seeing it may have a different, but complementary, role to what the Registrar's Office has for financial aid.

The **Myer Horowitz renovations** are a bit easier to decide upon, as there haven't been any renovations since the theatre was built. Look for a presentation to Council on the current state of the Myer Horowitz Theatre (MHT) and some of our options for renovations in the near future!

6. Executive Retreat

We held our **first executive retreat** last weekend, which I thought went very well! It was a nice way to include team bonding in an informal setting outside of the office, and also map out some strategies and resources that our goals will require this year.

7. Presence and Relevancy

I attended **my own convocation** and enjoyed shaking hands with a number of people that I'll be working with throughout this year as I collected my own B.Sc.

The entire Executive also attended the afternoon convocation of Arts and Natives Studies, where our new **Chancellor Douglas Stollery was installed**.

The university received its **largest single donation** ever from the Stollery Foundation and Royal Alexandria Hospital Foundation towards Women's and Children's health research, and I also attended the **wrap-up BBQ for the University ISP**. Finally, the full executive attended an event hosted by Dentons LLP.

That's all from me for now, and looking forward to the next report!

On June 21st, VP Paches and I attended the Mary Robinson Special Conferral Ceremony. Mary Robinson is the first female President of Ireland and served as the United Nations High Commissioner for Human Rights from 1997 to 2002. She delivered an inspirational speech in which she honoured MP Jo Cox. Mary Robinson was instrumental in advancing issues on human rights, good governance and climate justice and I highly encourage you to look into her life story and endeavours.

In other news, every two weeks, one member of the executive committee writes a blog post, which is then posted on the Students' Union website. ADVOCACY

Residence Life Task Force

On Friday the 17th, President Rahman and I had our first Residence Life Task Force meeting with the Dean of Students and the Deputy Provost. We talked about the different topics that we would talk about as well as the timelines and the processes that we need to determine (interviews, membership, etc.). Our next meeting is going to be in July (with the new Dean of Students) and we'll be having bi-weekly meetings from then onwards.

Lister Representatives

We have re-opened the applications for the Lister Representatives Positions- the deadline for the new aplications is July 4th. We have one to two positions to fill and have offered the positions to 3 students already.

HEALTH AND SERVICES

I have been meeting with our staff from the Peer Support Centre as well as the Associate Dean of Students, the Community Social Work team to chat about their visions for the year. They are

currently working on the ACCESS project (focused on the prevention of mental health concerns, starting with first year students) and I have been discussing what my role would be within that project.

COMMITTEES AND BOARDS

Campus Food Bank

I had my first meeting on the CFB board. We talked about ideas for their annual fundraiser, which could be replaced by a celebration of the 25th anniversary. I got to meet the board members, talk about staff additions and changes as well as the search for a new database that would offer more options to the way that the numbers are currently tracked.

UPASS

VP Paches and I will be involved in the upcoming negotiations around the UPASS. We have attended internal meetings where we communicate our negotiation targets with the University. In our next UPASS meeting with the City and the different stakeholders (MacEwan University, etc.), we awill be determining the timeline for the negotiations.

Finance Committee

We approved some changes made to the structure and the procedures of student group granting and the adjudication of SU awards after having listened to presentations from SU services staff about the rationale behind the changes.

UASU

Health & Wellness Conference

The Health & Wellness Conference (informally known as the day the VP X proved that Externals show up just in the nick of time) was a conference centered around alcoholism and substance abuse at the University of Calgary. Last Tuesday I had the chance to travel down with VP Al-Ghoessein as well as councillor Kwan to learn more on the subject. For the first part of the conference we found ourselves at a round table with representatives from various organizations, and had the chance to talk about the effects of substance abuse on our campuses. I found myself next to a counsellor from SAIT and was able to learn more about the effect alcohol abuse and binge drinking had on her campus. This panel brought up the intersectional issues related to drug abuse, things such as gendered issues around preception/shaming of drinkers (everything from casual drinking to binge drinking), as well as target demographics. One of the most interesting takeaways I had from that session was on preventative strategies to substance abuse and mental health decline. An audience member brought up the point that preventative strategies should be tailored to include all members of the student population. The example that she brought forward was that puppy rooms and face painting can only go so far, when it comes to someone who is more interested in football and fishing, for that individual a better way to help prevent a decline in mental health would be to hold something they're interested in such as a small football game. The point being, that when considering preventative measures we must consider the target populations point of view. The best way to ensure our services are being access by those who need it is to make sure we are speaking the same language they do.

She asks about Geer Week.

Councilor Prochnau's Response to Councilor Nahid:

He is in charge of Geer Week and explains what is Geer Week. It is essentially the Engineering version of Anti-Freeze, which will be hold in January. He welcomes all the university students to attend this event.
