Standing Orders of the Bylaw Committee Last approved April, 2016

Content of "Report to Students' Council"

- 11(5) The Report to Students' Council will consist of:
 - (a) a document styled "Summary of Proceedings" which <u>will</u> be a brief <u>written</u> summary of the Bylaw Committee's activities at the relevant meeting,
 - (b) a document containing a list of all motions voted on by the committee that the committee intends to be of force and effect in accordance with *Bylaw 100 s. 16(3)*, and
 - (c) an appendix of all documents voted upon by the Bylaw Committee for the purpose of providing an audit trail and accurate record of actions taken.

Bylaw 100 Last approved June, 2016

16. Reporting Structure

- The chair of each standing committee shall, after each meeting of the committee, submit to Students' Council a report including
 - a. any decisions made by the standing committee acting under authority delegated to it by Students' Council,
 - b. any recommendations made by the standing committee to Students' Council,
 - c. any standing orders adopted by the committee, and
 - d. a summary of all motions passed by the standing committee at the meeting in question
- 2. The Speaker shall table each report from each standing committee in Students' Council.
- 3. No decision made by a standing committee acting under authority delegated to it by Students' Council is effective before it has been provided to the Speaker as part of the standing committee's report to Students' Council.
