PRESIDENT RAHMAN'S RESPONSE

Thank you for the question Councillor Christensen. This year we relied solely on student volunteers to support the implementation of Bylaw 600, which meant few guarantees on frequency of translation or quality of translation. Any documents translated by students would have to be reviewed by both the CSJ Councillor and AUFSJ President, creating further delays.

As a result, no documents were translated this year. To tackle this issue, VP Paches has included a new principle in the budget: "Resources will be made available for the translation of all Students' Union bylaws and policies into French." Dedicated resources should help accomplish this goal by the end of the 17 - 18 year.

Budget Principles 2017-18

This is intended to serve as an outline of the fiscal priorities of the University of Alberta Students' Union for the fiscal year beginning May 1, 2017 and ending April 30, 2018. This document is legislated under Students' Council Standing Orders, and is mandated as a responsibility of the Vice-President (Operations and Finance) under Bylaw 1100.

Preamble

The Students' Union is guided by our Strategic Plan. Our mission is to serve, represent, and engage students. The four pillars that support our mission are:

- Services and businesses
- Events and programs
- Building space
- Advocacy

Our guiding values are:

Fiscal Considerations

Budget principles shall outline the basic direction for creation of the budget. The following adjustments lie outside of budget principles and, while they should be considered in the submission, are at the sole discretion of Students' Council and/or any other legislative body outlined in Bylaw:

- Alberta Consumer Price Index (ACPI) calculations for 2016-17
- Total membership revenue based on enrolment estimates from the Office of the Registrar
- Changes to the Post-Secondary Learning Act by the Government of Alberta
- Students' Union Membership Fee increases (beyond inflation) and decreases
- Students' Union Dedicated Fee increases (beyond inflation), decreases, creation, and/or elimination



Principles

1. In the event that a section of this document conflicts with any other section, the Finance Committee shall identify such a conflict and propose any necessary changes in the presentation of the final budget.
2. Total operating and capital expenditures will not exceed the amount of total operating and fee revenues. The only exception to this would be council-approved capital purchases that do not cause a deficit on an accrual basis.
3. Capital budgeting shall be apportioned at the discretion of the Financial Controller and Vice President (Operations and Finance) after the operating budget has been created. Using the set amount of capital funds allocated, decisions for use of capital funds shall be made by the Core Manager responsible for each unit.
4. The Students' Union shall not budget for a deficit in its operating and capital budget. Growth in a department shall be offset by a variety of strengthened revenue streams in that department, where possible.
5. All departments must work within the mandate of the Students' Union; activities or operations deemed to be beyond its scope shall be eliminated. The 2015-2018 Strategic Plan shall be used as a guide to assess relevance and value prior to such decisions.
6. External entities such as dedicated fee units and operating grants shall be managed as per existing Students' Union Bylaws and applicable contracts.
7. Unless otherwise noted, operating and fixed costs increase at a rate relative to the previous fiscal year no higher than inflation for the province of Alberta; activity of the Students' Union will continue in a manner consistent with the precedent set in previous fiscal years.
8. The Students' Union shall implement all necessary financial restraints and audits as required by the Post Secondary Learning Act and its own Bylaws and Standing Orders.
9. Unionized staff costs shall change as specified in the CUPE (Canadian Union of Public Employees) collective agreement. Managerial and other union-exempt staff who are not term staff are entitled to a merit increase in accordance with their respective employment agreements, appraisal outcomes and cost of living adjustments (based on ACPI). (Edited)
10. Operating and dedicated fees shall increase in accordance with the Students' Union Bylaw 3000, as set out in the 1992 referendum approving increases based on the Alberta Consumer Price Index. Based on estimates, ACPI for 2017-18 will be approximately 1.5%. (Edited)



11. In addition to ACPI increases, the Students' Union's Membership Fee shall increase by no more than an additional 10%, as approved by Students' Council, in direct response to the Alberta government's long-term plan to increase minimum wage. (Edited)
12. Resources shall be made available for recurring projects of the Executive Committee, provided they can show need for such resources and consistency of such projects.
13. Resources will be made available for the Executive Committee to build positive relationships with important stakeholders. Examples include Faculty Associations, Residence Associations and members of the University of Alberta Board of Governors. (New)
14. Resources shall be made available to promote and enhance visibility and constituency engagement for members of Students' Council.
15. Recurring, annual expenses of Students' Council shall be budgeted for outside of resources made available to promote and enhance visibility and constituency engagement for members of Students' Council. (New)
16. Resources will be made available for the translation of all Students' Union bylaws and policies into French. (New)
17. The Students' Union shall allocate resources to provide sufficient staffing to support student governance objectives.
18. The Students' Union shall allocate resources to increase the salary of Executive elected positions to bring the remuneration in line with the provincial average. (New)
19. The Students' Union shall allocate resources toward professional advice and services as they relate to advocacy.
20. Resources shall be made available for increased administration of student groups, should the Students' Union need to increase capacity in Student Group Services.
21. The Students' Union business units shall not budget for a deficit prior to cost apportionment allocations. All reasonable attempts to maximize the profitability of these business units, consistent with the mandate of the Students' Union as a service provider, shall be made.
22. The Students' Union shall allocate resources toward customer experience & retention improvements in its licenced establishments. (Edited)
23. The Students' Union shall allocate additional resources and staff towards the promotion of its business units.



24. The Students' Union shall allocate additional resources toward front-facing visual and operational improvements for its businesses and venues. (Edited)
25. Where possible, all entertainment units shall plan to recover all costs. Admission sales, sponsorship, and donations are acceptable sources of revenue.
26. The Students' Union shall make resources available towards a renovation to the Myer Horowitz Theatre and its corresponding capital fundraising campaign. (Edited)
27. Costs associated with Marketing and Communications, Facilities and Operations, and Administration shall be apportioned to all departments of the Students' Union based on usage.
28. Resources will be made available to provide honorariums for Elders to attend relevant meetings and events of the Students' Union. (New)
29. Resources will be made available for piano and microwave repairs that fall under Students' Union responsibility. (New)
30. Steps shall be taken towards the creation of a client services program for the purpose of creating efficiency and value for the booking of conferences and other multi-step events in the Students' Union Building.
31. Resources shall be allocated towards improving the audio and visual components of the Students' Union's venues.



Removed - 2017/18

1. In line with Operating Policy 5.12, non-academic materials offered for sale shall have price increases approved by the Core Manager responsible for that unit when necessary to balance annual expected revenue with expected costs. Where costs have increased in academic material areas, there shall be a marginal increase to compensate. (Already in Operating Policy)
2. The Students' Union shall allocate resources toward professional advice and services as they relate to advocacy. (In the SU structure)
3. New lease space shall be available in the Students' Union Building and may need to be funded accordingly. (Completed)

Mandatory Non-Instructional Fees Political Policy

Second Reading

2 Resolutions

1. The University of Alberta Students' Union will advocate for a predictable cost of post-secondary education, that can be reasonably anticipated year-to-year.
2. The University of Alberta Students' Union will advocate for an affordable cost of post-secondary education for all current and potential students.
3. The University of Alberta Students' Union will advocate for an accessible cost of post-secondary education, especially for students facing financial or cultural barriers.
4. The University of Alberta Students' Union will advocate to the Government of Alberta for the regulation of all mandatory non-instructional fees.
5. The University of Alberta Students' Union will advocate to the Government of Alberta for a framework which clearly defines which fees are non-instructional and therefore outside the framework established in the Public Post-Secondary Tuition Fees Regulation.
6. The University of Alberta Students' Union will advocate for a process where students provide meaningful input on which services mandatory non-instructional fees pay for.
7. The University of Alberta Students' Union will advocate to retain the student-approval mechanism for the implementation of any new mandatory non-instructional fees as well as for an increase to any existing mandatory non-instructional fees.
8. The University of Alberta Students' Union will advocate for transparency and accountability procedures as to where and how the fees levied on students are spent.
9. The Students' Union will advocate that students maintain representation on any body directing the general affairs and mandate of a service which is funded by a student fee.

Internationalization Political Policy

First Reading

1 Facts

1. The number of international students in Canada has increased by 148 percent from 2002 to 2011[1].
2. The number of international students transitioning from temporary to permanent resident status increased by 16 percent from 2002 to 2011[2].
3. The rate of international students transitioning from temporary to permanent resident status in the past decade has not kept up with the pace of international student enrollment in Canadian post secondary institutions.
4. The International Differential Fee (IDF) represents a serious threat to affordability and accessibility.
5. International students have less access to merit-based and need-based aid than domestic students, and do not have access to Provincial or Federal Government student loans.
6. Renewable scholarships for international students are important for their financial planning and cannot be regained if lost.
7. Post secondary institutions are permitted to charge international students more than they cost to educate.
8. International students should not bear the burden of an institutions' financial deficits.
9. The University of Alberta and the Students' Union recognizes the importance of international students.
10. The Government of Alberta does not require educational institutions to charge International Differential Fees (IDFs).
11. The Public Post-Secondary Institutions Tuition Fees Regulation does not regulate International Differential fees (IDFs).
12. The International Differential Fee limits the geographic diversity of our international students.
13. A diverse student body and institutional internationalization is a fundamental feature of a high-quality university education.
14. An enhanced campus experience may increase engagement and retention of international students.
15. Surveys have shown that:
 - a. integration with domestic students;
 - b. accessibility of on-campus housing; and
 - c. quality of career-related programming are the top three experiences international students seek in their post-secondary experience.
16. The transfer credit system plays a pivotal role in enhancing the quality of internationalization at the University of Alberta.

17. Cultural awareness and global experiences are highly sought-after attributes by potential employers.
18. Public reporting of statistical information regarding international students is infrequent and difficult to obtain.

Public Transit Political Policy

First Reading

1 Facts

1. Public transit is a common mode of transportation used by University of Alberta students that benefits the quality of life of all members in the community.
2. The U-Pass is to be implemented in the academic years consistent with the referendum Conditions.
3. The post-secondary bus pass provides a more affordable public transit option for students than a regular adult pass.
4. Public transit expansion would allow improved access for University of Alberta students to commute within the service area.
5. Smartfare technology would reduce the possibility for U-pass fraud and reduce the need for a U-Pass replacement fee.
6. Students who are employed with the University are not eligible for employee transit benefits. That leaves student employees who are not enrolled in a class for the spring/summer semester without a more affordable option than the adult bus pass.
7. Students often feel unsafe using public transit.

Scholarships and Bursaries Political Policy

First Reading

1 Facts

1. The cost of a university education has increased
2. This cost increase poses a great disincentive to accessing a university education, as well as a considerable barrier to finishing a degree
3. Scholarships and bursaries are an integral part of the student finance system, without which motivated and outstanding individuals could not afford a university education
4. The University of Alberta should not only aim to attract talented students, but demonstrate a commitment to realizing the full potential of current undergraduate students
5. Financial need can be detrimental to academic and extracurricular student achievement by diverting student focus and effort to employment
6. The current scholarship and bursaries applications process is inefficient and time consuming.

Hi Council,

Happy second last Council meeting of the year! Transitioning with the incoming executive team, particularly President-elect Banister, has been taking up the most of my time. I was also away for the CASA AGM last week, so expect a briefer report.

Here is an update on my activities since we last met:

1. CASA AGM

Our AGM in Wolfville, Nova Scotia was very productive. I was able to get six CASA policy revisions approved by the membership, most of which were related to the federal changes to the Canada Student Loans Program. The Federal Policy Committee also met to discuss what next year's team will likely need to look at with respect to CASA policy on the loans program.

2. Lister and PLH Meal Plan

The Board has approved a new meal plan for Lister, which is a variant on the Declining Balance model. I voted in favor of this meal plan. The meal plan for PLH was approved as well, and is an Anytime Dining model, that I think will not benefit students as much as the Lister plan. The other significant item covered at the Board meeting was the Comprehensive Institutional Plan, which contains our projected operating and capital budgets through the next three years. We also welcomed six new Board members at this meeting, who I think will provide great insight at meetings.

3. CAUS: Provincial Budget

The provincial budget was released, and incoming VPX Larsen, CAUS Chair Bruneau and I were present at the Legislature to field media questions. We also saw Minister Schmidt handle a media scrum on the investments towards post-secondary too. The budget is generally positive for students, with a 2% increase to university operating grants and renewed mental health funding.

We are not sure yet how the Mental Health advisory panel will impact the distribution of mental health funding, which is one area of concern for students. We also were expecting more investments in student financial aid, but saw some improvements with \$10 million invested here.

4. Deferred Maintenance: Dent/Pharm

The full executives were present for the announcement between the Minister of Advanced Education, President Turpin and myself for the \$149 million investment to renovate Dent/Pharm. I expect the project to take roughly three to five years. It seems as though the Registrar and Dean of Students offices will be relocated here to centralize essential student support offices.

VP Paches had a chance to review some of the building renovation plans, and is excited for what the new space can entail.

5. Academic Governance

I attended GFC alongside VP Banister, VP Ghossein, and a few of the incoming VP-elects. VP Banister and I also had a meeting with the Provost, where we gave an overview of some of the incoming Executives' priorities for next year. We did the same in our regularly meeting with the Registrar's Office this week as well.

6. Signature Areas Development Panel

VP Banister, VP Paches and I were present at the Signature Areas Development Panel Campus Forum, where President Turpin and Provost Dew solicited feedback from the community on how to best develop some of the emerging themes we've seen so far at the U of A.

7. Podcast

After a brief hiatus with so many executives away for the elections, the Voice of the Union podcast has returned. I spoke with VP Ghossein about the SUB House party in a couple of weeks, as well as the mental health funding. I also spoke with VP Sandare about the provincial budget announcement.

8. Presence and Relevancy

Elections for Council, GFC, FAs and DAs are wrapping up now, after the peak presence the SU had during Executive and Board elections. I congratulate all the candidates who put their name forward, and wish the incoming Council a productive and satisfying year.

I look forward to the upcoming meeting. All the best,

There was a GFC meeting on Monday March 20. As always I hosted the GFC Student Caucus meeting the Friday before where we discussed the agenda in advanced and I was able to answer any questions they had. At the GFC meeting we discussed learning initiatives, got an update from the Ad Hoc Committee on Academic Governance and Delegated Authority, voted to approve the sexual violence policy, got an update on the decommissioning of the nuclear reactor in the dent/pharm. building, as well as received the recommendations from the Scholarly Writing committee. Hey Council,

Wow, is it ever nice to be back. Three weeks off feels like forever, and I am finally getting settled back in. Last week was essentially 100% playing catch-up, and this week I was able to get back to my regular meetings and work. While it was tough to catch up, I feel like three weeks for a whole more year was a good trade. AMIRIGHT? In this report, I'll update you with that I've been working on and some important meetings that took place.

Budget Principals 2017/18

After returning from elections, and after receiving CAC's recommendations, I was able to complete budget principals. You will see them attached to this agenda. The UASU budget works in a similar fashion to a bylaw. The principals are essentially the first reading, and are the basis on which the full-itemized budget is created. Therefore, you won't see any specific numbers on this document, but you will see ideas that will guide them. I've been spending a good amount of time creating and consulting on them. If you have any questions or feedback, don't hesitate to ask me ahead of time, or during debate on my motion to approve.

St. Patrick's Day on Campus

Last Friday was legit one of my favorite days of the year, ST PADDYS DAY! I mean, what other holiday do you essentially get a free pass to hang out with your friends at the pub all day? Whether or not you hit up a pub, I hope everyone enjoyed it. We hosted events at Room at the Top & Dewey's, and both venues were packed. I am hoping to continue this trend of capitalizing on occasions to bring people into our bars. Shameless plug warning: In other words, bringing students back to campus!

Health & Dental Plan Committee

Last this week, VP Ghossein and I attended a meeting of the Health & Dental Plan Committee. The core elements of the discussion that took place, and the decision that was made, can be found in Studentcare's presentation at the beginning of this meeting. But key takeaways are that claims continue to grow, especially dental, and we need to find a way to continue to provide coverage, while keeping fees down.

Access Fund

Over the course of the last week, a member of our management team, Sirina Hamilton, and I were working with the Office of the Registrar to disburse the second last round of Access Fund grants. We only have one more round to go, and I am happy to report it is very likely we will remain on



budget this year. This is huge, as last year we were significantly over budget. Usage of the program is up as well this year.

Alberta Budget 2017 – Dent/Pharm & Deferred Maintenance Funding

Last week, the provincial government announced their budget. Overall, post-secondary students saw some things remain the same, and some improvements. We are happy to see that nothing was cut. Check out VP Sandare's Facebook page for a detailed outline. Specifically, I was ecstatic to see increased funding for deferred maintenance in two areas. The government has committed \$149m to restoring the Dent/Pharm building, which is essentially unusable right now. Additionally, they have increased the funding post secondary institutions received to address deferred maintenance from \$101m to \$154m. It is great to see the government addressing needed maintenance before building new infrastructure.

Myer Horowitz Theatre Renovations Update

This week finally saw me returning to the Myer Horowitz Theatre project. We held a design meeting, where the next steps into design development were discussed as well as options to vent a commercial kitchen in the lower level. Later that same day, we hosted a "Friends of the Myer Horowitz Society" board meeting. We updated the board with the latest from the feasibility study as well as schematic design. On that note, we have officially completed 22 of the approx. 30 interviews of the study. Expect an interim report at the last council meeting. We then hosted a discussion with the board on the topic of programming for the future theatre. We received a ton of valuable advice, including how to manage long term clients, as well as how the SU could possibly curate content. This last week, I also began the search for a consultant to complete a market analysis of the Edmonton theatre market. I have reached out to other renovation boards to see if any work has already been completed, for cost saving. After I hear back, I intend to reach out to experts in the community to advise on someone to complete this analysis.

Mental Health

Advisory Panel on Post-Secondary Mental Health

After the Province announced the budget related to Post Secondary Institutions, we learned that funding levels dedicated to Mental Health remained the same as the last funding round at \$3.6M. Details were not provided as to how that amount will be distributed at that time. However, as most of you already know, the recommendations that the Advisory Panel came up with were presented to cabinet and further detail on allocation may be based on some of the panel's recommendations. I am currently not a liberty to share the report with the public but I

would be more than happy to answer questions about the recommendations and the broad strokes of the report! (President Rahman and I talked about this on the Voice of the Union Podcast too so check it out!)

Mental Health Website

I have seen a first draft of the website and am very happy with how simple and responsive it is. We are currently working on the layout as well as the functionality of the website on different electronic devices. I will also reach out to Student Accessibility Services to inquire about the most accessible layout and aspects of that website (font, colours, even wording). One thing that I am very excited about is that the website will be available in French and English!

Residence

Residence Life Task Force

The recommendations and final report were sent to the President and the Provost. We are now waiting to hear back from them as they are likely to request a presentation on the report in the near future.

Lister Representatives

The LHSA president elections happened on Friday, March 10th. The VP elections happened on March 22nd and 23rd (Don't have the results at the time that I'm typing this report so stay tuned!)

Student Groups

A representative from the Dean of Student' Office is coming to a meeting of the Council of Residence Associations to consult residence associations on the new Student Group Policy as amended after consultations with different community partners such as the SU, the GSA, etc.

PROGRAMMING

SUB House Party

There are eleven student groups participating in the SUB House Party this year. The schedule is almost finalized so stay tuned! I am seeing changes in groups as some of them are asking to be added to the event and some of them don't have the capacity to participate anymore. The number of participating groups is still 11!

COMMITTEES AND BOARDS

Council of Residence Associations (CORA)

Our next CORA meeting is taking place on Friday the 24th. As mentioned, one of the items that we are going to discuss is the student group policy.

Health and Dental Plan Committee

The Health and Dental Plan Committee met to discuss the rise in health and dental claims. As you can see in the attached order paper, StudentCare are coming to do a presentation on why the committee chose to go with a 10% overall fee increase in conjunction with a 10% subsidy from the reserve fund, the reduction of the dental spending cap from \$750 to \$650 as well as a "rebalancing" of the health vs. dental fees (Refer to presentation and questions for more details).

The Landing Board of Directors

I am holding "office hours at the Landing" on Wednesday, March 29th from 1pm to 2pm so come check out the space and hang out if you're free!

UPASS Advisory Committee

The City's advisory committee on the UPASS met on Tuesday, March 21st to discuss signing contracts, discussing gaps in service and talking about the Smatfare.

 - g. Shall work with the Executive Committee of the Students' Union in implementing the Truth and Reconciliation Commission's Calls to Action, the Truth and Reconciliation Commission Political Policy and representing and consulting Aboriginal students.
 - h. Shall facilitate cultural sensitivity training for Students' Council, if necessary.
 - i. Shall compile a report on the representation and consultation of Aboriginal students as well as relevant advocacy work done by Students' Council, including the Executive Committee.

- j. Shall establish the framework for a Standing Committee that, in addition to the above mandate, will make recommendations on the following, by September 1, 2017:
 - i. Committee Membership: voting and non-voting;
 - ii. Addition of an Elder(s) and Oskapew to this Committee;
 - iii. Compilation of all relevant work done by Students' Council directly affecting Aboriginal students over the past 10 years;
 - iv. Requirement for Committee members to be trained in Aboriginal cultural sensitivity and inclusivity.
- k. Shall expire when the above Standing Committee is established by Students' Council.

2. Membership of this committee will be nine (9).

- a. Five (5) members of Students' Council;
- b. Two (2) members of the Executive Committee, as appointed by the Executive Committee;
- c. Two (2) executive members of the Aboriginal Student Council as voting members.
