Can you please explain any research or information you have on why the alternative forms of committees are not suitable and/or will not allow the Aboriginal Relations and Reconciliation Committee to be just as effective if not more so than a Standing Committee?

Councillor SUNDAY to Councillor PALINDAT:

Thank you for the question. Here is the answer to your question:

Thank you for your question. In regards to alternative forms of committees, the Aboriginal Relations and Reconciliation ad hoc committee has not looked at other committee forms, as our mandate (which was approved last year) specifies creating

the framework for a Standing Committee. However, personally it is my firm belief, as to others as well, that a Standing Committee is the only option when talking about reconciliation. A Standing Committee is a permanent committee of Council, which is written into Bylaw and remains a fixture of Students' Council. Reconciliation requires compromise on both sides, Aboriginal and non-Aboriginal; it is a relationship which aspires to create better communication and relations between these two groups of people. If Students' Council truly believes in the spirit of reconciliation, and does not wish to just pay lip service to it, Council will have to change. One way to demonstrate Council's devotion to reconciliation is to create such a committee, with the full status of a Standing Committee, that can be written into bylaw and remain a part of Students' Council. If ARRC was to stay an ad hoc committee or become a task force, it would lose the legitimacy that a Standing Committee holds and would reduce the amount it would be able to do by restricting its power. Council has stated numerous times that reconciliation is important to the Students' Union, whether that be having the Acknowledgement of Traditional Territories said at every meeting or having the Executive attend the MOU signing. By reducing ARRC to anything less than a Standing Committee demoralizes the notion of reconciliation and reduces it to fit the status quo of Council. Moreover, Aboriginal students have already been told that a Standing Committee would be created last year, during both last year's round of consultation and as a result of the approval of last year's General Order. The question of whether or not ARRC should be made into a Standing Committee is not just a matter of logistics and practicality, but a matter of trust. If Council wishes to go back on its word and renege on its promise of creating a Standing Committee, this broken promise will fracture the already tempestuous relationship between Aboriginal students and Students' Council. I know that for myself, the Native Studies Students' Association, and Aboriginal Student Council, anything other than a Standing Committee, regardless of other committee forms, will result in a cease of communications with Students' Council. Aboriginal Peoples have historically been treated by non-Aboriginal government and representative groups in unfair and surreptitious ways, and by choosing any other committee type, Students' Council will continue to perpetuate this relationship and increase Aboriginal students' distrust of the Students' Union. Although I am not against discussions of alternative committee types, such discussions should happen at a committee level. Should you wish to bring forward alternative committee types, I suggest that you research and ask for your findings to be included at the next Aboriginal Relations and Reconciliation ad hoc committee.

To the Executive and Counsellors of the Students' Union at the University of Alberta:

The Board of Directors¹ and staff of the Alberta Public Interest Research Group (APIRG) were disturbed to learn that a discussion on creating Aboriginal representation on the Aboriginal Relations and Reconciliation Committee (ARRC) has shifted. Rather than determining how best to give marginalized students a seat at the table, the SU is discussing hypothetical questions of "practice, precedent, and custom." This shift diminishes the focus on solutions which will center and amplify the experiences and voices of marginalized students; this shift is an egregious affront to the spirit of Reconciliation, inclusion, and diversity purported to be important to the SU. APIRG asks that the SU embody the ethic of "nothing about us without us." We believe that ensuring representation from affected communities on special committees related to their empowerment on campus will create a truly representational form of governance.

APIRG asks that the executives and counsellors of the Student Union, as representative of institutional power, do not continue believing that they can act in the best interests of students for whom the University can be a hostile and exclusionary place, without the direct participation of students affected by discrimination. In holding this belief and making "slippery slope" arguments, the SU exhibits paternalism--a belief that "those in power have the capacity to make decisions for and in the interest of those without power."² Throughout Canadian history, the paternalism of the state towards marginalized people--and especially Aboriginal peoples--has resulted in harmful legislation and practices such as the Indian Act and residential schools. We ask that the SU be mindful of this violent legacy and act in the spirit of Reconciliation.

APIRG has continually witnessed that people affected by oppression are the experts in how to progress forward towards a more equitable and just University. This is why we support grassroots solutions, rather than power-hoarding, top-down approaches.

Colonization is not hypothetical. Racism is not hypothetical. Broken treaties are not hypothetical. Therefore, APIRG asks that the SU does not hide behind hypothetical discussions. We ask that Executives and counsellors make good on their campaign promises to marginalized students and make the choice to not speak for marginalized students, but rather, pass the mic.

INTRODUCTION

The Discover Governance office in conjunction with the Council Administration Committee Chair produced an Entrance Survey for the 2017/2018 Students' Council members. Surveys such as this provide invaluable information on the types of improvements this office can make to support the Students' Council. The aim is to create an Entrance and Exit survey that will be consistent from year to year resulting in trends, which can be easily tracked. Feedback has been gathered from 10 out of 32 Students' Council members and the data derived from this is meant to serve as a foundation for future development and input into the Students' Council. However, it is to be noted that the data extrapolated only represents about 30% of council and results are un-proportionately skewed. These surveys are designed on Google Forms and are anonymously answered.

Survey circulated: 5 July 2017 to 28 July 2017

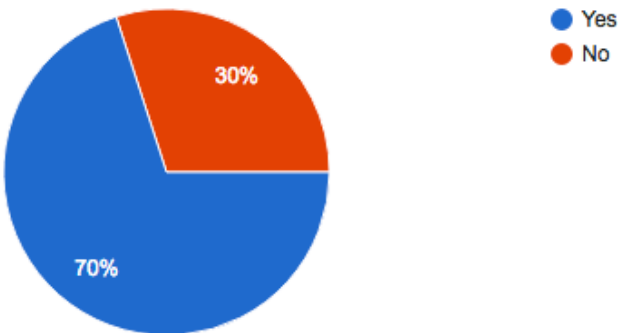
Do you have any constructive criticism for the speaker?

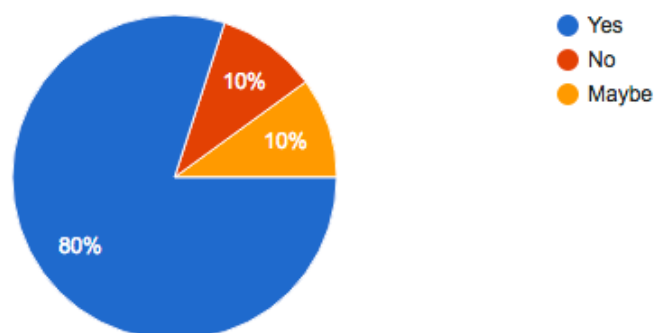
Do you feel comfortable speaking on council? Why or why not?

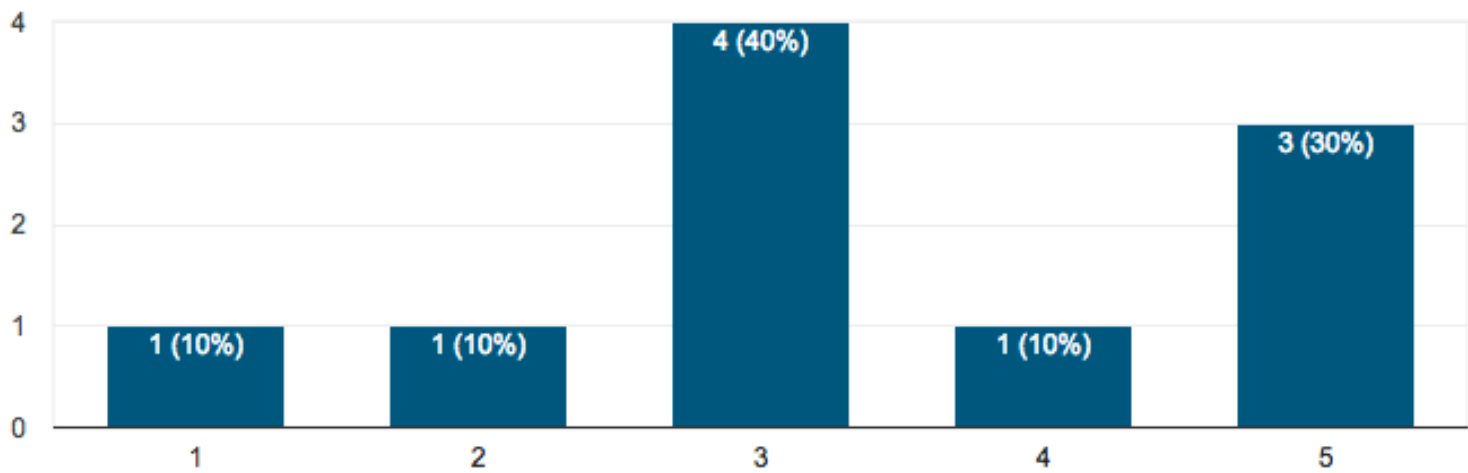
Do you plan on staying in contact with your Faculty Association throughout the year?



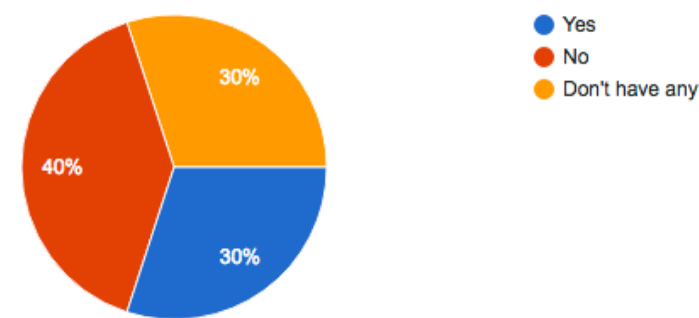

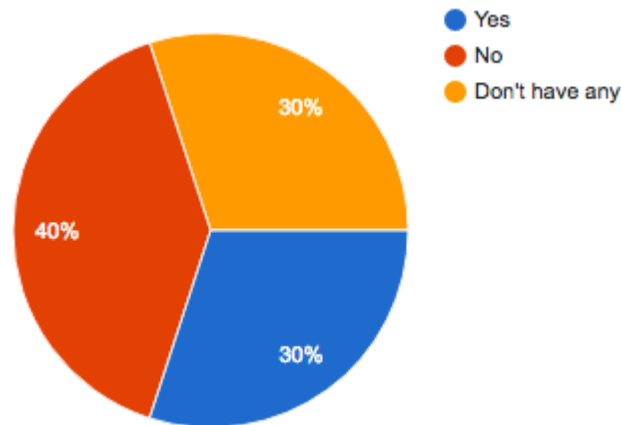
How much do you know about your Faculty Association? On a scale of 1 to 5. (1=Nothing, 5=A Lot)



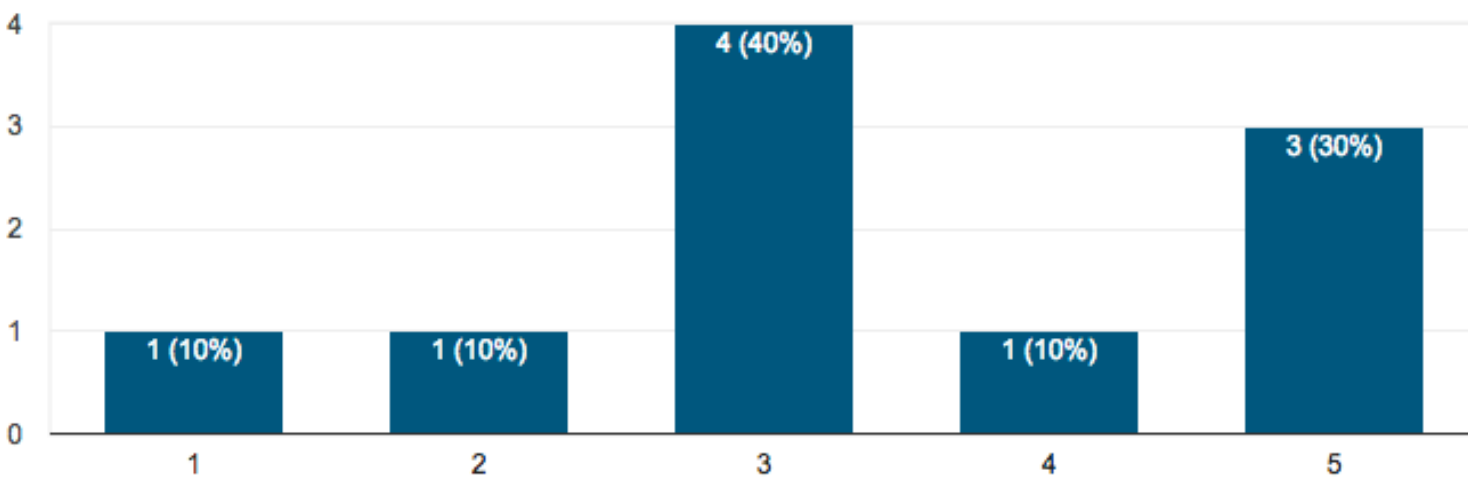
Have you met or been in contact with any of your Department Association(s)?



Do you plan on staying in contact with your Department Association(s) throughout the year?

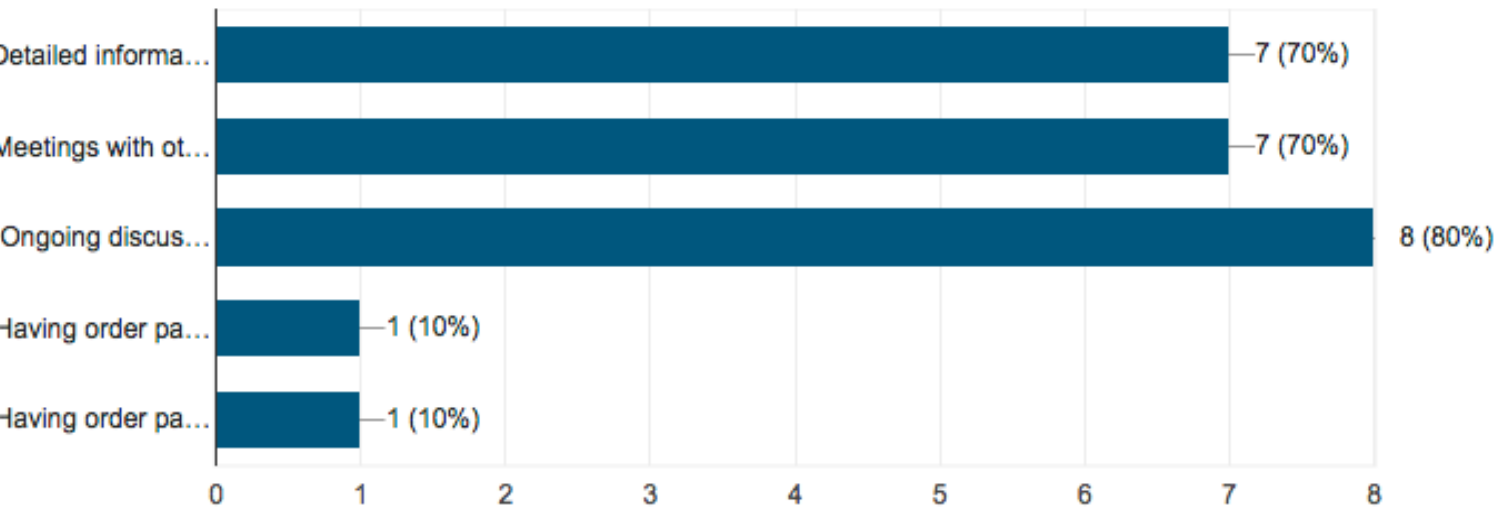


How much do you know about the Students' Union? On a scale of 1 to 5. (1=Nothing, 5=A Lot)



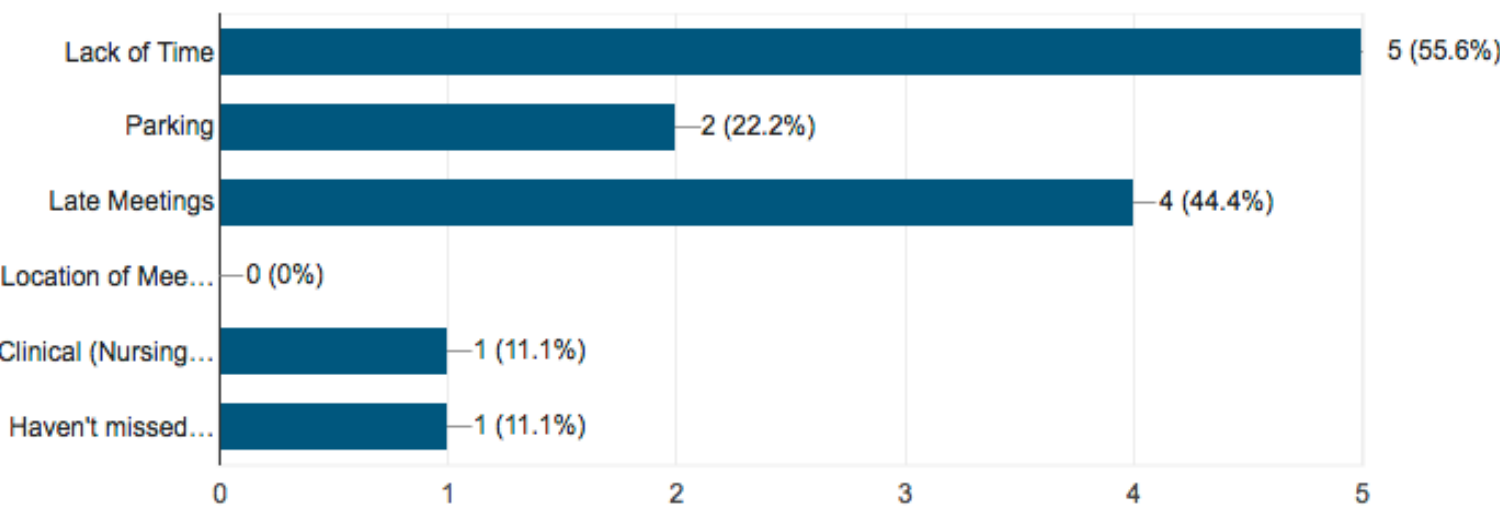
What can be done better to prepare you for Students' Council meetings?

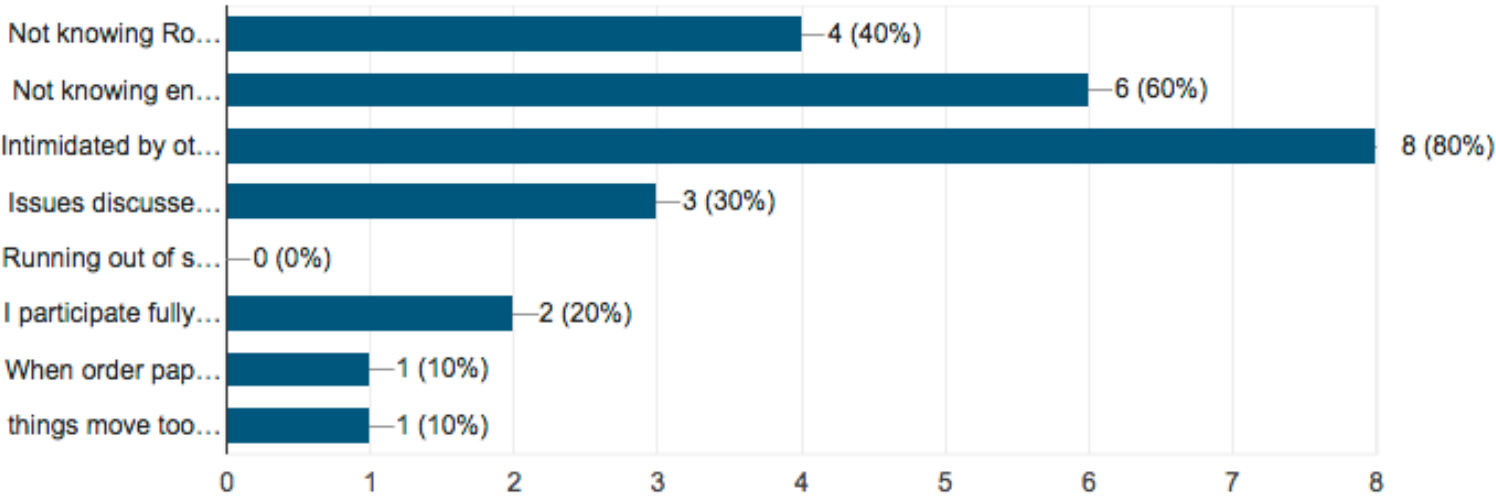
What is your biggest barrier to attending Students' Council meetings?

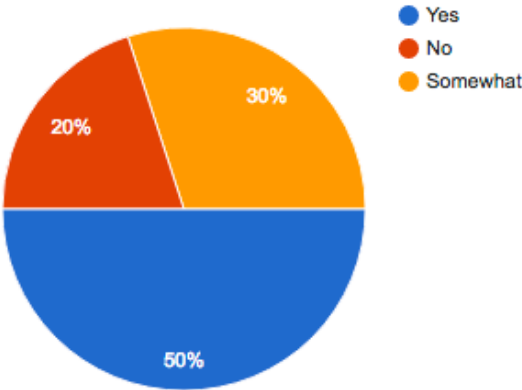


What is your biggest barrier to participating in Students' Council meetings?

In accordance with Bylaw 100, Section 16(1) and Section 8(4) of the Council Administration Committee Standing Orders, the following report has been submitted to the University of Alberta Students' Union. This report has been disseminated to fulfil Bylaw 100, Section 16(1) and Section 8(4) of the Council Administration Committee's Standing Orders.

The Council Administration Committee has met a total of 10 times (including an additionally scheduled meeting on August 15 and today's meeting on August 22, 2017) since the beginning of the new Council term. Non-permanent member attendance has been lackluster, a stable trend which seems to occur throughout the years. However, Councillors Flaman, Christensen, and Thibaudeau should be noted as positively contributing to the workings of the Council Administration Committee and for maintaining a steady presence at its meetings.

Many items have been brought forward and discussed at committee meetings. I am sending this report to inform Students' Council of the work the Aboriginal Relations and Reconciliation Ad Hoc Committee has done since its first meeting on May 17, 2017. As well, this report will provide supplemental information for the presentation (item 2a) which will be presented to Council.

Thus far, each member of the Aboriginal Relations and Reconciliation Ad Hoc Committee has worked tirelessly on ensuring the successful completion of our mandate. I applaud those members who actively participate in the workings of ARRC. Generally, meetings of ARRC occur on-Council Wednesdays at 6:00pm and frequently run over the three hour mark. In addition to this, additional meetings of ARRC have occurred and will likely occur into the future.

Before the report is underway, I would like to extend an invitation to all councilors to attend a meeting of ARRC. Meetings of ARRC are always open to the public and we would love to have the input of Councillors on what they would like to see ARRC become. Moreover, to those of you who may not know what ARRC is, or how it came to be, I ask that you either join us at a meeting or e-mail me. I will be happy to answer any questions in regards to ARRC.

1) Activities of the Council Administration Committee

Council has seen, the process to approving our first draft of the Standing Orders has been a slow process. Currently, we have approved the majority of sections within the Standing Orders and will likely have a completed draft within the next few meetings. Since tabling General Order 8a last Council meeting, ARRC has elected to stall work on the Standing Orders until this motion is resolved. The consensus of the committee was that it was preferential to hold off work until the motion passes or fails, so that our work would not have to be done if the outcome of the motion is unfavourable.

Aboriginal Student Group Consultations/Discussions

Although no Aboriginal student group, besides the Aboriginal Student Council and the Native Studies Students' Association, have been contacted, we have made an extensive consultation list. Once we approve our first draft of Standing Orders and recommendations, we will begin discussion with both individuals and relevant groups.

Petition to the University of Alberta Students' Union

In order to shed light on how undergraduate students feel about voting Aboriginal students-at-large positions on a potential Standing Committee, I created a petition. This petition was created to see how many undergraduate students agreed with allowing Aboriginal students-at-large position the ability to vote on the proposed Aboriginal Relations and Reconciliation Committee. This petition, along with a short preamble, can be found at the bottom of this report. The original format of the petition is a Google Form, which I will send out to all of you to view the official results. For the purposes of this report, the information house within the petition has been imputed into a table. For those of you who wish to discuss the petition further, it will be discussed at the next Aboriginal Relations and Reconciliation Ad Hoc Committee meeting on August 22.
