Dear Council,

The Executive and I have just been settling into the offices as best as we can. It is a high conference season, so we've been very in and out of the offices a fair bit. The summer weather is fantastic though, and it's been an amazing few weeks! The VP's never fail to impress me, and I couldn't be prouder.

### **1. Executive Committee**

- 2019/20 Executive Goals Document
  - We are in the process of working on our goals document for the year. This is where we take our individual platforms we ran on, and consolidate them into one. This is the **sole** document that will guide our year as an Executive team. We will be bringing it to you all soon for some feedback and insight.

### **2. Internal University**

- **Board of Governors**
  - We had our first board meeting, and it went well! We approved the President Search Committee Terms of Reference, and had extensive conversations regarding the impact of the elections on the post-secondary sector, and ways in which the University should begin to explore the relationship of student satisfaction and administrative costs.
- **General Faculties Council (GFC)**
  - At the GFC Academic Planning Committee (APC) we spent a lot of time discussing the impacts of the recent election as well, touched on free speech, approved the Comprehensive Institutional Plan (CIP) which included major wins regarding the ARRC recommendations. We estimate the Campus Alberta Funding letter will not come until late October.
  - Lastly at APC, we had a long discussion regarding the new tuition model for International students which will switch over from a course-based model to a program-based model. This is an extremely large change, and details have yet to be approved by the Board, but overall, this model provides and complies with the new legislation regarding tuition predictability.

### **3. External Advocacy**

- **Canadian Alliance of Student Associations (CASA)**
  - CASA is our federal advocacy group. More information can be found [here](#).
  - VP Brown and I will away again from May 24th to June 3rd for the CASA Foundations Conference!

- **Council of University of Alberta Students (CAUS)**
  - We just returned from our Changeover Conference in Canmore. It was a really productive weekend, and our student leaders in this province are incredible.
  - We elected a new Chair (Sadiya Nazir, UCSU) / Vice Chair (Bailey Harrey, ULSU) We also decided our Provincial priorities for the year, which is super exciting! These include sexual violence, student financial aid, work-integrated learning, mental health, and institutional funding.
    - The institutional funding point will include an ask regarding open educational resources [OERs], which is an issue I have been so passionate about and advocated for years! The exact ask and wording is going to be worked out, but we did it folks! Platform point: ✓

#### 4. Internal Students' Union

- As part of my goals, I wanted the UASU to look at integrating a more equitable environment. In light, the entire UASU staff is going to participating in a mandatory blanket exercise over the summer. I am excited for our staff to interact and learn through this experience.
- Furthermore, we have hired a First Nations, Metis & Inuit Coordinator, Megan Arcand, and we extremely honored to have her as part of our organization - a congratulations are in order! Her role is housed under the newly *re-named* UASU L.E.A.D (Leadership Education and Development) Centre, with a soft reporting structure to the President's portfolio because their role will touch on advocacy.

Dear Council,

It's been two weeks already and I am learning more and more each day about the role, and the incredible opportunity to make positive changes towards a healthy academic environment on campus. My office is feeling like home, and I welcome you to all come say hi - it smells really nice in here and there is still candy! Here are some things I have been doing over the past two weeks.

### **1. Open Education Advocacy Committee**

I have met with the OER Project Manager, Krysta McNutt to discuss preliminary direction set up of the **open education advocacy committee**, of which I intend to chair. This committee is comprised of faculty, staff and students with the intent of increasing awareness around the importance of OERs. I am in the process of setting up meetings with all Faculty Associations over the next few months. This will be a great opportunity to meet and better understand issues that individual faculties are facing at the UofA. Dear Council,

It has been a wild couple of weeks, but I am very glad to be home for the next week-ish. Much has already been accomplished in getting our external work off on the right foot, and there is still much to come!

**1. International student article:** I was interviewed by [Global News](#) and BBC Canada on the topic of international student work and barriers in Canada as Chair of CASA. This followed a student in eastern Canada who is facing potential deportation for working over the 20-hour limit that international students are allotted during the school year. It is crucial that the federal government consider the [Canadian Alliance of Student Association's asks](#) to remove barriers to work, work-integrated learning, and citizenship for international students.

**2. House of Commons Committee presentation:** As I mentioned in my last report, I was invited by the HoC Standing Committee on Finance to [present on the federal budget](#) and how it [benefits students](#). The presentation went quite well, and I was able to highlight measures such as the lowering of interest rates, the creation of more work-integrated learning placements, and the adding of more graduate and doctoral positions. I was asked by a Conservative MP if we wanted to see interest eliminated from student loans and if this budget went far enough in doing so, to which I responded that we would absolutely like to see it eliminated and that hopefully this budget puts us on track to get there. I was also able to attend Question Period thanks to a friend of mine that works in Parliament.

I will also be featured in a new podcast that AUSU is putting together to discuss CASA and its value to students. Stay tuned!

Dear Council,

So I'm a couple of weeks into the role now and things are moving along well. Just going through various carryover projects and starting work, so there aren't too many exciting items to inform you of today. I did get the opportunity to see some of you at RATT on the patio, which was a lot of fun!

Also, I have heard from a number of you that you are interested in SERC, so I have started looking into what bringing that back may entail. I likely won't have much on this point until mid to late June as I'll be leaving until May 28, but I wanted to give those of you who were interested in the sustainability initiatives of the SU an opportunity to learn a bit more about what your SU does to be environmentally friendly in our operations. To this end, I have attached a short report that reviews what initiatives the SU has taken to be environmental and have added a motion for a discussion period to review the Students' Union's Sustainability.

### **The Executive Compensation Package**

By this time the Executive Compensation Package will have already been brought to Finance Committee and, assuming it went through there, you will likely notice it on the agenda for this council meeting. This proposal was put together last year by an ad-hoc committee, and therefore, I have not personally done the work on this. Instead, I am working to finalize steps so that Council can implement it.

### **Planning Out The Year With Marketing**

I met with our Marketing department last this week to discuss my portfolio goals for the year and set priorities for which ones will be worked on in what order. Our Marketing department works exceptionally hard and is swamped with work between all our services and business as well as the execs goals, but the SU has added some new mechanisms to streamline the planning and make the process easier from them. Additionally, last year Council had passed a new budget which saw them get a little more money to strengthen their capacity. That said, after the meeting, it looks like we should be able to get through all the goals, and I am looking forward to bring them to Council as they are developing over the next year.

### **Committee Meetings of Note**

#### **Bylaw and Finance**

The first meeting of Bylaw and Finance committees under the new chairs took place this week. Both of the sessions were mostly looking at preparatory work for the year with the Finance Committee also having to look over last year's executive compensation page proposal.

Tuition Budget Advisory Committee (TBAC)

TBAC met for the first time in my term. In this meeting, we reviewed the suggested changes the university was looking to make tuition to meet the government mandate from last year. The current format the university seems to be considering would see domestic student tuition cost be adjusted the same as they have been in the past (curved with CPI) but will see reasonably significant changes in international student tuition cost format. International students have had to pay on a per class bases in the past (just like domestic students) and often have a hard time predicting what the cost for these classes may be throughout the term. The new format provides international students with a price for the program of their choice with a guaranty that it will not change for a length of time which is the standard program length plus one year (so four years for a BA plus one for example). On the whole, the new process seems to be better for international students as they can have predictable costs for going to school here.

U-Pass Administrative

This committee meeting wasn't particularly eventful as we primarily discussed current U-Pass distribution and usage rates and noted any student considers that had recently occurred on an individual basis. There was some discussion around the eventual implementation of Smart Fare on ETS systems in the future, but more deliberation will happen in the next meeting on that point.

United Way

This meeting was looking over the last years United Way campaign on campus and how to improve this year's campaign.

Centre LRT Working Committee

This meeting was interesting as we revied multiple proposed LRT lines alongside other stakeholders from around the university area to make suggestions for how the city should proceed with building its new LRT line. There were six drafts presented to us, and we had some discussion around the pros and cons of each. In the next meeting, we should receive new selections which reflect some of these recommendations.

**Upcoming Conference With Student Care**

Vice President Larsen and I will be leaving for the Student Care Conference on the 22nd of this month, and I look forward to learning more about the health and dental plan there.
