Policy Review

1 Facts

Facts

- 1. Students come to the University of Alberta for a high-quality education. The fees associated with this education, however, can overwhelm students. These costs include, but are not limited to: tuition, textbooks, mandatory non-instructional fees, rent and utilities, groceries and other costs that come with being a student.
- 2. The University of Alberta Students' Union is leading in research into student poverty. Much is still unknown about this population and needs to be further researched.
- 3. According to the 2018 Undergraduate Survey Report, the most common homelessness-related indicators are: being evicted or forced to leave their residence, couch-surfing or staying with friends without paying formal rent, and sleeping on campus because they had nowhere else to go. These relatively commonplace behaviours are linked with greatly increased risks of food insecurity. 12
- 4. There is growing evidence that students who find themselves in transient situations are sometimes forced to resort to survival-sex activities such as sex work, sharing explicit images of themselves for money, or selling used undergarments simply to pay for their education.
 - 4.1. In 2018, the University of Alberta had the 6th highest sugar baby rate out of all universities in Canada with the majority of their income going to educational costs. 3
- 5. Many students have self-reported living in transient situations including living in their car, abandoned buildings, and sleeping on campus.
 - 5.1. Students who identify as LGBTQ2S+ are at a higher risk for these situations. 1

- 6. Students who identify as LGBTQ2S+ are three times more likely to be evicted or forced to leave their residence, and significantly more likely to couch-surf, identify as homeless, and sleep on campus because they have nowhere else to go. 2
 - 6.1. Students who listed their gender as 'non-binary or other,' meanwhile, experienced significantly higher rates of all homelessness indicators.
- 7. FNMI students face a significant risk of being evicted or forced from their residence. This is consistent with the ARRC Recommendations, which note that culturally-sensitive housing opportunities are a priority for FNMI students. It is also concerning in light of the high proportion of FNMI students with dependent children. 2
- 8. Students who experience potential homelessness indicators are far more likely to skip meals frequently due to the cost of food. 2
- 9. According to the 2018 Undergraduate Survey Report, 24% of students skip meals once or twice per week due to the cost of food. Another 7% do so more than twice per week. Risk factors include:
 - i. Increased food insecurity between first and second year.
 - ii. Faculties at special risk include Arts, Business, Open Studies, and Native Studies.
 - iii. 12% of international students skip meals more than twice per week due to the cost of food, compared to 6% of domestic students.
 - iv. 9% of students who self-identify as visible minorities skip meals more than twice per week due to the cost of food, compared to 5% of other students.
 - v.16% of FNMI/Indigenous students skip meals once or twice per week due to the cost of food, compared to 11% of non-Indigenous students.
 - vi. 9% of students who self-identify as LGBTQ2S+ skip meals more than twice per week due to the cost of food, compared to 6% of other students.
 - vii. Students with dependent children face a mildly increased risk of food insecurity.

 viii. 17% of students with disabilities skip meals once or twice per week due to the cost of food, compared to 11% of other students.

- 10. A significant population of students indicated that they would not visit the Campus Food Bank even if they felt they needed it. $\underline{1}$
- 11. In the Perceived Career Value of a UAlberta Education survey, students had agree/disagree question on a 0-100 slider scale: "I feel like my experience at U of A is preparing me to find a good job. The average of all students was 58.5. 4
 - I. Students who skip meals more than twice a week due to the cost of food (average rating 48)
 - ii. Students who have at least one type of homelessness-related experience (average 42)
 - iii. Students who skip meals once or twice a week due to the cost of food (average 54)

2 Resolutions

NEW POLICY

- 1. The Students' Union will continue advocacy for lower costs associated with a university education, this includes: tuition, mandatory non-instructional fees and residence.
- 2. The Students' Union shall advocate that the University of Alberta conducts demographic research to gain a better understanding of student poverty on campus.
- 3. The Students' Union will advocate that the Dean of Students' Office effectively communicate the Safe House program to the campus community for those students in need of emergency access to safe housing.
- 4. The Students' Union will engage relevant community stakeholders to better understand the systemic barriers underlying student poverty.
 - i. The Students' Union will create an ongoing group of community stakeholders to understand these barriers
- 5. The Students' Union will work with the Campus Food Bank to address issues and stigmas students face when accessing the food bank.
- 6. The Students' Union will work with various organizations around the greater Edmonton area to further understand the student in poverty population including populations in homeless shelters, students who rely on survival sex.

The Students' Union believes that the Government of Alberta has the duty to fund the cost of a post-secondary education system that has the capacity for all eligible individuals to participate given the increased importance of an educated populace and the growing demands of an emerging knowledge economy.

Organization of Arts Students and Interdisciplinary Studies

Faculty Association Membership Fee Renewal Proposal - Revision



Proposal for the renewal of the Faculty Association Membership Fee (herein, the "FAMF") for the Organization for Arts Students and Interdisciplinary Studies (herein, OASIS) which serves as the faculty association for the University of Alberta Faculty of Arts (herein, the "Faculty of Arts").

Purpose: The membership fee is proposed based on the following grounds: OASIS was established in 2014 in order to act as a representative of students in the Faculty of Arts and to provide students with services and events to enhance their time spent in the Faculty of Arts. Over time, OASIS has evolved as an organization in order to better serve its constituents through events and services. Therefore, the FAMF will be used for three main purposes.

Firstly, OASIS offers grants to individuals, groups, and department associations. Granting provides deserving students with financial support for further learning opportunities. Currently, granting comprises a large portion of OASIS expenses. Previously, OASIS mandated that 50% of the FAMF would be allocated to grants. Moving forward, OASIS will maintain this mandate in order to increase the number of grants distributed.

Secondly, OASIS strives to support the Faculty of Arts community through events. These events include Arts Gala, Case Competition, and Arts Con. OASIS hosts events tailored to celebrate individual work and talent within the Faculty of Arts. As a result, OASIS utilizes the FAMF in order to maintain and improve events and support events hosted by department associations. Additionally, OASIS provides a significant subsidy for students on event ticket prices in order to facilitate increased accessibility of student involvement.

Thirdly, OASIS provides services in order to ease the burden of members of the Faculty of Arts. Although a relatively low cost in comparison to granting and events, services such as locker rentals require minimum funding in order to operate. This includes OASIS' capacity to advertise, as without advertisement the services would remain unknown to Arts students at large. Additionally, OASIS lacks the financial capacity to fully represent Arts students as the limited budget restrains OASIS' ability to advertise. Fundraising has been raised as a means of increasing the budget, but OASIS lacks the personnel in order to increase both events and fundraising. Fundraising would cause a significant drain on the operating capacity of OASIS.

Amount: The amount of the fee shall be changed from \$2.50 per student per semester for all Arts students to \$3.00 per student per semester for all Arts students starting in September 2020.

Timeline: The FAMF shall start in September 2020 and cease April 2022.

Scope: An Arts student shall be defined as anyone who is enrolled in the Faculty of Arts and is a member of OASIS as per the OASIS Constitution Article 3 Section 3.01. The FAMF shall apply to all undergraduate students, both full-time and part-time, in the Faculty of Arts. The fee has an option to opt-out, and refunds are made available to students. See "Refund Mechanism" for implementation of the OASIS opt-out practice.

Allocation: The money received from the FAMF shall be divided for usage based on several criteria ranked as the following:

- 1. Minimum 50% of FAMF funds will be allocated for the purpose of granting.
- 2. Hosting and supporting events in celebration of the Faculty of Arts and its students.
- 3. Providing services to Arts students to improve experience during undergraduate career.
- 4. The remainder will be placed in a savings account for usage at a later date.

Eligibility: As per article 3 section 3.01 of the OASIS constitution, all undergraduate students registered in the Faculty of Arts at the University of Alberta shall be automatically granted membership in OASIS. Through this, students will have access to services and events created by OASIS

Refund Mechanism: The FAMF, upon request, may be refunded for the semester the student is currently enrolled. The student must contact OASIS by email or in person in order to receive said refund. Proof of enrollment will be required in order to receive a refund. Once a refund is received, a receipt will be retained by OASIS to ensure proper accounting.

Management: OASIS finances and the FAMF are managed by the OASIS VP Finance. The VP Finance is responsible for proper stewardship of funds and must ensure that records are kept for transparency. The VP Finance is an elected position in which one must be elected by Arts students. Additionally, OASIS undergoes an audit every trimester.


Context

- Purpose: The FAMF allows OASIS to be in a better financial position to provide Arts students with important services such as granting and free printing, as well as events to celebrate Arts at the University of Alberta.

Refund Mechanism


- Students may request an individual refund of the Faculty Association Membership Fee either in person or via email

Revenue Breakdown (Estimates 2019-2020)












Allocation of \$27,000 FAMF









Diversity of Responses

Granting Process

- 1. OASIS puts together the Granting Committee
 - a. Composed of the VP Finance, a representative from OASIS Council (Director of Granting), and three representatives that each represent one of Social Sciences, Humanities, and Fine Arts.
 - b. Students at Large are given priority to fill the representative seats, and applications are merged with our Director applications. In the event that no Students at Large are forthcoming then the positions are filled by OASIS members.
- 2. Groups and individuals complete granting application forms by an advertised date
- 3. Granting committee reviews the applications
 - a. Department Associations are granted first to ensure that OASIS fulfills our fiduciary duty to Arts Organizations
 - b. The remaining money is allocated to individuals and student groups
 - c. If need be, the Granting committee can allocate money but not dispense the funds until the individual or group submits further documentation. If these conditional grants are given, the granting committee must reconvene to ensure the conditional documentation satisfies the committee.
- 4. All funds are dispensed to successful applicants

Representation of Arts Faculty

- Monthly meetings are held between OASIS executives and the Dean of Teaching and Learning

OASIS FAMF Renewal

OASIS is currently consulting students on their upcoming FAMF renewal.

What is OASIS

OASIS or also known as the Organization for Arts Students and Interdisciplinary Studies is the representative body of students for the Arts Faculty. Our job is to advocate on behalf of Arts Faculty students, support and hold accountable department associations and provide Arts students with events and services to improve their university experience.

What is the FAMF

The FAMF is the Faculty Association Membership Fees which is an opt-out fee paid for by every Arts Faculty undergraduate student in their student fees. Currently, students in the Faculty of Arts are paying \$2.50 per semester, with a total of \$5.00 for the full academic year. In comparison to other faculty association OASIS currently has the lowest FAMF. This amounts totals to \$27,000 and accounts for 85.4% of our revenue breakdown.

What you get from it!


As per the Students Union, "the purpose of the FAMF is to provide financial stability to faculty associations by giving the groups a regulated method of collecting a membership fee with an opt-out mechanism". The FAMF as mentioned prior allows OASIS to function. As per OASIS' previous FAMF consultation, OASIS promises to allocate 50% of its FAMF to granting. Furthermore, with the money received from the FAMF, OASIS is able to offer its services.

The OASIS budget below is the current breakdown of the OASIS spending, here you can see where OASIS money is allocated and what we are able to do at our current level of funding.


Currently, OASIS has the ability to negotiate the terms of the FAMF, this includes the total fee itself and the term period.

The survey gathered a response from 98 Arts undergraduate students.

Responses were received from every year of study, however first year and fifth year/above were lower than other years.

Feedback:

- Over 50% of responses were received from students who would describe themselves as being not involved in student governance.

b. Form Breakdown

The results of the survey indicate that students voted in favour of an increase of funds (whether to \$3.00 or more) and that most students are comfortable with a 2 year term.

Feedback:

- Regarding the comfortability of a general fee increase, more students were either committed to an increase or were on the fence compared to those who would not support an increase
- The form allowed for multiple indications of what a student thinks the fee should be, ²/₃ of the responses recommended increasing the fee
- Responses from the form suggest that a 2 year term is appropriate given that OASIS is still a young organization that needs to increase awareness
- It was raised that a potential fee increase might make students unhappy with paying more to an organization they are not aware of
- A counter argument was raised that an increase of funds would allow OASIS to improve and increase its marketing campaign
- OASIS would be able to solely increase the services it offers, as the cost of office supplies and other auxiliary costs are currently covered

2019-17/6 QUESTION PERIOD

BROWN: Inquired, to the chair of the Council Administration Committee, as to the nature of the Deputy Returning Officer (DRO) positions that the Students' Union is now hiring.

BEASLEY: Responded that there are two or three DROs that assist and report to the Chief Returning Officer (CRO) as part of the Elections Office team as well as provide neutral administrative and marketing support to candidates.

DRAPER: Inquired, to the Vice President Academic, as to the success of Student Leaders Week 2020 compared to its previous iterations as GovWeek.

AGARWAL: Responded that he has not yet reviewed comparative statics. Noted that Student Leaders Week has, so far, seen between 40 to 60 attendees. Clarified that GovWeek was rebranded as Student Leaders Week to be more inclusive given that governance is just one part of leadership.

BOSE: Inquired, to the President, as to whether she has more information surrounding the Alberta Government's plan to introduce a post-secondary performance based funding model.

BHATNAGAR: Outlined that the model provides that, beginning in 2020-2021, 15% of the University's funding (increasing to 40% by 2022-2023) from the Campus Alberta Grant will be based on its performance on key indicators. Expressed concern that the exact nature of the metrics is unclear. Outlined that the metrics will relate to the University's graduate employment rate, median graduate income, graduate skills and competencies, work-integrated learning opportunities, administrative expense ratio, sponsored research revenue, and enrolment (including potential targets for

domestic students, international students, and under-represented learners)

SUNDAY: Inquired as to whether the Executive is, as the Council of Alberta University Students, 'cautiously optimistic' about the changes.

BHATNAGAR: Responded in the affirmative. Noted, for example, that the new funding model may provide the University incentive to offer more student work experience opportunities. Expressed concern that some of the performance metrics are based on factors the University does not control, such as the economic strength of Alberta. Expressed concern that the new funding model may result in reductions to University funding.

AGARWAL: Inquired, to Councillor Draper, as to the status of the Open Resource Classroom Archive (ORCA) program.

DRAPER: Responded that the Faculty of Arts had made clear that they cannot alone fund the development of ORCA. Noted that the Faculty proposed that Draper solicit support across the University. Clarified that ORCA is an online platform whose aim is to provide students with course documentation detailing its structure, assessment methodology, and content.

SUNDAY: Inquired, to the President, as to whether there is a probationary period within the new Campus Alberta Grant funding model wherein institutions would be given extra time to meet their performance targets

BHATNAGAR: Responded in the negative.

VARGAS ALBA: Inquired, to the President, as to whether the Executive is concerned that the province's student representative bodies across Alberta are not united in their position on the Alberta Government's new funding model.

BHATNAGAR: Responded in the affirmative. Expressed concern that the Alberta Students' Executive Council has not cooperated with the Council of Alberta University Students.

DIXON: Inquired, to the President, as to how the UASU will advocate the province on its new funding model.

BHATNAGAR: Responded that the UASU will focus on ensuring that the calculations for the performance metrics work for the University, not against it.

SUNDAY: Inquired, to the President, as to the nature of the proposed three year investment management agreements.

BHATNAGAR: Responded that the Alberta Government will form three year investment management agreements will each post-secondary institution in the province instead of the current practice of announcing investment funding annually.

DRAPER: Inquired, to the President, as to whether he can receive a report detailing the results of Friday's Joint Board/GFC/Senate Summit focusing on the new budget model.

BHATNAGAR: Respond in the affirmative

BOSE: Inquired as to how the Alberta Government could assess its proposed graduate skills and competencies performance metric.

BHATNAGAR: Responded that the Government may survey employers. Considered that, if the University aims to improve its performance on this metric, it may begin to offer more practical courses focused on teaching job skills.

VARGAS ALBA: Inquired as to whether the University cut staff as a result of the 2019 Alberta budget.

BHATNAGAR: Responded in the negative. Clarified that the University did not need to lay-off staff because it found savings by reducing administrative spending and freezing hiring.

SAYED: Inquired, to the President, as to where else in Canada performed based funding is used for post-secondary institutions.

BHATNAGAR: Responded that this funding model is only used in Alberta and Ontario.

VARGAS ALBA: Inquired into how the performance model may impact how the University provides student services.

LEY: Responded that front-line services such as mental health support (identified as an administrative cost) may be removed if the University seeks to improve its administration to faculty ratio performance metric.


Context

Refund Mechanism


- Students may request an individual refund of the Faculty Association Membership Fee either in person or via email

Revenue Breakdown (Estimates 2019-2020)







Allocation of \$27,000 FAMF









Diversity of Responses

Granting Process

- 1. OASIS puts together the Granting Committee
 - a. Composed of the VP Finance, a representative from OASIS Council (Director of Granting), and three representatives that each represent one of Social Sciences, Humanities, and Fine Arts.
 - b. Students at Large are given priority to fill the representative seats, and applications are merged with our Director applications. In the event that no Students at Large are forthcoming then the positions are filled by OASIS members.
- 2. Groups and individuals complete granting application forms by an advertised date
- 3. Granting committee reviews the applications
 - a. Department Associations are granted first to ensure that OASIS fulfills our fiduciary duty to Arts Organizations
 - b. The remaining money is allocated to individuals and student groups
 - c. If need be, the Granting committee can allocate money but not dispense the funds until the individual or group submits further documentation. If these conditional grants are given, the granting committee must reconvene to ensure the conditional documentation satisfies the committee.
- 4. All funds are dispensed to successful applicants

Representation of Arts Faculty

- OASIS works closely with the Arts Faculty in order to better represent students
- Monthly meetings are held between OASIS executives and the Dean of Teaching and Learning
- Committees exist to ensure that student's voices are heard
