Dear Council,

It's been a busy two weeks! Check out my report for an outline of what the past two weeks have been like for me, but don't hesitate to ask me any questions if you want more information!

Updates to previous questions

- I did not receive any questions at the previous council meeting which require additional information.

UASU Nom Com

The UASU Nominating committee has set the deadline for the SCFC Committee, and EDIT for July 13th. We will be adjudicating the applications for the next council meeting. Currently we are in the process of organizing the interviews for the Senate applications.

Academic Restructuring Town Hall

Bill Flanagan hosted a town hall on the topic of Academic Restructuring on Wednesday. Around 2,000 individuals tuned into this Townhall and had the opportunity to ask questions surrounding the presentation and academic restructuring as a whole. One thing of note in this town hall was the use of the program ThoughtExchange. This program allowed viewers to ask questions and rank others' questions to create a list of "hot topics" that the majority of those who participated wanted answered. I found this experiment quite interesting as it helps cut down on the monopolization of question period by a small number of individuals, and actively allows questions from the majority to be answered. It will be interesting to see how the program plays out, as questions who do not have the majority support behind them are still important to ask and have answered.

Service Excellence Transformation Town hall

On wednesday the 15th there will be another town hall, this time focused on the Service Excellence Transformation (SET). SET is a program happening in tandem with Academic Restructuring focusing on internal services structures rather than Faculty structures. The aim of SET is to increase efficiency in services by increasing specialization and reducing generalization. I highly recommend attending this townhall to learn more and to ask questions surrounding the aim of the SET program and the means which the university will take in order to meet those aims.

Discipline Interpretation and Enforcement Board

I have been working alongside the other members of the D.I.E Board hiring committee in order to ensure that we have a full and functional D.I.E Board for the coming year. The D.I.E Board works as a judicial branch of the students union, enforcing our bylaws and providing answers to reference questions on issues relating to our bylaws. Due to their important role in our governance process it is important that the D.I.E board is filled and functioning. This is part of an ongoing goal of mine to ensure all levels of student governance are functioning at the highest level possible. This goal starts with the active work of ensuring that all levels of student governance are having positions filled in order to ensure the work is completed, as well as working to ensure that students are aware of the various opportunities for involvement which exist. This goal also involves critically examining the process in which seats are filled and why seats may be historically empty as well as looking at who historically fills



these seats. Due to that personal goal I am especially excited for EDIT as this is a project I would like to

pitch to them for help and consultation.

I have continued my project of meeting with all FA presidents, currently there are only two Faculty Associations which I have not met. These meetings are intended to continue throughout the term in order to facilitate an open and proactive dialogue with all 14 Faculty Associations. By ensuring that conversations happen in meetings, I feel as though it becomes more likely that the FAs will reach out to me when they have issues, as I become an individual rather than a nebulous position. I fundamentally believe in the power of 1-1 conversations to build connections and accomplish goals, and based on what has happened since my previous meetings, that belief is not unfounded.

Open Education Conference Diversity, Equity and Inclusion Team

- As many of you may know, I serve on the Diversity, Equity, and Inclusion Team of the 2020 Open Education Conference. I am absolutely honoured by this opportunity to work with so many people passionate about Open education and EDI. We met for the first time last week to discuss the Mission, Vision and Values of the conference as well as the committee. We are also in the process of drafting a set of "conversation principles" for other planning committees as well as ourselves in order to ensure that the planning as well as the conference itself is open and inclusive. These principles are meant to guide discussion tone, and language use to ensure that discussions are done in a respectful and professional manner and to reduce the possibility of alienation, or tokenization of people or opinions.

Personal life Update

- As many of you know, I have a passion for procedural governance at the provincial level as well as the history of the Alberta legislature. The point of convergence for these two passions of mine happens to exist within the office of the Speaker of the House as well as the office of the Sergeant at Arms. As someone who quite often watches and listens to the procedures of the legislature as well as studies the history and quirks of it (ask me about the hamburger in QP so i know people actually read this) I have had a small personal quest for the past year. This quest is to have my personal copy of Robert's Rules of Order signed by the individuals in the legislature who helped inspire my love of procedural politics. This has been a long term goal as it involves approaching a variety of people from across the province of Alberta in hopes of them being willing to sign it. Something that has been bringing me a lot of joy at work lately is that I have started using my whiteboard to make to-do lists for my major priorities and projects. Each item is colour-coded to indicate urgency, and overall it has been helping me a lot. So here's to organizational tools! My garden is still thriving: I used some of my basil in a recipe yesterday and it was so fragrant. I hope your hobbies are also bringing a smile to your face these days.

Services Update

UPass

We are putting a lot of effort into fighting for a good deal for students to have affordable transit in the Fall. We put forward a strong and comprehensive proposal to ETS for an opt-in UPass for the Fall, which they have turned down. We are currently (as of July 9th) drafting an alternate proposal that seeks to accomplish an equally good outcome as the last proposal. Despite our very best efforts, solutions are not quickly forthcoming, as ETS is being slow to bring forward solutions or to meet in the middle. We are investigating further advocacy efforts to try to arrive at a solution for students as quickly as possible, so that we can mobilize our staff to implement what needs to be.

As far as the Ride Transit Program for the Summer goes, I am aware that it presents some issues. It is cumbersome, and ETS has yet to update me on if the back-end administration systems are working to allow students to participate (though they guarantee that students can participate). These issues are only increasing our determination to find a feasible solution for the Fall semester. For the time being, I thank you for your patience, as we really are working hard to get the best possible outcome.

Projects Update

Free Menstrual Products Initiative

Vice President Kidd and I have had some interesting meetings about the free menstrual products initiative over the last two weeks. One of them, which I would like to highlight, was with Hempact. Hempact is a student-run startup (which has recently become incorporated), that was started through the Enactus club at the University of Alberta. They are developing a biodegradable sanitary pad made from hemp fibres that would otherwise become waste. As part of our long-term strategy for the free menstrual products initiative, we plan to work with them to



Hello Council,

For the last two weeks I have been trying to keep the two Boston ferns I recently bought alive, without great success. Despite following all the instructions, they are continuing to slowly wilt. If anyone has a particularly strong green thumb knows how I can save my plants, please let me know! They cheer up my work space a lot so I would hate to see them go. Aside from that, this has been probably the busiest week of my job so far. However, it has also been a change to work on some really important issues, and we have made a lot of progress-- so I consider it a great couple weeks nonetheless.

Maintenance Grant Amalgamation

As many of you will remember, the Alberta government recently amalgamated the Maintenance Grant, which served the unique needs of students with dependents who had exhausted all other financial aid, into a new grant which is not available for students in four year degree programs and does not serve the unique needs of students with dependents. In order to start a conversation about this and encourage the government to reallocate funding to the maintenance grant, I have spoken with CBC Edmonton, The Gateway, the Edmonton Journal, and Global News. I have also encouraged CAUS members to reach out to local media outlets near them.

As a next step, I have written an open letter which we will send to the Minister's office requesting the restoration of the maintenance grant or the creation of a suitable alternative. I will be trying to get co-signatures from the leaders of other provincial student groups, and sending it early next week.

Federal Francophone Education Policy

Continuing our ongoing advocacy for long-term stability at Campus Saint-Jean, I met with the Policy Director and Policy Development lead for the Canadian Alliance of

Student Associations, our federal partner, to discuss creating a francophone education policy. They were enthusiastic about the idea and expressed a desire to see it go forward this year, with the first lobbying with it likely to occur in Fall 2021. To help move things along, our Students' Union will be providing a briefing note explaining the relevant federal policies and how they are impacting Campus Saint-Jean.

Fall CAUS Campaign

We have been collaborating with CAUS's government relations firm, Alberta Counsel, to create draft messaging and digital strategy for a low-cost fall on campaign social media against post-secondary cuts. Our message will focus on the importance of student success and strong universities to Alberta's economic future, and will try to reach beyond the core PSE audience of students and staff into more peripheral PSE stakeholders like parents and businesses. The timing of this campaign, right before the Alberta 2030 review's initial report and during early budget deliberations, is intended for maximum influence on the budget and the review process.

Abstract

Policy Committee is renewing the Academic Materials Policy set to expire in April 2021. Amendments include additions/refinements to various parts of the facts and resolutions, inclusion of citations, and emphasis on the importance of online educational barriers and support in light of Covid-19 and online education going forward. Summary of changes can be found in the chart at the end of the document. This policy is being brought forth to council for reading of Second Principles.

Political Policy Academic Materials (2nd Principles)

1 Facts

- 1. The true cost of being a student is composed of many factors, such as tuition, fees, cost of living, foregone wages, and academic materials.
- 2. The University of Alberta estimates that a student should expect to spend \$1750 on academic materials. These academic materials are course-specific and critical to passing a course.¹
- 3. Many students avoid or drop classes based on textbook costs, leading to different educational experiences.²
- 4. 10% of students have been forced to choose between textbooks and food/monthly necessities.³
- 5. The rate of textbook cost increases have exceeded the rate of inflation over the last decade.4
- 6. Quality of education and cost of textbooks have no direct causal link.⁵
- 7. First-year students spend significantly more on textbooks, despite opting out of purchasing them as frequently as non first-year students.⁶
- 8. Publishers often introduce new and more expensive editions of textbooks in rapid succession without necessarily undertaking substantial content revision, which adversely affects the used textbook market, leading students to incur higher costs in affording academic materials.⁷
- 9. Students can recover part of the cost of their textbooks by selling them as used books, and students can usually acquire a textbook for a lower cost by buying used textbooks. There are also many opportunities to acquire academic materials at a discounted cost or for free.
- 10. Online textbooks that expire or are single access cannot be sold to recover the cost, or kept for reference after finishing the term.
- 11. Course instructors are the primary decision-makers in terms of setting academic materials for their courses.

- 12. The use of additional and online academic tools and platforms (such as learning management systems, online assignments, material aimed at enhancing self-evaluation by students), are increasingly being offered by publishers for a nominal cost and are becoming more widespread. Many students face technological barriers which inhibit access to such materials.8
- 13. The tools and platforms used to offer additional academic material to students often vary by publishers and are not standardized across courses and faculties, leading to additional expenses for students.
- 14. Many students do not have sufficient internet access to support common models of online instruction. Students who live in rural or remote communities are at a disproportionate risk.⁹
- 15. The use of mandatory access codes in courses impose a further financial burden on students already paying for instructional costs of post-secondary education.
- 16. The Government of Canada already has mechanisms in place for Goods and Services Tax (GST) exemptions.¹⁰
- 17. There are no provincial sales taxes levied on books for Canadian provinces that use a Harmonized Sales Tax (HST).¹¹
- 18. The Book Importation Regulations approved by the Governor General in Council in July 1999 allowed book importers to charge a premium of 10% on books imported from the United States and 15% on books from any other country.¹
- 19. Students may access copyrighted material for scholarship as has been codified.
- 20. Open Educational Resources (OER) are resources, such as textbooks, course materials, video clips, images, infographics, multimedia applications, or whole courses that have been designed for use in teaching and learning that are freely available and published with an open license which permits users to reuse, revise, remix, retain, and redistribute them (known as the "5Rs").

2 Resolutions

- The Students' Union will advocate for academic materials to be as affordable and accessible as possible.
- 2. The Students' Union will advocate that courses with online learning platforms and interactive academic materials should not impose costs already covered by tuition.

- 3. The Students' Union will advocate against students bearing the burden of extra costs that occur through importation, delivery or other tariffs, taxes, and fines associated with academic materials (regardless of any changes in PST, HST, or GST regulation).
- 4. The Students' Union will publicize and promote the various ways that students can save money on academic materials.
- 5. The Students' Union will raise awareness among educators and instructors of more affordable alternatives available to them.
- 6. The Students' Union will advocate to the University and the government to support the development and utilization of Open Educational Resources.
- 7. The Students' union will advocate for a cap on class expenses post tuition.
- 8. The Students' Union will advocate for online courses to be delivered in a way which minimizes technological barriers, such as low-bandwidth online teaching practices.
- 9. The Students' Union will advocate that materials required for online learning are affordable and respects students' privacy.
- 10. The Students' Union will provide options / infrastructure to aid in the sale of secondhand textbooks.
- 11. The Students' union will add information surrounding textbook affordability and textbook alternatives to the orientation package in order to educate incoming students of the additional costs they face.



New Policy: Student Financial Aid and Scholarships

1 Facts (Student Financial Aid)

- Post-secondary education is a public good due to the benefits it brings to the social structure and tax system.
- The cost of attaining a post-secondary education includes tuition, fees, the cost of educational materials, and living expenses.
- The cost of a university education as well as student debt continues to increase.
- The high costs associated with university education pose a barrier to accessing, and a disincentive to completing a university education.
- Students who do not receive financial assistance for their education may be required to take on large amounts of debt.
- 6. Some students require part or full time employment in order to finance their education.
- There is an opportunity cost for individuals who choose to pursue

Facts

- Post-Secondary education is not only a benefit to individual graduates, but is also a public good due to positive impacts on economic productivity and government revenue¹.
- 2. The University of Alberta, the Government of Alberta, and the Government of Canada have a responsibility to make post-secondary education accessible to qualified people of all backgrounds so that they may achieve their full potential.
- The cost of participating in post-secondary education includes tuition, fees, the cost of educational materials, and living expenses.
- 4. The cost of university education has increased rapidly in Canada in recent decades, with tuition alone rising over 270% in real terms since 1990. This has forced increasing numbers of students to take out large student loans that are burdensome later in life².
- The high cost of university education is both a disincentive to beginning a university education and an obstacle to completing one.

- an education rather than earnings from working.
- Students partaking in part or full time employment do not have the same opportunity for academic achievements as those who do not require employment to finance their education.
- The high cost associated with university education can be detrimental to academic and extracurricular student achievement.
- Need-based aid, merit based awards, and student loans are all integral parts of the student finance system.
- The current need-based aid and merit based awards application process is inefficient and time consuming.
- 12. Need-based aid is an integral part of the student finance system, without which students in financial need could not afford a university education.
- Merit based awards target students who are less likely to have dire need of financial aid.
- The University of Alberta should not only aim to attract talented

- Students lose significant potential income when they choose to pursue a university education instead of full-time work.
- Some students require either full or part-time employment while attending university to meet their financial needs, which can reduce their opportunities for academic achievement and extracurricular activity³.
- Both needs-based and merit-based awards, and both repayable and non-repayable aid, are integral parts of the student financial aid system.
- The current application process for student financial aid is inefficient and inaccessible⁴.
- Needs-based aid plays an essential role in allowing students from less privileged socioeconomic backgrounds to access university education.
- 11. Merit-based awards typically target students who have less financial need⁵ and as a result are not sufficient on their own to ensure the accessibility of post-secondary education.
- 12. Education tax credits are an inefficient and poorly targeted mechanism for distributing student financial aid⁶.
- Up-front, non-repayable, needs-based grants represent the most accessible and fair method of distributing student financial

7 Elections Staff Terms of Office

- 1. The Chief Returning Officer shall serve from May 1 to April 30 of the following year.
- 2. The Deputy Returning Officer(s) shall serve from December 1 to April 30 of the following year.

8 Duties of the Elections Staff

- 1. The duties of the C.R.O. shall include:
 - a. overseeing the implementation of the Elections Bylaw, which includes Bylaws 2100, 2200, 2250, 2300, 2400, and 2500.
 - b. such duties required of the C.R.O. under Bylaw 100 and 8100; and
 - c. being the highest responsible manager of the Elections Office and elections staff, particularly when interpreting, enforcing, and delegating authority afforded by the aforementioned Bylaws.
- 2. The duties of the Deputy Returning Officer(s) shall include:
 - a. such duties as may be required of the D.R.O.(s) under the Elections Bylaws, Bylaws 2100, 2200, 2250, 2300, 2400 and 2500.
 - b. such assistance as required by the Chief Returning Officer in the discharge of their duties, as set out in Section 8(1).
 - c. In the event the C.R.O. is incapacitated and can not complete the duties of the office, C.A.C. shall assign those duties to another member of the elections staff in the interim.
- 3. Duties of the elections staff to be found in Bylaw include but are not limited to;
 - a. conducting the balloting process; and
 - b. conducting the elections; and
 - c. the advertisement of elections; and
 - d. submitting to the Speaker, as soon as practically possible, a report containing the results of any election of members to Students' Council; and
 - e. determining the allocation of Councillors before the release of every nomination package and forthwith tabling Students' Council a report detailing the allocation of Councillors and the statistics used to reach that allocation; and

- f. determining the dates for all nomination deadlines, elections cycles, and voting days; and
- g. the validation and posting of all nomination packages, plebiscite and referendum petitions; and
- h. all relevant consultation and committee engagements; and
- i. duties as prescribed in Bylaw 8100 including the running of plebiscites;
 and
- j. with the assistance of Discover Governance the creation and dissemination of Vacancy Petitions.

27 Campaign Materials

- 1. The cost of all campaign materials shall be approved by the elections staff before being used in campaign activities. Candidates shall provide the elections staff with:
 - a. a written estimate of the cost of the proposed campaign material, including the source of that cost; and
 - b. the complete contents of the proposed campaign material.
- 2. The elections staff shall provide in confidence a written or electronic approval or refusal of campaign materials within eight (8) working hours of receiving a request as set out in Section 27(1).
- 3. Where a candidate contravenes Section 27 the offending campaign materials shall be destroyed and the C.R.O. may assess an additional penalty to that candidate, as set out in Section 41.

FOTANG to DRAPER: Asked if DRAPER could speak more on the Public Health

Response Team and any discussions coming out of this Committee.

DRAPER clarified the structure of these University of Alberta Teams and explained some discussions occurring regarding the Fall semester and COVID-19 considerations.

HARIHARAN to KRAHN: Inquired about what current discussions with ETS are regarding how students can apply to their programs.

KRAHN responded to clarify the current situation and the present program and process to ride transit from the ETS.

HARIHARAN to KRAHN: stated that an inquiry was made and the approval process was occurring on a difficult case-by-case basis.

KRAHN stated that there will be a commitment made to push for clarity and greater accountability from ETS.

BID to EINARSON: Inquired about whether staff were consulted to find the standing orders and if there does not seem to be any standing orders, what actions will be taken.

EINARSON responded by stating that more outreach will be done and that the Translation Committee's current goal will be to revitalize the goals of the Translation Committee.

FOTANG to KIDD: Inquired about who would be making up the EDI Task Force in addition to the SALs.

KIDD explained the breakdown of who would be on the EDI Task Force.

AGARWAL stated that if there are no Standing Orders existing for the Translation Committee they will have to be created under the scope of Bylaw 100.

FOTANG to KIDD: Asked for clarification on whether those who have been nominated to be on the Committee will be fixed members or not.

KIDD responded that they will be fixed for this year and that different voices will be considered depending on the perspective of the EDI Task Force and what it decides.

HARIHARAN to KRAHN: Asked for clarification on whether the PAW fee will be optional for students in the Fall semester.

KRAHN stated that the fee has not been optional in the past, barring specific cases, and therefore would not be currently considered.

KORDE to DRAPER: Inquired about the Student Life Group and what is currently

being considered by the group.

DRAPER briefly described the group and handed off the time to another Executive member who could respond.

KIDD provided clarity on the Student Life Group.

DE GRANO to KIDD: Inquired about whether there would be compensation for Focus Groups on the EDI Task Force.

KIDD responded stating that the current idea is that the Focus Groups will be compensated but exact amounts have not been decided.

BRANDWEIN agreed with VP DRAPER and expressed support for action accountability but worries about voting bias caused by silencing and censoring that sets an unhealthy precedent that leads people to vote contrary to their own views.

BUCHANAN referenced different language present in the Standing Orders in 17(3) in regard to confidential and secret ballots, stating that confusing language could be clarified. Stated that there could be greater accountability merit that is more beneficial than concerns of group thinking.

YABUT echoed the perspective of VP DRAPER and stated that there is an opportunity to further this discussion at an additional time.

BOSE stated the benefits of using the tools present, such as the Call for Division.

AGARWAL echoes the concerns of bias in voting due to controversial items if this motion were to be formalized.

KONRAD expressed that echoing EDI, particularly Inclusion, that this change may not allow for Council to be the most inclusive of spaces.
