Hello Council,

This report will be a little shorter than usual as I spent the week of the 9th-13th on vacation. It was great to disconnect (mostly) and enjoy some time in Quebec with my grandmother and parents!

### **Amarjeet Sohi Meeting**

On Monday, the executive team met with mayoral candidate and former Edmonton Mill Woods MP, Minister of Infrastructure, and Minister of Natural Resources Amarjeet Sohi. We have now met with about half of registered mayoral candidates in Edmonton, and we have had very engaging conversations about key municipal students advocacy issues, including:



- Affordable housing, which is one of Edmonton's main assets. We have emphasized the need to allow dense, student-friendly housing near transit and in the core. Secondary suites, more and denser apartments and mid-or-high rises, and transit-oriented development are all key parts of the solution.
- Safe and respectful law enforcement practices that ensure students feel safer on transit and campus
- Student employment and ways the city can facilitate it, including working through the business community
- How the university community and the city can collaborate to support Edmonton and U of A's interests with the provincial government

### **Improved COVID safety on campus**

This Tuesday, the University [overhauled the COVID safety plan for the Fall semester](#). We are very pleased to see this change-- we feel that it responds to the advocacy of the Students' Union in our [letter to Dr. Deena Hinshaw last week](#). We feel that the changes

are reasonable and allow us to return to campus and a more exciting campus life, while ensuring that students who are understandably still concerned about COVID feel safe. While we have received both positive and negative reactions from students, the overall reaction has been relief and support.

It is important to emphasize that the Students' Union does not support the restriction of campus life or preventing students from enjoying their year. If all goes as we hope, the next semester will look mostly normal with the exception of mandatory testing for unvaccinated students (with accommodations) and masking. While masks are inconvenient, I think we can all agree that they are a minor inconvenience and a small price to pay for making people feel safe in their community.

Lastly, I've received a lot of questions about what the University's exit plan from restrictions is. While no decisions have been made about the Winter semester, I see the Fall semester as a gradual transition towards normalcy in the Winter. If there is no outbreak on campus, and no unpleasant surprises in public health, I believe a return to normalcy in the Winter is appropriate. COVID cannot and will not last forever.

### **Announcement next Wednesday**

We will be making an exciting joint announcement about COVID safety on campus with the University next Wednesday. While previous COVID announcements have been grim but necessary work, I hope we will all find this one much more positive.

Lastly, I want to wish you all the best of luck as we return and gather on campus again. I know it has been a miserable year for many of us, and while we still have some way to go I hope we are turning the corner. I can't wait to see you all in person and share the experience that Students' Council should be, and get to know you all as more than a zoom square.

Dear Council,

Yet another two weeks have passed. As we get closer to the start of the semester, a lot is happening in the VPA world. Here is a breakdown of what I have been working on!

### **Zero Textbook Cost Indicator Program**

After three years of advocacy and two submissions to GFC, the Zero Textbook Cost (ZTC) Indicator program launched on Monday, August 16, 2021. This is an essential program to transparently inform students about the costs associated with their educational choices, increase accessibility to education, lower/remove the cost of course material, and recognize instructors' efforts in achieving cost reduction of their teaching materials. Instructors remove the cost of additional course material through open educational resources (OER), Library materials, or free and online content.

A form was sent out to all professors and explained what Zero Textbook Cost means, why they should participate, how to enroll in the program, and where to find resources to start teaching ZTC if they would like to. Since the program launch on Monday, in less than 24 hours, 185 instructors have signed up for the program! As of Wednesday morning, there are 270!!!

After years of VPA advocacy, I cannot stress enough how big of a win this is for students. This program could save students at the University of Alberta potentially millions of dollars this year alone! A University of Toronto ZTC pilot project across only 53 courses saved students almost half a million dollars and saved 1.7 million pages' worth of paper (around 9 tons). This is HUGE!!

While this program is only a pilot for the 2021/22 academic year, we need to continue to encourage professors in our faculties to sign up for the program. I encourage all of you to reach out to instructors you have had that didn't have additional course material costs associated with their courses and encourage them to sign up for the program if they haven't already. Instructors can find the form in their inbox or email Anna Vocione (Assistant Registrar Exams and Timetabling) at [anna.vocioni@ualberta.ca](mailto:anna.vocioni@ualberta.ca) if they want to sign up!

Stay tuned for more information on how this indicator works on Bear Tracks and how you can help to expand ZTC on campus!

Finally, I want to give a shoutout to my predecessors Akanksha Bhatnagar (VPA 18/19), Joel Agarwal (VPA 19/20), and David Draper (VPA 20/21) for all the work they put into getting this program to where it is now. <3

## **Mandatory Support Fee**

Many students have reached out to me about a new fee that they see on their fee breakdown in Bear Tracks called the “mandatory support fee.” I reached out to the Registrar’s Office about this fee because of the concern that it was not transparent at all, and students did not know where their money was going. I have cleared this up, and info on where to find the fee information is below.

“The label of Mandatory Support Fee represents a variety of approved non-regulated fees that generally apply at the course level. This is why there are different amounts because it is being driven specifically by student registration. Examples of these fees include field schools, field trips, mandatory supplies, etc. These fees are all approved through our normal governance processes.

A student can see the breakdown of these fees by viewing the ‘charge details’ page or the “tuition receipt” once paid.

In the New Bear Tracks, instead of seeing the account details, we can see **Charges Due**. By Clicking on the tab labelled Detail of Charges Due, the student can see further details offered by the item type description.



### **Mayoral Planning Working Group**

The planning group met this past Tuesday to begin planning for the Mayoral forum. We have a date and time in and are currently reaching out to mayoral candidates to send out invitations. Once we hear back we will begin to discuss the forum format, draft questions, recruit a moderator, event promotion strategies and much more. As always I will keep the council updated on any developments and when you can RSVP for this event.

### Important Meetings and Updates

#### **Vote on Campus**

We are currently working with Edmonton Elections about setting up a voting station for advanced voting. The Advance Voting station would be available to students, staff and any eligible voters on campus and will take place for one day between October 4-8, 2021 from 11am-4pm to have the voting station open. We are currently trying to establish which date that shall be. The municipalities of Strathcona County and St. Albert may also be in attendance at the voting station to provide the option for voters living in those jurisdictions. Edmonton Elections will coordinate directly with Strathcona County and St. Albert and advise us if these municipalities are also able to join the Advance Voting station.

#### **Meeting with Armajeet Sohi**

Some of the execs had an in person meeting with Mayoral candidate Armajeet Sohi. Sadly I was not feeling well that day but I still was able to join in virtually. We raised concerns surrounding important issues of expanding access to transit, having more affordable housing spaces for students, we discussed campus security and policing and also discussed student employment and how to combat brain drain and retain more students in Edmonton. Mr. Sohi expressed support for improving access to transit for students, addressing the root cause and social inequities that often lead to crime that may make its way to campus and ways we can address this through better social and public policy. Mr. Sohi also discussed ways the City, Post-Secondaries and community members can better collaborate.

## **U-Pass Update:**

In our last council meeting, I mentioned that a lot has been going on behind the scenes regarding U-Pass. Working with ETS these last few weeks has been less than ideal and incredibly frustrating. I was hoping that things would have been resolved by now, but unfortunately, that is not the case. Nevertheless, the U-Pass program is returning in the Fall. I know that many students, including myself, rely on transit to get to campus and daily necessities like getting to the grocery store or a doctor's appointment. This year, we will be transitioning from the traditional U-pass stickers to an Arc card, as you might have seen in our Instagram reel that we posted this week. We were expecting a shipment of Arc cards from ETS this week, but unfortunately, due to a miscommunication between ETS and their Arc card vendor, distribution is currently delayed. We are incredibly disappointed with this news, especially with the semester starting in less than two weeks. We are working very hard to resolve this issue.

## **Period Equity:**

VP Dixon and I have been working incredibly hard on the Period Equity initiative and have a few exciting things to share.

## **At-Cost Products**

The first exciting thing is that all of the menstrual products sold at SUBmart will now be sold "at-cost". Meaning that all of the menstrual products in SUBmart will no longer be marked up in price. But what does that **actually** mean? We're not making money off of periods.

## **Sustainable Menstrual Products**

As we announced last week, we now provide Ruth biodegradable pads in our dispensers. If you don't already know, Ruth provides a sustainable, biodegradable, disposable menstrual

Natracare is another sustainable menstrual products alternative that contains zero plastic. We are super excited that we can provide two sustainable options to traditional menstrual products this year.

### **Dispensers**

We have now put up another dispenser in the Students' Union Building (SUB). It's located on the main floor of SUB, just outside the bathrooms by the bookstore so that everyone can access it. VP Dixon and I have been in conversations with Campus & Community Recreation (CCR) about installing dispensers in their building in hopes of expanding the Period Equity initiative across campus. I'm excited to say that we will be installing two dispensers in Van Vliet this year!! We are still in the planning stages of this project and will continue to update you as we make progress.

Hi,

Boy howdy, we are so close to the start of the semester! I've been working on several projects and advocacy efforts, I touch on some of them here, but I'm leaving a lot out. Please ask me any questions you might have!

### The Pronoun Campaign

The pronoun campaign has officially launched! Every professor teaching this semester has been emailed about the pronoun campaign and given resources that will educate them and their students about pronouns.

This is the slide that marketing made for professors to use during their intro presentations.



**We have had a positive response to the campaign so far**, and I am happy to announce that many professors have already signed up for the campaign!

### Period Equity

Myself and VP Kimani continue to make great strides in terms of our period equity project. In the past couple of weeks, we have:

- Gotten our first delivery of Ruths sustainable menstrual products
- Installed a new dispenser in SUB
- Worked with the university to identify a potential sponsor for the project
- We started selling our menstrual products in SUB Mart at cost, reducing the price and making them more accessible.
- Ordered Natracare Products for SUB Mart to encourage the use of sustainable menstrual products

- And collaborated with CCR to identify two places in Van Vliet Complex that we could install dispensers in by the end of the Fall term.



### Residence - The Return to Campus and COVID

As you all know, we had some big advocacy wins in the last couple of weeks. The university has announced a number of COVID related regulations that will help students stay safe this fall. There are a number of details that still need to be worked out and we continue to advocate for students whose needs were not met by these changes. In particular, we are advocating for international students.

There are also some issues in residence that I continue to advocate on and that I hope will be addressed soon. The main issue we are having with residence is that *Residence Services has overbooked Lister and PLH, meaning that almost 500 students who had signed contracts to live in Lister or PLH are being relocated and were only told last week.* I am incredibly concerned about this, and I am working to ensure that these students receive the needed accommodations or compensation from residence. **If any students reach out to you about their specific situation, please have them email me!**

### Aboriginal Awareness Week Planning

We had our first planning meeting on the 10th, and we were able to start planning the event. Since then, I have started more detailed planning of the event by creating a work

plan, researching potential presenters and sessions, and continuing to work on finding a sponsor. Our next planning session will be on the 23rd.

### Abstract

A review of Bylaw 200 has shown that it needs to be updated, and we would like to proceed to make these changes with Council's approval. The updates proposed will update the language used, provide clarity on definitions, acknowledge rights, outline the role of the Students' Union in advocacy, and identify Canadians as treaty partners.

## First Reading

### Aboriginal Consultation and Engagement

#### **First Principles**

- Change in terminology from Aboriginal to FNMI (First Nations, Metis, and Inuit) in all elements of this bylaw that do not refer to legal documents.
- Definition of what compensation can look like when consulting and engaging with FNMI elders and organizations.
- Acknowledgement of FNMI inherent Aboriginal and treaty rights.
- Outline the role of the Students' Union to work in solidarity with FNMI students and not negate their own advocacy.
- Identify all Canadians as treaty partners, not treaty people.
