The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwaciwâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsitapi (Blackfoot), Métis, Dênesųłinê (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

Dear Council,

I hope everyone is doing well! It has been an extremely busy and productive time since my last report. If you have any questions, please feel free to reach out or ask during Council.

### **Direct Action at the Board of Governors**

As referenced in our last Council Meeting, the Students' Union and Graduate Students' Association will collaborate to protest tuition increases at the Board of Governors on March 24, 2023. In preparation for the meeting on March 24, the SU and GSA will hold a joint information session in February, and an Art Build in March. All of you can expect more information that can be disseminated to the student body once it is prepared, and we hope you can all work with the SU and GSA executive teams to ensure we get as much student involvement as possible leading up to the Board of Governors meeting.

### **GoA Student Affordability Announcement**

As many of you probably know, last week, the Minister of Advanced Education was at the University of Alberta to make an announcement surrounding student affordability measures leading up to the release of the provincial budget. In the announcement, three were five (5) announced measures:

1. Capping domestic tuition at 2% starting in the 24/25 academic year.
2. Reducing student loan interest rates to the prime rate, from the prime rate + 1%;
3. Doubling the student loan interest-free grace period to 12 months;
4. Increasing the income threshold for Alberta's Repayment Assistance Plan from \$25,000 to \$40,000; and
5. Increasing Alberta Student Grant monthly payments from \$250 to \$475.

While we welcome these improvements that will help current students and recent graduates, the most significant measure, the 2% cap, comes into effect too late, among other concerns. Firstly, students shouldn't have to spend another 1.5-2 years waiting for GoA support when student leaders have clearly demonstrated the need exists. We urge the Minister and government to respond to this and commit to investing in more needs-based grants that all low-income students are eligible for, not just students in high-demand

programs. Additionally, even with a cap on tuition at 2%, we are concerned about what that means for the quality of our programs since the government has yet to commit any additional backfill funding to make up for any shortfall that institutions have as a result.

### **Trip to Augustana**

A couple of weeks ago, our executive team had an opportunity to travel to Augustana and spend some time on their campus! It was great chatting with the Augustana Students' Association executive team about what projects and initiatives they are currently working on and sharing with them some of the projects the UASU executive is working on.

### **Board of Governors Strategy Session**

Last week, the board of governors had a strategy session surrounding the next steps for the University Strategic Plan (USP). It was an excellent opportunity to ask questions and discuss what we heard from the community in the first phase of consultations. We will enter the second phase when we share what we heard back with the community in the coming weeks.

### **Council of Alberta University Students (CAUS) Counterparts**

This week, the executive team attended CAUS Counterparts at MacEwan University. It was an excellent opportunity to discuss how we can leverage the advocacy that our counterparts have done to support our advocacy in our home institutions, brainstorm policy positions that we would like CAUS to take, and strategize about where CAUS needs to go to be as effective as possible for its members.


**WORLD SOCIAL JUSTICE DAY**



UofA NCHA-II 2019:

69.6% of respondents felt very lonely

76.7 % of respondents felt very sad

66.4% felt overwhelming anxiety

62.9% of respondents felt things were hopeless

<b>Subject</b>	National Standard for Mental Health & Well-Being for PSI Students - Overview
<b>Summary</b>	<p>The <a href="#">National Standard for Mental Health &amp; Well-Being for Post-Secondary Students</a> was officially released in October 2020. This standard is the first of its kind in the world and provides a set of flexible, voluntary guidelines to help Canadian post-secondary institutions support the mental health and well-being of their students. Since its release, the Canadian Association of College and University Student Services, in partnership with the Canadian Association of Standards, has been supporting Canadian post-secondary institutions to facilitate implementation of the standard on campuses across the country.</p>
<b>Current State</b>	<p>Under the auspices of the U of A's <a href="#">Healthy University Strategic Plan (HUSP)</a>, the National Standard Working Group is currently implementing the standard on our campuses. It is in the best interest of our students, faculty and staff that we implement the standard. It will ensure that our student mental health supports remain evidence informed, coordinated and relevant to the needs of today's students. It will also align student health and wellness efforts with the key principles of the HUSP and International <a href="#">Okanagan Charter</a>.</p> <p>The <a href="#">National Standard Working Group</a> has initiated a pan-campus engagement process to consult with our diverse students, faculty, staff and service-providers about their experiences with student mental health. This process is underway with the launch of the <a href="#">Student National Standard Engagement Survey</a>. A Faculty and Staff engagement survey is planned for release in early March. Together, these assessment tools will collect information from our community regarding the student mental health experiences, opportunities, challenges and hidden barriers. That information will then inform focus groups, roundtables and a world cafe that will assist the National Standard Working Group and Advisory Committee in identifying key student mental health priorities to be addressed in Phase Two of the project.</p> <p>Alongside the National Standard Working Group, a Campus Advisory Group has been struck to bring together diverse student, faculty and staff voices that will inform the implementation of the standard and support the Working Group in its engagement efforts. It will ensure that we are accurately interpreting the data collected from our campus engagement process and identifying the priority mental health needs of our students.</p>

**Roadmap & Expectations**

Implementation of the standard at the U of A will allow us to further our cooperative work with students, campus service providers, faculty, and staff to strengthen how we foster student mental health. The benefits of doing so should be seen through the academic success of our students, so they have access to timely and appropriate mental health support when and where they need them most.

Key priorities to be addressed in the implementation include:

1. Undertake university-wide engagement process to assess student mental health needs, opportunities and gaps;
2. Collect data on current university mental health services and programs;
3. Set campus mental health priorities based on engagement and data;
4. Implement, evaluate and continuously improve the existing policies, service delivery, and programming coordination.
5. Review current U of A policies that support student mental health;
