The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųłiné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

ALI: Questions GLOCK if they support the reappointment of Flanagan as the President.

GLOCK: Answers that they are a part of the voting process in the Board and due to the nature of its confidentiality, it would be a breach of information on their behalf.

MOHAMED: Questions why the UASU isn't taking any direct approach to ensuring building students' trust in the university administration.

GLOCK: States that they are only aware of the protestors group working on the issues during the encampment day, from which the UAUS has been asked to step back.

MOHAMED: Adds that in a conversation with Flanagan, they learned about the working group for building trust among the students (which is not only focused on the encampment). Thinks that both of them are referring to the same group but the UASU should be taking the lead on it and actively advocating for it.

ABBASI: Answers that the UASU is part of the working group but as an observer. The SJP would want to take the lead on this to discuss their demands. Adds that there are no terms of reference available for this working group as of now.

ALI: Questions if the UASU has any opinion on the reappointment of Flanagan.

GLOCK: States that they cannot speak for it since they have voted and their no public statement issued on this.

ALI: Highlights that many associations have supported removing and not reappointing Flanagan. As a former student leader, they are disappointed since the UASU has a lot of power and reach. There's not much support coming from the UASU and students had hope from this executive team.

GLOCK: Thanks them for bringing this issue to the discussion table. The executive team is dedicated to working towards the students' needs.

SCHMIDTKE: Regarding the protestors' working group, questions if the UASU is advocating for the working group to consist of only students. Thinks that decisions shouldn't be made by a third party.

ALVA: The students (who were part of the protest) stated that this is their hard work and they don't want the UASU to be involved in this matter. The UASU isn't taking a step back, there's still a presence in these meetings and will continue to advocate and be in touch with the students.

SCHMIDTKE: Questions if it only is students in the working group or people outside of the community.

THIESSEN/GOETZ MOVE TO extend Open Forum by 15 minutes CARRIED 15/00/00

GLOCK: Re-iterates that the UASU has been asked to be the observer. This is a discussion only between the protestors and the university. They aren't sure who specifically has been selected to be on the group. Assures that they will continue to monitor the situation.

2024-03/7 QUESTION PERIOD

THIESSEN: Questions GLOCK on how they plan to hold the university accountable for their actions, now that Flanagan has been reappointed.

GLOCK: Answers that they are aiming to establish clear communication about issues with the budget cuts and restructuring. With the removal of the encampment as well, the team wants to focus on clear communication.

BOTROS: Thinks that the UASU should be advocating for all students to spearhead this issue instead of a third party.

ALVA: Clarifies that it hasn't been confirmed who is leading this working group. Terms

of reference are still being discussed and assured that the university is reaching out to all the relevant people to gather information.

BOTROS: Questions if there's any way to ensure that only students are part of the working group instead of any other relevant parties.

ALVA: States that there is faculty involved as well, along with a lot of other associations. Amidst everything, there will be students, and assures that students will have a voice and platform.

GOETZ: States that the flex bus' round trip ticket costs \$40. Questions ALVA about the subsidy value being discussed and advocated for.

ALVA: States that the details are bound to change. However, there are many stakeholders engaged in this. Cannot confirm a dollar amount as of now.

LAM: Clarifies that the BoG Representative also is a part of the voting in the Board and is a part of it. While GLOCK might be bound to have details confidential, there are certain details that they can expand further upon. Adds that they are arranging a meeting with the administrative and will try to highlight the issues to them.

THIESSEN: Questions GLOCK on how they will ensure that the UASU holds its mandates to advocate, particularly directed towards the conversations with the university administration.

GLOCK: Answers that they are meeting various university parties and different stakeholders. They engage with the stakeholders only when relevant. However, they will continue to push the advocacy points that were shared with the Council earlier.
