The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųliné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

Abstract

Mutual Aid Project Micro-Grants are for U of A groups, units and informal collectives to support them and the communities of which they are a part, in their experiences of trauma, harm and grief. This includes addressing the needs of those most affected and harmed by the university's responses to the

encampment and Palestine activism. While individually focused approaches to accessing support are available, these mutual aid project micro-grants will aim to animate collective practices for holding harm and grief while encouraging diverse university communities to share their stories, learnings, imaginations and strategies towards mutual flourishing. This grant opportunity is one of a number of paths forward, part of the Moving through Conflict initiative which can be found here.

What are the pathways in "Moving through Conflict"?

Concept

- Draws on mutual aid principles.
- Focuses on lateral (not hierarchical) acts of caring.
- Aims to change systemic causes of harm and inequities.
- Embrace strategies of:
 - Collective care.
 - Conflict resolution.
 - Increased transparency.
 - Transformative action. 0

Holding Harm, Grief, Imagination & Stories.

AIM: Support collective practices for holding harm and grief while encouraging diverse University communities to share their stories. learnings, imaginations and strategies towards mutual flourishing. Launch Micro-mutual aid project grants in July 2024 to offer avenues to support this collective work

Safety & Policing.

AIM: Review or develop clear, transparent and accountable guidelines around the use of surveillance, police and determination of threat in times of protest and beyond. Multiply alternative pathways beyond security and police.

Transparency & Accountability.

AIM: Prioritize transparency in establishing trust and accountability (i.e., arms-length investigation). Initiate restorative approaches that address the impact of institutional decisions as well as our responsibility to broader scholarly communities (i.e., supporting displaced Palestinian scholars).

Principles of Responsible Investment.

AIM: Disclose university's endowment pool (UEP) investments and ensure investment decisions align with University Funds Investment Policy and responsible investment principles. Engage investment expertise and consult on outcomes.

Freedom of Expression.

AIM: Clarify and defend the different rights, responsibilities and limitations (collective agreements, laws, etc.) of U of A's diverse community members. Expand understanding of and capacity for respectful dissent.

Communications in Times of Conflict.

AIM: Develop transparent guidelines for official U of A communications about conflicts both within and beyond the University. Align these guidelines with principles around U of A's role in times of crisis, conflict and harm

What are Mutual Aid Project Micro-Grants?

PURPOSE:

- o Pathway Holding Harm, Grief, Imagination & Stories
- Address needs of those affected by university's responses to encampment and Palestine activism.
- Inspire diverse, community-specific approaches to grieving and conflict resolution.
- Foster collective holding toward care.

FOCUS:

- Encourage collective practices for holding harm and grief.
- Promote storytelling, learning, imaginations, and mutual flourishing.

PROJECT EXAMPLES:

- Storytelling: Sharing circles, digital storytelling storying experiences of harm, mutual aid, resilience.
- o Embodied Practices: Yoga, cultural dances.
- o Creative Practices: Zines, photovoice, tools.
- Imagination Practices: Invite campus members to envision past, future, and alternative ways forward.
- Collective Learning: Teach-ins on conflict, mutual aid for transformation.
- Cultivating practices for Emergent Needs: Collective meals, supporting displaced/newcomer students.

Guiding Principles of Supported Projects

- Support those experiencing harm
- Activate collective imagination around how we might coexist with reduced harm
- Focus on mutuality and reciprocity in actions and outcomes
- Commit to collective learning and sharing among communities with the intent of spanning differences
- Center learning, discovery and citizenship to build more creative and resilient communities

Eligibility

- <u>Leadership:</u> Must be led/co-led by
 - Registered student group
 - U of A department, unit, or team
 - Formal or Informal Collective of at least three U of A members (students, faculty, and/or staff)

Scope:

- Serve the U of A community, but can be open to the public while held at U of A.
- Projects can serve target specific subsets of the U of A community (e.g., students, those directly impacted by the encampment clearing).

Compliance:

Must abide by U of A policies (Discrimination and Harassment Policy, Space Management Policy).

Bylaw 310 Chief Returning Officer and Elections Staff

First Principles

 Bylaw 310 s.04 will be moved to Regulation 310.03 to allow for Students' Council to suspend or waive provisions pertaining to elections staff eligibility to expand the pool of eligible candidates in exceptional circumstances.

Legislative Changes

Bylaw 310: Chief Returning Officer and Elections Staff

01. Mandate

1. This bylaw shall govern the duties and hiring process of the Students' Union Elections Staff.

02. Elections Staff Composition

- 1. The Elections Staff shall consist of:
 - a. the C.R.O.; and
 - b. one (1) or more D.R.O.(s), at the discretion of the C.R.O. and as permitted by budgeted availability of funds.

03. Elections Staff Hiring

- 1. The C.R.O. shall be ratified by the Students' Council after a hiring committee issues a recommendation. See Regulation 310.03 Elections Staff Hiring for the procedure.
- 2. The D.R.O.(s) shall be hired by a committee chaired by the C.R.O. See Regulation 310.03 Elections Staff Hiring for the procedure.

04. Elections Staff Eligibility Requirements

- 1. The Elections Staff shall not concurrently hold any position on the Students' Council, its boards and committees, Student Representative Associations, Dedicated Fee Units, the D.I.E. Board, or the Students' Union's paid staff.
- 2. The Elections Staff shall be Members of the Students' Union throughout their terms.

045. Elections Staff Terms of Office

- 1. The C.R.O. shall serve from May 1 to April 30 of the following year.
- 2. The D.R.O.(s) shall serve from no earlier than December 1 and end on April 30 of the following year.

056. Election Staff Duties

- 1. The duties of the C.R.O. shall include
 - a. overseeing the implementation of Bylaws 310, 320, and 330;
 - b. such duties required of the C.R.O. under other SU Bylaws; and
 - c. being the highest responsible manager of the Elections Office and Elections Staff, particularly when interpreting, enforcing, and delegating authority afforded by the aforementioned Bylaws.

- 2. The duties of the D.R.O.(s) shall include:
 - a. such duties required of the D.R.O.(s) under Bylaws 310, 320, and 330; and
 - b. such assistance as required by the C.R.O. in discharging their duties as set out in Section 06(1).
- 3. If the C.R.O. is incapacitated and can not complete the duties of the office, C.A.C. shall assign those duties to another Member of the Elections Staff in the interim.
- 4. See Regulation 310.06 Elections Staff Duties for the list of responsibilities for Elections Staff.

067. Elections Staff Reporting and Dismissal

- 1. The C.R.O. shall report directly to the Students' Council and shall be dismissed only by a two-thirds (2/3) majority vote of the Students' Council on two consecutive meetings, to be held not less than one (1) week apart.
- 2. The D.R.O.(s) shall report directly to the C.R.O. and shall be dismissed only by a simple majority vote of the Members of the C.A.C.
- 3. The C.R.O. shall submit a written report to the Students' Council before the end of their contract or April 30, whichever comes first. See Regulation 310.07 Elections Staff Reporting and Dismissal for the procedure.
- 4. The final installment of remunerations for the C.R.O. shall be made contingent on submitting the written report outlined in Regulation 310.07 Elections Staff Reporting and Dismissal.

078. Elections Advertisement

 The Elections Staff shall develop an advertisement and elections strategy to communicate the release of nomination packages, nomination deadlines, and elections which is to be presented by the C.R.O. to the Students' Council at a minimum of thirty (30) days before the release of Executive Committee nomination packages. See Regulation 310.08 - Elections Advertisement for the procedure.

089. Classroom Talks

- 1. The C.R.O. shall provide Candidates with a list of staff, departments, and faculties that have requested that Candidates not speak between classes.
- 2. The C.R.O. is not responsible for the actions of Candidates speaking between classes.
- 3. The C.R.O. maintains the right to reprimand Candidates who speak during scheduled class time without the instructor's consent.

Regulation 310.03: Elections Staff Hiring

01. Elections Staff Eligibility Requirements

- 1. The Elections Staff shall not concurrently hold any position on the Students' Council, its boards and committees, Student Representative Associations, Dedicated Fee Units, the D.I.E. Board, or the Students' Union's paid staff.
- 2. The Elections Staff shall be Members of the Students' Union throughout their terms.

021. Chief Returning Officer

- 1. Students' Council shall ratify the C.R.O. after a recommendation is issued by a hiring committee composed of:
 - a. the incumbent C.R.O., as chair, voting only in the event of a tie;
 - i. If the incumbent C.R.O. seeks an additional term:
 - a. the incumbent C.R.O. shall be subject to the same hiring procedures as other Candidates; and
 - b. the incumbent Speaker of the Students' Council shall serve as chair, voting only in the event of a tie.

- b. two (2) Members of the D.I.E. Board
 - i. in the event that less than two (2) Members of the D.I.E. Board are available to serve on the committee on at least seven (7) days' notice, the Council Administration Committee may appoint an individual who is not a Member of the Students' Council for each D.I.E. Board seat on the committee unable to be filled.
- c. the Chair of the Council Administration Committee
 - i. the Chair of the Council Administration Committee shall forward the selection committee's recommendation to the Students' Council; and
- d. a staff Member from the Students' Union's Governance Department, as a non-voting Member.

032. Deputy Returning Officer(s)

- 1. The D.R.O.(s) shall be hired by a hiring committee composed of
 - a. the Chief Returning Officer, as chair;
 - b. two (2) Members the Council Administration Committee; and
 - c. a staff Member from the Students' Union's Governance Department, as a non-voting Member.

Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

HENNING: Questions GLOCK about what the Rural Connection Program is meant to do that is already not being done by the University.

GLOCK: The Rural Connection Program was an idea that stemmed from their personal experience as they came from a rural high school where the U of A had tabled once but was overshadowed by other tables and hence never got the exposure of the presentation. Shares that recently, a small town's Students' Union had come to tour at SUB and they asked a lot of questions ranging from the building to the processes. There was clearly a missing bridge between knowledge and the ability to be able to walk to the university to explore student life.

The Office of the Registrar has offered to share their supplements for the university materials.

HENNIG: Questions why is the team aiming for outreach towards prospective students rather than the current students who aren't aware of the scope of the UASU.

GLOCK: States that it is important to connect with prospective students since first-year students don't get involved in a lot of things. Giving the awareness to them can increase student engagement and students would walk into campus knowing the

Executive team and the councillors.

TT: Questions if they are inviting Bill Flanagan to speak at the Week of Welcome.

FLAMAN: Answers that there's no such formal invite but there's usually a President's Address that will take place where they would be present.

THIESSEN: Questions ABBASI about what advocacy priorities were discussed for CAUS and when they would be published on the website.

ABBASI: Answers that it was an umbrella of topics that were discussed and there are no specific details as of now.

THIESSEN: Questions what would the expected timeline be for these advocacy priorities to be detailed out for CAUS.

ABBASI: States that the board meetings will happen soon. Adds that CAUS will be presenting their pre-budget submissions so hopes to have the priorities laid out by the start of the Fall term.

BOTROS: Questions FLAMAN if their stay at different campuses was paid for in any way, and if it was approved by the Council.

FLAMAN: Answers that the permissions for conferences need approval but the distance travel is included in the operating policies. Plans to get the total breakdown to executives for approval, however, only 8 out of the 19 days were vacation days.

GOETZ: Questions ALVA about how much consultation has been done with ASA before talks about Flix bus were being set up.

ALVA: Answers that they were contacted for this idea via an email in May and reached out to Miron (ASA President). None of the details are finalized at the moment but there are multiple stakeholders involved if we reach an agreement.

BOTROS: Questions GLOCK if reaching out to Augustana and getting ASA on board will be helpful, instead of reaching out to high schoolers that may or may not be attending UofA.

GLOCK: States that they have considered Camrose and hoping to be involved with the Augustana Campus as well.

ABBASI: Adds that they went to high school in Camrose and will be reaching out to them.

BOTROS: Questions how will we ensure that the UASU is distinguished from the University officials?

GLOCK: States that this is an ongoing issue on campus as well. It would be beneficial to advertise and have the UASU branding. This program majorly focuses on sharing student experience and not with advocating for applying to a specific program.

THIESSEN: Suggests that they should be looking inwards and building the lack of knowledge and awareness that exists on campus.

GLOCK: States that this is an additional initiative for students who can't go to open houses as such.

CHANG: Questions if this program would conflict with the work of other student groups who do community outreach

GLOCK: States that the UofA Ambassadors Program does something similar. Currently not aware of any other student group but can have consultations if there are any groups who do similar outreach.

GOETZ: Shares concern with worries that the program could be stepping into other's shoes as recruiters rather than an association. Adds that virtual presentations could be ignored and questions if virtual presentations are the best way to make an impact.

GLOCK: States that they don't want UASU to be confused as the University officials. It would be better to reach out to those students who have already applied or are interested in attending UofA.

Shares that from personal experience they have seen good engagement with virtual presentations during their time in high school. This is also considering costs associated with in-person visits. They would not like to involve student dollars for this program when virtual options are available.

PASAY: Adds that this wouldn't be in a recruiting sense since in a small high school there would be potentially 5-10 students attending U of A. Maybe the program can begin before the applications begin and bring students to the panel who previously

went to UofA. This way the program can introduce the students to UofA's student life and the UASU.

GLOCK: Urges interested councilors to contact them to discuss further ideas on this program.

CHANG: Questions about what is the expected amount to be spent and where will it be spent.

GLOCK: Answers that there will be no student dollars going towards this program. Since this program overlaps with what the Office of Registrar does, there could be potential talks with them if they can support this initiative. Currently, there are no predicted costs since it will be all virtual. But if there's potential funding, it could be useful to have in-person visits.

GOETZ: Given that UASU has seen low engagement previously, questions why this program is intended for rural students and not for students at large.

GLOCK: States that there could be an avenue for outreach toward urban students and it would require a different mechanism. There could be in-person visits involved in that case and can invite students to SUB, Council for more direct and easier involvement.
