Alberta Minimum Wage Profile April 2015 – March 2016



Introduction

The Alberta Minimum Wage Profile presents current information on persons whose average hourly earnings¹ are at or below minimum wage in Alberta and other provinces. Statistics include the percentage of employees² earning at or below minimum wage in each province plus the characteristics for those persons in Alberta.

The profile is based on minimum wage rates that are effective for two reference periods: April 1, 2014 to March 31, 2015 and April 1, 2015 to March 31, 2016.

Interprovincial Analysis

Over the two reference periods, Alberta's minimum wage rose from \$10.20 on September 1, 2014 to \$11.20 on October 1, 2015. The number of employees earning at or below minimum wage in Alberta increased over the two reference periods from 41,700 to 59,200 or from 2.2% to 3.1%, tied with Saskatchewan for lowest percentage of minimum wage earners among the Canadian provinces. For Canada, the proportion decreased between the two periods to 7.4% from 6.9% as provinces raised their minimum wages (Figure 1, 3).

Between March 31, 2015 and March 31, 2016, nine provinces and two territories raised their minimum wage rates (Figure 2).




Figure 4: Provinces with Upcoming Minimum Wage Increases

Five provinces and two territories have scheduled increases to their minimum wage rates in 2016. Figure 4 shows a summary of upcoming minimum wage increases in 2016 (For more information, see Appendix B).

Alberta Analysis

At 32.7%, the 15 to 19 year old group remained the largest group of minimum wage earners in Alberta, and the 20 to 24 year old group was the second largest in the April 2015 to March 2016 period (Figure 5).

The proportion of minimum wage earners increased for the following three age groups in the April 2015 – March 2016 period compared to the April 2014 – March 2015 period:

20 to 24 years, up 2.3 percentage points; 25 to 29 years, up 1.6 percentage points; and 55 years and over, up 3.5 percentage points.

There were proportionately fewer minimum wage earners in all other age groups in the current reference period compared to the previous period (Figure 5).

Just over half, or 56.7%, of minimum wage earners worked part-time between April 2015 and March 2016 (Figure 6).

As in the previous reference period, a larger proportion, or 76.7% of minimum wage earners were in permanent employment (Figure 7).

During the current reference period, 45.0% of minimum wage earners were parents of which 15.5% were single earner families with children (Figure 8).

During the current reference period, 44.0% of minimum wage earners were living with their parents. Another 7.1% were the main income earner in their household and had children under 18 (Figure 9).

Of all minimum wage earners, 40.6% had less than one year of job tenure in the April 2015 – March 2016 reference period. The proportion that had one to five years of job tenure was 41.3%, which was higher than the 38.1% in the previous reference period. Overall, the proportion of minimum wage earners who had job tenure of five years or less decreased from 83.2% in the previous period to 82.0% in the current reference period (Figure 10).

Between April 2015 and March 2016, more than half, or 53.0%, of Alberta's minimum wage earners were employed in two industries: Retail Trade and Accommodation and Food Services. Another 9.2% of Alberta's minimum wage earners were employed in Other Services (Figure 11).

Between April 2015 and March 2016, more than half of Alberta minimum wage earners worked in the following three occupational groups: Sales and service occupations n.e.c.³, 27.9%; Retail salespersons, sales clerks, cashiers, including retail trade supervisors, 24.3%; and Chefs, cooks, and food and beverage service, including supervisors, 9.5% (Figure 12).

Of all Alberta minimum wage earners over the April 2015 to March 2016 period, 27.8% had some high school as their highest level of education and 27.4% had high school diplomas as their highest level of education. The proportion with less than high school was lower in the current period, at 31.5%, compared to the previous period, at 33.5% (Figure 13).

Females made up 61.2% of the minimum wage earners in Alberta in the current reference period, which is higher than the 60.4% in the previous period. The proportion of male minimum wage earners from April 2015 to March 2016 was 38.8% (Figure 14).

Appendix A

Methodology

The data for this profile are gathered from the Labour Force Survey (LFS) conducted by Statistics Canada. Each month, the Labour Economics and Statistics Unit of Alberta Labour receives LFS files from Statistics Canada. This includes a microdata file, which contains the complete file of all LFS responses.

The minimum wage analysis is performed on the microdata using the statistical software package SAS. The Canadian territories are excluded from this analysis. Twelve-month averages are used to ensure the results are not affected by seasonality. The microdata files for each of the twelve months examined are combined into one large data set and annual averages are then calculated. In this profile, the results are an average of the April 2015 to March 2016 numbers.

Minimum wage rates often change; therefore the minimum wage profile will differ from one report to the next.

Occupational and industrial classifications were based on the following.

All data on the number of minimum wage earners and their characteristics are from Statistics Canada, LFS microdata files.

Definitions

These definitions are from Statistics Canada, except for "Employees" and the occupational and industrial groups.

Employees

In this analysis, people who were either selfemployed or listed as having an hourly wage rate of \$0.00 were removed from the overall employment figure to determine the number of employees. Please note that the number of <u>employees</u> in organizations is different from the <u>employment</u> figure for Alberta.

Full-Time Employees

People who usually work 30 hours or more per week at their main or only job.

Minimum Wage Earner

People whose average hourly earnings are equal to or less than the minimum wage rate. Some employees fall outside the scope of the Employment Standards Code's minimum wage provisions and may earn less than minimum wage. See Section 8 of the Employment Standards Regulation and section 2(3)(g) of the Code for more information.

Occupations in Social Science, Government Service and Religion

Occupations in this major group include Recreation, sports and fitness program supervisors and early childhood educators and assistants.

Other Services (except Public Administration) Industry

Consists of establishments engaged in repairing or performing general maintenance on motor vehicles, machinery, equipment, and other products; providing personal care services, funeral services, laundry services and other services to individuals, such as pet care services and photo finishing services; organizing and promoting religious activities, supporting various causes through grantmaking, advocating (promoting) social and political causes, and promoting and defending the interests of their members. Private households are also included.

Part-Time Employees

People who usually work less than 30 hours per week at their main or only job.

Permanent Job

A permanent job is one that is expected to last as long as the employee wants it, given that business conditions permit. There is no pre-determined termination date.

Sales and Service Occupations n.e.c.

Occupations in this major group are primarily concerned with providing services <u>not elsewhere classified</u> in other Sales and service occupational groups, non-store retail sales not elsewhere classified and providing services related to sales. Examples of occupations in this category include Attendants in recreation and sport as well as supervisors.

Temporary Job

A temporary job has a predetermined end date, or will end as soon as a specified project is completed. Included in temporary jobs are seasonal, temporary, term or contract jobs; also include work done through a temporary help agency; casual jobs; and other temporary work.

Average hourly earnings

Average hourly earnings before taxes and other deductions, and include tips, commissions and bonuses. Because tips, commissions and bonuses are included, the analysis may not include all minimum wage earners. This variable is not exclusive to wage earners and includes employees who are salaried, work on commission and other pay schemes. Because it is just based on hourly earnings and not hourly wage the analysis may

include persons who are not minimum wage earners.

Minimum Wage Backgrounder

As a first step to meeting its commitment to increase the hourly minimum wage to \$15, the Government of Alberta increased minimum wage rates on October 1, 2015. No decisions have been made regarding future minimum wage increases.

- Hourly minimum wage was increased by \$1.00 from \$10.20 to \$11.20.
- Hourly liquor server rate was increased by \$1.50 from \$9.20 to \$10.70.
- Weekly minimum wage was increased by \$40 from \$406 to \$446.
- Monthly minimum wage was increased by \$190 from \$1,937 to \$2,127.

The minimum wage is the lowest rate of pay that employers may legally pay to employees. In Alberta, for employees under provincial jurisdiction, the *Employment Standards Regulation* sets the minimum wage, as well as rules around its payment. The rules apply regardless of the employee's employment status (e.g. full-time, part-time or casual) or how they are paid (e.g. hourly rate or salary).

The minimum wage in Alberta has fallen behind the earnings of Albertans in general, and increasing the minimum wage is essential to helping low-income earners and families who struggle to meet their daily needs. It is important that all Albertans can provide for themselves and their families.

There is a growing trend to support a minimum wage rate that can help provide a better standard of living. Alberta is the first jurisdiction in Canada to commit to implementing a minimum wage of \$15 per hour. Seattle is supporting a phase-in of \$15 per hour minimum wage by January 2017. New York State and California are both in the midst of raising the minimum wage to \$15 per hour over the next few years. Recent findings out of Seattle show minimum wage increases did not impact grocery prices, apartment rents, gas prices or the cost of retail goods. Additionally, many employers reported they would not make drastic cuts to staff, eliminate benefits, contract out work or move their business in response to increasing minimum wage to \$15 per hour.

Alberta is currently facing a declining price of oil, an increase in unemployment and a general economic downturn, and the government is mindful of the possible effects minimum wage increases could have on workers and business owners in the province.



The government has taken steps to see families and businesses through the current economic climate and the transition to a \$15 per hour minimum wage:

- Reduced the small business corporate income tax rate from 3 per cent to 2 per cent.
- Reintroduced the Summer Temporary Employment Program.
- Created the Alberta Investor Tax Credit that encourages investment in small and medium-sized businesses in non-traditional sectors.
- Created the Capital Investment Tax Credit that encourages businesses to invest in machinery, equipment and buildings to grow their business and create jobs.
- Continued support of economic diversification and lending to small- and mediumsized businesses through a \$1.5 billion program with Alberta Treasury Branches.
- Alberta Child Benefit provides up to \$2,750 per year for the most vulnerable families
- Enhanced the Alberta Family Employment Tax Credit that will allow more families to receive the credit, and many families will receive a larger credit.

This consultation will gather input from employer and employee organizations, social advocacy groups and low-income earners about their experiences with the 2015 minimum wage increases, help identify other strategies government may consider to ease the transition towards a \$15 per hour minimum wage and identify additional evaluation tools to assess impacts of minimum wage increases.

The following questions can be used to help inform your thoughts:

- What have been your experiences with the changes to minimum wage that came into effect in October 2015?
- What actions can we take to ensure successful implementation of future minimum wage increases?
- How can we measure the social and economic impacts of changes to the minimum wage?

Minimum Wage Fact Sheet

The average hourly wage in Alberta as of March 2016 was \$29.97, up from \$29.80 in February 2016. This was the highest rate of all provinces. Compared to the same month last year, the March 2016 average hourly wage is up by \$1.34 or 4.7%.

Profile of minimum wage earners in Alberta

- In February 2016 there were 1,885,000 employees age 15 and over in Alberta.
- Alberta has the lowest percentage of minimum wage earners in the country (3.1%) compared with 6.9% across Canada.
- The number of minimum wage earners in Alberta has increased from 41,700 (April 1, 2014 to March 31, 2015) to 59,200 (April 1, 2015 to March 31, 2016).
- As of February 2016, 346,300 of employed Albertans earned \$15 per hour or less.

Of minimum wage earners in Alberta:

- 32.7% are between the ages of 15 and 19;
- 17.9% are between the ages of 20 to 24;
- 15.1% are over 55 years of age;
- 56.7% are employed part-time;
- 76.7% are permanent employees (not seasonal, temporary or casual);
- 53.1% were employed in the retail, accommodation, or food service industries;
- 55.2% have some high school or high school diplomas as their highest level of education; and
- 61.2% are female.

2. Residences

CAUS policy states that we are opposed to an form of differential tuition, including market modifiers. I'd appreciate hearing from Council on whether you

CASA's Policy committee approved about half of the policies that were set to expire at the end of this year, and also looked at a draft policy around RESPs for students.

5. Alumni Council

I attended the second meeting of Alumni Council, which was reminiscent of the introductory conferences for CASA and CAUS simply because we covered the mandate and scope of Alumni Council. We also covered the regular activities Alumni Council does each year.

6. Misc Projects

I presented our executive goals to GFC Exec, a presentation required before it goes to full GFC for advice and consideration. I will also present to BLDC at the end of the month.

VPs Ghossein, Paches and I attended an MNIF oversight committee, which was a project steered by President Khinda last year. We will be working out a reporting system so that students have more transparency in what their MNIFs (mandatory non-instructional fees, often seen as basket of goods fees) are going towards at the University.

VP Sandare and I also attended the Tuition Budget Advisory Committee, which was short because of the tuition freeze from Bill #3 last year.

7. Presence & Relevancy

After Week of Welcome, the SU Exec hosted a BBQ in collaboration with AUFSJ at CSJ for the students over there. We saw MP Boissonault for a brief time, and connected with many students while practicing our French skills.

Two FA dinners have taken place: one with the Alberta Pharmacy Students' Association and the other with the Faculty of ALES Undergraduate Association.

4. Other Exciting Endeavours


Interdisciplinary Conference



Federal

National Advocacy Team - Adovcacy Webinar

On the federal front, the national advocacy team has given the go ahead for CASA staff, and student NAT Board Member Tristan Bray, to make an online webinar focused around advocacy how-to. The webinar has been developed to help inform students, especially members of council, how advocacy works and best case practices when doing it. 2016-08/6a Governor Champagne to VP Banister:

With all the events at GovWeek, what are the strategies to incite people to go to these events and manage to get good attendance to all these events. What strategies can we use to help fill up these events?

Vice President Banister's Response:

Thank you for your question. In terms of marketing strategies, we are investing in the marketing of this. Marketing has assured that it will be organized and will be advertising this at both the Week of Welcome events and Orientation. Invested in SUB TV Boards, physical hand out, website, facebook event, etc. Also, relies on the individual host of the events and they will also be doing advertising. Given that nothing with Resident fee collection seems to be going according to plan, there a plan B for associations that have tighter budgets like RSJ? Does SU have a plan to fill that programming fund shortfall if the association fee drags on?

Vice President Ghossein's Response:

This is university's responsibility to collect these fees or at least find a way to do so. We see shortcomings not being on our part. One solution, I can see, is to ask the university to fill that gap by loaning the association's that money but not sure on how associations will pay back that money. I think an argument can be made to the University that it is their responsibility to see that associations are viable as it was their responsibility to ensure that these fees were collected.

Has there been a response from Residence services as to why they won't collect the fees?

Vice President Ghossein's Response:

I mentioned last time that following our meeting with Residence Services they had informed us that they will no longer be collecting the fees. 2016-08/7c Bill #6 - CRO Responsibilities - Second Reading

LARSEN/CHRISTENSEN MOVE to approve the second reading of Bill #6, on the recommendation of Bylaw Committee, to clarify and outline C.R.O. Responsibilities according to the these first principles:

First Principles (Approved August 9, 2016)

- 1. The Chief Returning Officer (C.R.O.) responsibilities shall be updated to reflect the growing scale of elections and value of office. As such the following amendments shall be made to bylaw to ensure a stronger role throughout the academic year and during SU elections.
- 2. Advertisement responsibilities of the C.R.O. shall be amended to ensure the position has larger and long term responsibilities to properly advertise elections.
- 3. Timelines for reporting the activities of the C.R.O.'s office, both during elections and throughout academic year, shall be amended or introduced.
- 4. Timelines for nomination packages shall be amended to ensure timely release.
- 5. The C.R.O.'s responsibilities regarding proper classroom talk procedure shall be outlined.
- 6. The C.R.O.'s office shall ensure timely release of rulings as well as fair and due process for candidates during elections.
- 7. The C.R.O.'s responsibilities regarding the review of campaign materials content shall be amended to focus on ensuring campaigns do not go over budget.

8. The elections bylaws, specifically but not limited to 2100(8) Duties of Elections Staff, shall be amended to fully include responsibilities of the elections staff to ensure clear understanding of office.

Councilor Larsen introduces the motion and discusses all the changes made within the document. Councilor Larsen mentions changes to definitions, CRO and DRO. Also, mention the inclusion of classroom talks. Councilor Christensen speaks in favour of the bill. Mentions that the CRO's office is overburdened and that this bill will help balance tasks and responsibilities between the CRO and the DRO. Vice President Ghossein mentions concerns to the growth of the number of DRO's, and mentions to the lack of the autonomy of the CRO. She points out that there is a lot of consultations that should have done to adding another DRO. She mentions many changes to the bylaw, and recommends that the motion be sent back to Bylaw Committee. Councilor Larsen explains the changes, and what exactly was changed. He mentions why the changes made are necessary, and that all the changes have been worked through with the current CRO, Donald. Councilor Monda speaks in favour of many the changes however agrees with Vice President Ghossein's concerns. Vice President Banister expresses in concern of the jump between first and second principles, and speaks in favour of sending this back to Bylaw. Vice President Paches speaks on the finance committee, and discusses how it is not in the budget to have a second DRO. Also, speaks in favour of sending this back to Bylaw. Councilor Larsen expresses that he is not in favour of going back to bylaw, and rather discusses making amendments. Vice President Ghossein discusses concerns over other wordings throughout the bill. Also, suggests discussing bill with the general manager of Discover Governance as they will be able to provide some advice. President Rahman mentions issues with role of elections' office. Councillor Christensen mentions how the bill attempts to solve these systemic problems have been seen in the CRO office.

First Principles (Approved August 9, 2016)

- 1. The evaluation of Students' Council seat allocation review currently occurs irregularly and often on an *ad hoc* basis.
- 2. Seats are currently distributed according to the "representation by population" rule.
- 3. Bylaw 100 shall be amended to implement a regular timeline for Students' Council seat review.
- 4. Bylaw 100 shall be further amended to adjust the number of seats according to the most recent enrolment data.
- 5. Every Faculty shall have a minimum of one (1) seat.
- 6. Where the allocation of seats shall be based on student enrolment below:
 - a. 1-1499 shall receive one (1) seat; and
 - b. 1500-2499 shall receive two (2) seats; and
 - c. 2500-3499 shall receive three (3) seats; and
 - d. 3500-4499 shall receive four (4) seats; and
 - e. 4500-5499 shall receive five (5) seats; and
 - f. 5500-6499 shall receive six (6) seats; and
 - g. 6500-7499 shall receive seven (7) seats; and
 - h. 7500-8499 shall receive eight (8) seats; and
 - i. 8500-9499 shall receive nine (9) seats;
 - j. And so on...
- 7. Bylaw 100 schedule shall be amended to include a chart with the information provided in (7).
- 8. Seat allocation shall remain constant until the next general election cycle.

President Rahman expresses concerns on how much change can happen in three years, and that in order to represent students properly, they should review it every year. CHRISTENSEN/BANISTER MOVE to approve the second reading of Bill #8, on the recommendation of Bylaw Committee, and amend Bylaw 100 and 2300 based on the following first principles:

First Principles (Approved August 9, 2016)

- Councillors are expected to attend, send a Proxy or Councillor-Designate, to meetings of Students' Council.
- 2. A Councillor shall have an attendance record of at least 50% of meetings each trimester, where attendance is defined as attending for at least one (1) roll call of attendance.
- 3. Formal attendance shall be calculated at the end of every trimester by the Speaker.
- 4. Where a Councillor has less than 50% attendance at the end of the trimester, they shall be automatically removed as a member of Students' Council.
 - a. Leaves of absence for elections shall not be accounted into the attendance percentage.
- 5. The contravening Councillor shall be able to appeal their removal to D.I.E. Board, based on extenuating circumstances including but not limited to those listed below, within three (3) business days of their removal:
 - a. Medical, emotional, mental, or family emergencies; and
 - b. Other circumstances deemed reasonable, at the discretion of D.I.E. Board.
- 6. Unreliable proxies or Councillor-Designates shall not be considered a reasonable excuse for appeal, unless D.I.E. Board deems there were extenuating circumstances.
- 7. The Speaker shall attend the D.I.E. Board hearing to provide the official attendance record and field any questions of the Board.
- 8. Should the D.I.E. Board approve an appeal to the contravening Councillor, that Councillor shall be re-appointed immediately.
- 9. The Speaker shall present at Council and email these regulations to all Councillors at the start of each trimester.
- 10. These regulations shall also be included in the Nomination Package of each Council election.

- 11. Bylaw 100 and 2300 shall be amended to implement this process.
- 12. This process shall not take effect until the 2017/2018 term of Students' Council.

Councilor Christensen introduces the bill. Vice President Banister speaks in support of the bill, and questions point 6b. Councilor Farooq agrees with Vice President Banister and mentions how students within Nursing and Medicine faculties might struggle to come to meetings. Councilor Christensen discussed the wording of point 6b and why they chose to include it. Councilor Monda discusses how point 6b is not necessary as councilors should be able to arrange for a proxy. Vice President Paches mentions how the point can be broadly interpreted. Councilor Christensen mentions point 6b can be striked but hopes to see some type of point concerning Professional Program as they have very different schedules in which they might not be able to find proxies. Other councilors mention how 6b can still relate as due to the various offering of classes, they might not be able to attend certain meetings. Other councilors mention how point 6b might unfairly punish students who are unable to attend, while other councilors mention how it is not unfair as it is not unreasonable to expect councilors to find proxies.
